1.36 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

ARTICLE 1

TRANSPORTATION POLICY

Section 1. Minnesota Statutes 2006, section 123B.88, subdivision 3, is amended to read:

Subd. 3. **Transportation services contracts; requirements.** (a) The board may contract for the furnishing of authorized transportation under section 123B.52, and may purchase gasoline and furnish same to a contract carrier for use in the performance of a contract with the school district for transportation of school children to and from school.

(b) An initiated transportation service contract shall include by contract language, addendum, or supplementary information terms addressing:

(1) a summary of school bus driver training requirements, including the minimum number of preservice training hours and the minimum number of in-service training hours;

(2) a driver recruitment and retention plan, including an explanation of:

(i) the actions the contractor has taken or will take to recruit qualified drivers for the transportation services contract;

(ii) the process for screening applicants to be certain that they meet the school bus driver requirements of federal law, of state law, and of the transportation service contract, including federal and state-controlled substance and alcohol testing requirements;

(iii) the training that drivers receive prior to assignment to transportation service; and

(iv) the actions of the employer to retain qualified drivers to meet requirements of the transportation services contract, including an explanation of wage rates and employee benefits and policies on compensated absences such as paid vacations, holidays, and sick leave;

(3) the reporting to the local school district of all school bus accidents;

(4) the reporting to the local school district of all school bus driver-reported traffic convictions, based upon the requirement of commercial drivers to report traffic convictions to their employer under Federal Motor Carrier Safety Administration regulation in Code of Federal Regulations, title 49, section 383.31;

(5) the reporting within one week to the local school district the results of any Minnesota State Patrol inspection of school buses being regularly utilized for the transportation under the transportation contract;

(6) the school bus driver employee turnover ratio, defined as the total number of school bus drivers employed during the most recent school year divided by the daily average number of school bus drivers employed during the same regular school year, within bus garage location or other reasonable basis. The turnover rate may exclude

3.1 those drivers whose employment is terminated or who are otherwise removed for cause
3.2 from service; and

3.3 (7) the date of hire of the employer's current employees identified by their job
3.4 classifications, which may include any relevant prior experience. Summer and other
3.5 regular school breaks should not be considered interruptions to employment.

3.6 (c) Notwithstanding section 123B.52, a school district may award a transportation
3.7 contract in the interest of student safety and cost-effectiveness.

3.8 **EFFECTIVE DATE.** This section is effective July 1, 2008.

3.9 **Sec. 2. [123B.915] SCHOOL BUS DRIVERS.**

3.10 Subdivision 1. **Driver pay.** School bus driver employees must be paid for the
3.11 actual time worked. If a route pay system or hourly estimation is used, school bus driver
3.12 employees must be scheduled and paid for actual time for required inspection of buses.

3.13 Subd. 2. **Right to refuse.** School bus drivers who document needed bus repairs
3.14 shall have the right to refuse to operate the bus immediately for a safety-related repair,
3.15 which meets the out-of-service definition of Minnesota Rules, part 7470.0600. In this
3.16 situation, the driver shall be provided an alternate bus, if available, and time to inspect it.
3.17 The driver shall not be penalized in any way for fees, fines, or consequences incurred by
3.18 the employer for delays or failure to provide the transportation service in a timely manner
3.19 in this situation. Nothing in this section may diminish the rights, pay, or benefits of drivers
3.20 covered by a collective bargaining agreement with an exclusive representative.

3.21 **EFFECTIVE DATE.** This section is effective July 1, 2008.

4.1 Subdivision 1. **Vehicles exempt from tax, fees, or plate display.** (a) The following
4.2 vehicles are exempt from the provisions of this chapter requiring payment of tax and
4.3 registration fees, except as provided in subdivision 1c:

4.4 (1) vehicles owned and used solely in the transaction of official business by the
4.5 federal government, the state, or any political subdivision;

4.6 (2) vehicles owned and used exclusively by educational institutions and used solely
4.7 in the transportation of pupils to and from those institutions;

4.8 (3) vehicles used solely in driver education programs at nonpublic high schools;

4.9 (4) vehicles owned by nonprofit charities and used exclusively to transport disabled
4.10 persons for charitable, religious, or educational purposes;

4.11 (5) ambulances owned by ambulance services licensed under section 144E.10, the
4.12 general appearance of which is unmistakable; and

4.13 (6) vehicles owned by a commercial driving school licensed under section 171.34,
4.14 or an employee of a commercial driving school licensed under section 171.34, and the
4.15 vehicle is used exclusively for driver education and training.

4.16 (b) Vehicles owned by the federal government, municipal fire apparatuses including
4.17 fire-suppression support vehicles, police patrols, and ambulances, the general appearance
4.18 of which is unmistakable, are not required to register or display number plates.

4.19 (c) Unmarked vehicles used in general police work, liquor investigations, or arson
4.20 investigations, and passenger automobiles, pickup trucks, and buses owned or operated by
4.21 the Department of Corrections, must be registered and must display appropriate license
4.22 number plates, furnished by the registrar at cost. Original and renewal applications for
4.23 these license plates authorized for use in general police work and for use by the Department
4.24 of Corrections must be accompanied by a certification signed by the appropriate chief of
4.25 police if issued to a police vehicle, the appropriate sheriff if issued to a sheriff's vehicle,
4.26 the commissioner of corrections if issued to a Department of Corrections vehicle, or the
4.27 appropriate officer in charge if issued to a vehicle of any other law enforcement agency.
4.28 The certification must be on a form prescribed by the commissioner and state that the
4.29 vehicle will be used exclusively for a purpose authorized by this section.

4.31 fraud unit, in conducting seizures or criminal investigations must be registered and must
4.32 display passenger vehicle classification license number plates, furnished at cost by the

4.34 must be accompanied by a certification signed by the commissioner of revenue or the
4.35 commissioner of labor and industry. The certification must be on a form prescribed by

5.3 (e) Unmarked vehicles used by the Division of Disease Prevention and Control of the
5.4 Department of Health must be registered and must display passenger vehicle classification

5.6 and renewal applications for these passenger vehicle license plates must be accompanied
5.7 by a certification signed by the commissioner of health. The certification must be on a
5.8 form prescribed by the commissioner and state that the vehicles will be used exclusively
5.9 for the official duties of the Division of Disease Prevention and Control.

5.10 (f) Unmarked vehicles used by staff of the Gambling Control Board in gambling
5.11 investigations and reviews must be registered and must display passenger vehicle
5.12 classification license number plates. These plates must be furnished at cost by the
5.13 registrar. Original and renewal applications for these passenger vehicle license plates must
5.14 be accompanied by a certification signed by the board chair. The certification must be on a
5.15 form prescribed by the commissioner and state that the vehicles will be used exclusively
5.16 for the official duties of the Gambling Control Board.

5.17 (g) Each state hospital and institution for persons who are mentally ill and
5.18 developmentally disabled may have one vehicle without the required identification on
5.19 the sides of the vehicle. The vehicle must be registered and must display passenger
5.20 vehicle classification license number plates. These plates must be furnished at cost by the
5.21 registrar. Original and renewal applications for these passenger vehicle license plates must
5.22 be accompanied by a certification signed by the hospital administrator. The certification
5.23 must be on a form prescribed by the commissioner and state that the vehicles will be used
5.24 exclusively for the official duties of the state hospital or institution.

5.25 (h) Each county social service agency may have vehicles used for child and
5.26 vulnerable adult protective services without the required identification on the sides of the
5.27 vehicle. The vehicles must be registered and must display passenger vehicle classification
5.28 license number plates. These plates must be furnished at cost by the registrar. Original
5.29 and renewal applications for these passenger vehicle license plates must be accompanied
5.30 by a certification signed by the agency administrator. The certification must be on a form
5.31 prescribed by the commissioner and state that the vehicles will be used exclusively for the
5.32 official duties of the social service agency.

5.33 ~~(g)~~ (i) All other motor vehicles must be registered and display tax-exempt number
5.34 plates, furnished by the registrar at cost, except as provided in subdivision 1c. All vehicles
5.35 required to display tax-exempt number plates must have the name of the state department
5.36 or political subdivision, nonpublic high school operating a driver education program, ~~or~~

6.1 licensed commercial driving school, or other qualifying organization or entity, plainly
6.2 displayed on both sides of the vehicle; ~~except that each state hospital and institution for~~

6.17 **EFFECTIVE DATE.** This section is effective the day following final enactment
6.18 and expires June 30, 2013.
