The bill was read for the first time and referred to the Committee on Governmental Operations, Reform, Technology and Elections

1.1 A bill for an act
1.2 relating to the legislature; requiring senate living and other expenses to be
1.3 determined by resolution adopted by the senate; amending Minnesota Statutes
1.4 2006, sections 3.099, subdivision 1; 3.101.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2006, section 3.099, subdivision 1, is amended to read:

1.7 Subdivision 1. **Pay days; mileage; per diem.** The compensation of each member
1.8 of the legislature is due on the first day of the regular legislative session of the term and
1.9 payable in equal parts on January 15, in the first month of each term and on the first
1.10 day of each following month during the term for which the member was elected. The
1.11 compensation of each member of the legislature elected at a special election is due on the
1.12 day the member takes the oath of office and payable within ten days of taking the oath for
1.13 the remaining part of the month in which the oath was taken, and then in equal parts on the
1.14 first day of each following month during the term for which the member was elected.

1.15 Each member shall receive mileage for necessary travel to the place of meeting
1.16 and returning to the member's residence in the amount and for trips as authorized by
1.17 resolution adopted by the senate for senate members and by the house of representatives
1.18 for house members.

1.19 Each member shall also receive per diem living expenses during a regular or special
1.20 session of the legislature in the amounts and for the purposes as determined by resolution
1.21 adopted by the senate for senate members and by the house of representatives for house
1.22 members.

1.23 On January 15 in the first month of each term and on the first day of each following
1.24 month, the secretary of the senate and the chief clerk of the house of representatives shall

2.1 certify to the commissioner of finance, in duplicate, the amount of compensation then
2.2 payable to each member of their respective houses and its total.

2.3 Sec. 2. Minnesota Statutes 2006, section 3.101, is amended to read:

2.4 **3.101 LIVING EXPENSES.**

2.5 A member of the legislature in addition to the compensation and mileage otherwise
2.6 provided by law shall be reimbursed for living and other expenses incurred in the
2.7 performance of duties or engaging in official business during a regular or special session
2.8 and when the legislature is not in session in the manner and amount prescribed by
2.9 resolution adopted by the senate ~~Committee on Rules and Administration~~ for senators and
2.10 by the house Committee on Rules and Legislative Administration for house members.

2.11 Sec. 3. **EFFECTIVE DATE; APPLICATION.**

2.12 This act is effective retroactively from January 1, 2007.
