

2.1 An employer must make ongoing skill development and training opportunities, including
2.2 supervisory training, available to employees.

2.3 Subd. 4. **Information provided to employee by employer.** (a) An employer must
2.4 provide an explanation in an employee's native language of the employee's rights and
2.5 duties as an employee either person to person or through written materials as required
2.6 by state or federal law, or a valid collective bargaining agreement that, at a minimum,
2.7 includes:

2.8 (1) a complete description of the salary and benefits plans as they relate to the
2.9 employee as required under chapter 181 and information about workers' compensation
2.10 benefits under chapter 176, unemployment benefits under chapter 268, and vocational
2.11 rehabilitation under chapter 268A;

2.12 (2) a job description for the employee's position as required under chapter 181;

2.13 (3) a description of leave policies as required under chapter 181 and United States
2.14 Code, title 29, chapter 28;

2.15 (4) a description of the work hours and work hours policy as required under chapter
2.16 181, United States Code, title 29, chapter 201, or a valid collective bargaining agreement;
2.17 and

2.18 (5) a description of the occupational hazards known to exist for the position as
2.19 required under chapters 181 and 182 and United States Code, title 29, chapter 15.

2.20 (b) The explanation must also include information on the following employee rights
2.21 as protected by state or federal law and a description of where additional information
2.22 about those rights may be obtained:

2.23 (1) the right to organize and bargain collectively as required under this chapter and
2.24 chapter 177, and United States Code, title 29, chapter 7;

2.25 (2) the right to a safe workplace as required under chapters 181 and 182 and United
2.26 States Code, title 29, chapter 15; and

2.27 (3) the right to be free from discrimination as required under this chapter and
2.28 chapters 181, 182, and 363A, and United States Code, title 42, chapter 21.

2.29 Subd. 5. **Civil action.** A person aggrieved as a result of a violation of this section
2.30 may file suit in any district court of this state. If the court finds that the respondent has
2.31 intentionally violated this section, the court may award damages up to and including an
2.32 amount equal to the original damages and may provide injunctive relief.

2.33 Subd. 6. **Criminal penalty.** An employer who violates this section is guilty of a
2.34 misdemeanor.

3.1 Sec. 2. **[179.87] MEATPACKING INDUSTRY WORKERS RIGHTS**
3.2 **OMBUDSMAN.**

3.3 Subdivision 1. **Position established.** The position of meatpacking industry workers
3.4 rights ombudsman is established within the Department of Labor and Industry. The
3.5 ombudsman shall be an employee of the department. The ombudsman shall be appointed
3.6 by the commissioner in consultation with the chairs of the standing committees of the
3.7 senate and house of representatives with jurisdiction over labor and employment issues in
3.8 accordance with the preference established in subdivision 5.

3.9 Subd. 2. **Duties.** The ombudsman shall inspect and review the practices and
3.10 procedures of meatpacking operations in the state. The ombudsman shall work to ensure
3.11 workers rights under section 179.86 are protected.

3.12 Subd. 3. **Access.** The ombudsman or designated representatives of the ombudsman
3.13 shall have access to all meatpacking operations in the state at any time meatpacking
3.14 products are being processed and industry workers are on the job.

3.15 Subd. 4. **Office.** Necessary office space, furniture, equipment, and supplies as
3.16 well as necessary assistance for the ombudsman shall be provided by the Department of
3.17 Labor and Industry.

3.18 Subd. 5. **Language preference.** Preference shall be given to applicants for the
3.19 ombudsman position who are fluent in languages in addition to English.

3.20 Subd. 6. **Report.** The ombudsman shall, on or before December 1 of each year,
3.21 submit a report to the members of the legislature and the governor regarding any
3.22 recommended actions the ombudsman deems necessary or appropriate to provide for the
3.23 fair treatment of workers in the meatpacking industry.
