Committee Recommendation and Adoption of Report:

To Pass as Amended and re-referred to the Committee on Governmental Operations, Reform, Technology and Elections

1.21 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.22 Section 1. Minnesota Statutes 2006, section 97A.015, is amended by adding a  
1.23 subdivision to read:

1.24 Subd. 26c. **Immediately released or immediately returned to the water.**

1.25 "Immediately released" or "immediately returned to the water" means that a fish must not  
1.26 be retained longer than is needed at the site of capture to unhook, identify, measure, or  
1.27 photograph the fish. Placing a fish on a stringer, in a live well, or in a cooler, bucket, or  
1.28 other container is not "immediately released" or "immediately returned to the water."

1.29 Sec. 2. Minnesota Statutes 2006, section 97A.015, subdivision 24, is amended to read:

2.1 Subd. 24. **Game birds.** "Game birds" means migratory waterfowl, ring-necked  
2.2 pheasant, ruffed grouse, sharp-tailed grouse, Canada spruce grouse, prairie chickens,  
2.3 gray partridge, bob-white quail, wild turkeys, coots, gallinules, sora and Virginia rails,  
2.4 mourning dove, American woodcock, and common snipe.

2.5 Sec. 3. Minnesota Statutes 2006, section 97A.045, is amended by adding a subdivision  
2.6 to read:

2.7 Subd. 12. **Establishing fees.** Notwithstanding section 16A.1283, the commissioner  
2.8 may, by written order published in the State Register, establish fees providing for the use  
2.9 of state wildlife management area or aquatic management area lands for specific purposes,  
2.10 including dog trials; special events; and commercial uses. The fees are not subject to the  
2.11 rulemaking provisions of chapter 14 and section 14.386 does not apply.

2.12 Sec. 4. Minnesota Statutes 2006, section 97A.401, subdivision 5, is amended to read:

2.13 Subd. 5. **Wild animals damaging property.** Special permits may be issued with  
2.14 or without a fee to take protected wild animals ~~that are damaging property~~ or to remove  
2.15 or destroy their dens, nests, eggs, houses, or dams for the purpose of preventing or  
2.16 reducing damage or injury to people, property, agricultural crops, or other interests. The  
2.17 commissioner may prescribe rules for taking Canada geese and their nests and eggs, with  
2.18 or without a permit, consistent with federal regulations. ~~A special permit issued under this~~  
2.19 subdivision to take beaver must state the number to be taken.

2.20 Sec. 5. Minnesota Statutes 2006, section 97A.405, subdivision 2, is amended to read:

2.21 Subd. 2. **Personal possession.** (a) A person acting under a license or traveling from  
2.22 an area where a licensed activity was performed must have in personal possession either:  
2.23 (1) the proper license, if the license has been issued to and received by the person; or (2)  
2.24 the proper license identification number or stamp validation, if the license has been sold to  
2.25 the person by electronic means but the actual license has not been issued and received.

2.26 (b) If possession of a license or a license identification number is required, a person  
2.27 must exhibit, as requested by a conservation officer or peace officer, either: (1) the proper  
2.28 license if the license has been issued to and received by the person; or (2) the proper  
2.29 license identification number or stamp validation and a valid state driver's license, state  
2.30 identification card, or other form of identification provided by the commissioner, if the  
2.31 license has been sold to the person by electronic means but the actual license has not

3.1 (c) If the actual license has been issued and received, a receipt for license fees, a

 3.3 identification number or stamp validation, does not entitle a licensee to exercise the rights  
 3.4 or privileges conferred by a license.

3.5 (d) A license ~~or stamp~~ issued electronically and not immediately provided to the  
 3.6 licensee shall be mailed to the licensee within 30 days of purchase of the license ~~or stamp~~  
 3.7 ~~validation, except for a pictorial turkey stamp or a pictorial trout and salmon stamp.~~ A  
 3.8 pictorial turkey ~~stamp or a pictorial~~, migratory waterfowl, pheasant, or trout and salmon

4.10 defined in section 97B.001, in deer permit areas that have deer archery licenses to take

4.12 license per year under this subdivision. For properties with co-owners or cotenants, only

- (2) for Lake Superior fish bought for sale to consumers, \$35;
- (3) for Lake of the Woods, Namakan, Sand Point, and Rainy Lake fish bought for sale to retailers, \$300; and
- (4) for Lake of the Woods, Namakan, Sand Point, and Rainy Lake fish bought for shipment only on international boundary waters, \$35.

**97C.301 LICENSE REQUIRED TO TAKE FISH.**

Subd. 3. **Spearing.** A person may not take fish by spearing from a dark house without a dark house spearing license and an angling license.

**97C.365 SPEARS PROHIBITED WHILE ANGLING IN FISH HOUSE OR DARK HOUSE.**

A person may not have a spear within a dark house or fish house while angling.
