The bill was read for the first time and Interim introduction, referred to Finance

1.1 A bill for an act
1.2 relating to capital improvements; appropriating money for a grant to the city of
1.3 Sartell for the Central Minnesota Regional Parks and Trails; authorizing the sale
1.4 and issuance of state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **APPROPRIATION.**

1.7 \$4,000,000 is appropriated from the bond proceeds fund to the commissioner
1.8 of natural resources for a grant to the city of Sartell to acquire 68 acres of land located
1.9 along the Sauk River near the confluence of the Mississippi to serve as part of the Central
1.10 Minnesota Regional Parks and Trails.

1.11 Sec. 2. **BOND SALE.**

1.12 To provide the money appropriated in section 1 from the bond proceeds fund,
1.13 the commissioner of finance shall sell and issue bonds of the state in an amount up to
1.14 \$4,000,000 in the manner, upon the terms, and with the effect prescribed by Minnesota
1.15 Statutes, sections 16A.631 to 16A.675, and by the Minnesota Constitution, article XI,
1.16 sections 4 to 7.

1.17 Sec. 3. **EFFECTIVE DATE.**

1.18 Sections 1 and 2 are effective the day following final enactment.
