The bill was read for the first time and Interim introduction, referred to Finance

1.1 A bill for an act  
1.2 relating to capital improvements; appropriating money for a law enforcement  
1.3 center at Alexandria Technical College; authorizing the sale and issuance of  
1.4 state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **APPROPRIATION; ALEXANDRIA TECHNICAL COLLEGE.**

1.7 Subdivision 1. **Appropriation.** \$10,500,000 is appropriated from the bond proceeds  
1.8 fund to the Board of Trustees of the Minnesota State Colleges and Universities to design,  
1.9 construct, furnish, and equip a law enforcement center addition and to renovate, furnish,  
1.10 and equip existing space for a teaching lab and general classrooms at Alexandria Technical  
1.11 College.

1.12 Subd. 2. **Bond sale.** To provide the money appropriated in subdivision 1 from  
1.13 the bond proceeds fund, the commissioner of finance shall sell and issue bonds of the  
1.14 state in an amount up to \$10,500,000 in the manner, upon the terms, and with the effect  
1.15 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota  
1.16 Constitution, article XI, sections 4 to 7.

1.17 **EFFECTIVE DATE.** This section is effective the day following final enactment.
