1.1 A bill for an act
1.2 relating to state lands; modifying Minnesota critical habitat private sector
1.3 matching account; modifying outdoor recreation system; adding to and deleting
1.4 from state parks, recreation areas, and forests; modifying authority to convey
1.5 private easements on tax-forfeited land; providing for public and private sales,
1.6 conveyances, and exchanges of certain state land; authorizing 30-year leases of
1.7 tax-forfeited and other state lands for wind energy projects; amending Minnesota
1.8 Statutes 2006, sections 84.943, subdivision 5; 86A.04; 86A.08, subdivision 1;
1.9 282.04, subdivision 4a; Laws 2006, chapter 236, article 1, section 43.

1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2006, section 84.943, subdivision 5, is amended to read:

1.12 Subd. 5. **Pledges and contributions.** The commissioner of natural resources may
1.13 accept contributions and pledges to the critical habitat private sector matching account.
1.14 A pledge that is made contingent on an appropriation is acceptable and shall be reported
1.15 with other pledges as required in this section. The commissioner may agree to match a
1.16 contribution contingent on a future appropriation. In the budget request for each biennium,
1.17 the commissioner shall report the balance of contributions in the account and the amount
1.18 that has been pledged for payment in the succeeding two calendar years.

1.19 Money in the account is appropriated to the commissioner of natural resources only
1.20 for the direct acquisition or improvement of land or interests in land as provided in section
1.21 84.944. To the extent of available appropriations other than bond proceeds, the money
1.22 matched to the nongame wildlife management account may be used for the management
1.23 of nongame wildlife projects as specified in section 290.431. Acquisition includes: (1)
1.24 purchase of land or an interest in land by the commissioner; or (2) acceptance by the
1.25 commissioner of gifts of land or interests in land as program projects.

2.1 Sec. 2. Minnesota Statutes 2006, section 86A.04, is amended to read:

2.2 **86A.04 COMPOSITION OF SYSTEM.**

2.3 The outdoor recreation system shall consist of all state parks; state recreation areas;
2.4 state trails established pursuant to sections 84.029, subdivision 2, 85.015, 85.0155, and
2.5 85.0156; state scientific and natural areas; state wilderness areas; state forests; state
2.6 wildlife management areas; state aquatic management areas; state water access sites,
2.7 which include all lands and facilities established by the commissioner of natural resources
2.8 or the commissioner of transportation to provide public access to water; state wild, scenic,
2.9 and recreational rivers; state historic sites; state rest areas, which include all facilities
2.10 established by the commissioner of transportation for the safety, rest, comfort and use
2.11 of the highway traveler, and shall include all existing facilities designated as rest areas
2.12 and waysides by the commissioner of transportation; and any other units not listed in
2.13 this section that are classified under section 86A.05. Each individual state park, state
2.14 recreation area, and so forth is called a "unit."

2.15 Sec. 3. Minnesota Statutes 2006, section 86A.08, subdivision 1, is amended to read:

2.16 Subdivision 1. **Secondary authorization; when permitted.** A unit of the outdoor
2.17 recreation system may be authorized wholly or partially within the boundaries of another
2.18 unit only when the authorization is consistent with the purposes and objectives of the
2.19 respective units and only in the instances permitted below:

2.20 (a) The following units may be authorized wholly or partially within a state park:
2.21 historic site, scientific and natural area, wilderness area, wild, scenic, and recreational
2.22 river, trail, rest area, aquatic management area, and water access site.

2.23 (b) The following units may be authorized wholly or partially within a state
2.24 recreation area: historic site, scientific and natural area, wild, scenic, and recreational river,
2.25 trail, rest area, aquatic management area, wildlife management area, and water access site.

2.26 (c) The following units may be authorized wholly or partially within a state forest:
2.27 state park, state recreation area, historic site, wildlife management area, scientific and
2.28 natural area, wilderness area, wild, scenic, and recreational river, trail, rest area, aquatic
2.29 management area, and water access site.

2.30 (d) The following units may be authorized wholly or partially within a state historic
2.31 site: wild, scenic, and recreational river, trail, rest area, aquatic management area, and
2.32 water access site.

2.33 (e) The following units may be authorized wholly or partially within a state wildlife
2.34 management area: state water access site and aquatic management area.

3.1 (f) The following units may be authorized wholly or partially within a state wild,
3.2 scenic, or recreational river: state park, historic site, scientific and natural area, wilderness
3.3 area, trail, rest area, aquatic management area, and water access site.

3.4 (g) The following units may be authorized wholly or partially within a state rest
3.5 area: historic site, trail, wild, scenic, and recreational river, aquatic management area,
3.6 and water access site.

3.7 (h) The following units may be authorized wholly or partially within an aquatic
3.8 management area: historic site, scientific and natural area, wild, scenic, and recreational
3.9 river, and water access site.

3.10 Sec. 4. Minnesota Statutes 2006, section 282.04, subdivision 4a, is amended to read:

3.11 Subd. 4a. **Private easements.** (a) A county board may convey a road easement
3.12 across unsold tax-forfeited land to ~~an individual~~ a person, as defined under section
3.13 645.44, subdivision 7, requesting an easement for access to private property owned by
3.14 the ~~individual~~ person if:

3.15 (1) there are no reasonable alternatives to obtain access to the ~~individual's~~ person's
3.16 property; and

3.17 (2) exercising the easement will not cause significant adverse environmental or
3.18 natural resource management impacts.

3.19 (b) The county auditor shall require ~~an individual~~ a person applying for an easement
3.20 under paragraph (a) to pay the appraised value of the easement. The conveyance must
3.21 provide that the easement reverts to the state in trust for the taxing district in the event
3.22 of nonuse.

3.23 Sec. 5. Laws 2006, chapter 236, article 1, section 43, is amended to read:

3.24 Sec. 43. **LAND REPLACEMENT TRUST FUND; ITASCA COUNTY.**

3.25 Notwithstanding the provisions of Minnesota Statutes, chapter 282, and any other
3.26 law relating to the apportionment of proceeds from the sale or lease of tax-forfeited land,
3.27 Itasca County must apportion the first \$1,000,000 received from the sale or lease of
3.28 tax-forfeited lands within Minnesota Steel Industries permit to mine area near Nashwauk,
3.29 Minnesota, as provided in Laws 1965, chapter 326, section 1, as amended. Any remaining
3.30 proceeds received from the sale or lease must be deposited into a tax-forfeited land
3.31 replacement trust fund established by Itasca County under this section. The principal
3.32 and interest from this fund may be spent only on the purchase of lands to replace the
3.33 tax-forfeited lands sold to Minnesota Steel Industries. Lands purchased with the land
3.34 replacement fund must:

4.1 (1) become subject to trust in favor of the governmental subdivision wherein they lie
4.2 and all laws related to tax-forfeited lands; and

4.3 (2) be for forest management purposes and dedicated as memorial forest under
4.4 Minnesota Statutes, section 459.06, subdivision 2.

4.5 **EFFECTIVE DATE.** This section is effective the day after compliance with
4.6 Minnesota Statutes, section 645.021, subdivision 3, by the governing body of Itasca
4.7 County.

4.11 North, Range 46, Clay County: That part of the Southeast Quarter of Section 11, described
4.12 as follows: Beginning at the southwest corner of the Southeast Quarter of said Section
4.13 11; thence North 00 degrees 13 minutes 06 seconds East (assumed bearing), along the
4.14 westerly line of the Southeast Quarter of said Section 11, for a distance of 503.33 feet;
4.15 thence South 89 degrees 25 minutes 32 seconds East for a distance of 200.00 feet; thence
4.16 North 00 degrees 13 minutes 06 seconds East, parallel to the westerly line of the Southeast
4.17 Quarter of said Section 11, for a distance of 457.87 feet; thence South 89 degrees 44
4.18 minutes 18 seconds East for a distance of 323.00 feet; thence South 48 degrees 16 minutes
4.19 47 seconds East for a distance of 89.46 feet; thence South 29 degrees 17 minutes 10
4.20 seconds East for a distance of 1,035.56 feet to a point of intersection with the southerly
4.21 line of the Southeast Quarter of said Section 11; thence North 89 degrees 44 minutes 18
4.22 seconds West, along the southerly line of the Southeast Quarter of said Section 11, for
4.23 a distance of 1,100.00 feet to the point of beginning. Said tract of land contains 16.133
4.24 acres, more or less, and is subject to the following described ingress-egress easement: A
4.25 30.00-foot strip of land for purposes of ingress and egress centered along the following
4.26 described line: Commencing at the southwest corner of the Southeast Quarter of Section
4.27 11, Township 139 North, Range 46 West, Fifth Principal Meridian, Clay County,
4.28 Minnesota; thence North 00 degrees 13 minutes 06 seconds East (assumed bearing), along
4.29 the westerly line of the Southeast Quarter of said Section 11, for a distance of 15.00 feet to
4.30 the true point of beginning; thence South 89 degrees 44 minutes 18 seconds East, parallel
4.31 to and 15.00 feet northerly of the southerly line of the Southeast Quarter of said Section
4.32 11, for a distance of 797.03 feet; thence North 22 degrees 07 minutes 20 seconds East for a
4.33 distance of 327.76 feet and there terminating.

4.34 **Subd. 2. [85.012] [Subd. 21.] Frontenac State Park, Goodhue County.** The
4.35 following areas are added to Frontenac State Park, Goodhue County:

5.1 (1) all that part of Government Lot 4, and all that part of the Southwest Quarter of
5.2 the Southeast Quarter and of the Southeast Quarter of the Southwest Quarter, all in Section
5.3 2, Township 112 North, Range 13 West, described as follows, to-wit: Beginning at the
5.4 point of intersection of the east and west center line of said Section 2 with the line of the
5.5 west shore of Lake Pepin, running thence West 6 chains; thence South 33 degrees 15
5.6 minutes West 9.60 chains; thence South 41 degrees West 5.54 chains; thence South 51
5.7 degrees 15 minutes West 4.32 chains; thence South 65 degrees 15 minutes West 4 chains;
5.8 thence South 70 degrees 45 minutes West 11.27 chains to a rock in Glenway Street in the
5.9 village of Frontenac; thence South 48 degrees 30 minutes East 4.72 chains to the north and
5.10 south center line of said section; thence South 39 degrees 10 minutes East 11.14 chains;
5.11 thence South 32 degrees 30 minutes East 8.15 chains to the north line of Waconia Avenue
5.12 in said Frontenac; thence North 42 degrees 50 minutes East 5.15 chains; thence North 23
5.13 degrees 50 minutes East 2.75 chains; thence North 9 degrees 20 minutes East 7.90 chains;
5.14 thence North 20 degrees 20 minutes East 4.64 chains; thence North 52 degrees West 3.80
5.15 chains; thence North 20 degrees 20 minutes East 18.40 chains to the east line of said Mill
5.16 Street in said Frontenac; thence South along the east line of said Mill Street 3.76 chains
5.17 to the north line of Lot 8 in Block 13 in said Frontenac; thence along said north line to
5.18 the shore of Lake Pepin; thence along the shore of said lake 1.50 chains to the point of
5.19 beginning, containing in all 35.67 acres of land, more or less. Excepting therefrom all that
5.20 part of Government Lot 4, Section 2, Township 112 North, Range 13 West, described,
5.21 as follows: Beginning on the shore of Lake Pepin at the northeast corner of Lot 8 in
5.22 Block 13 of the town of Frontenac, running thence westerly along the north line of said
5.23 lot to the northwest corner thereof; thence northerly along the easterly line of Mill Street
5.24 in said town of Frontenac 215 feet, more or less, to its intersection with the north line of
5.25 said Government Lot 4; thence East along the north line of said Government Lot 4 to low
5.26 water mark on shore of Lake Pepin; thence southerly along the low water mark of Lake
5.27 Pepin to the place of beginning. Also excepting that part of Government Lot 4, Section 2,
5.28 Township 112 North, Range 12 West, which lies West of Undercliff Street in said village,
5.29 North of the southerly line of said Lot 1, Block 14, prolonged westerly, and East of a line
5.30 beginning 6 chains West of the intersection of the east and west center line of said Section
5.31 2 with the west shore of Lake Pepin, being the point of intersection of the west line of said
5.32 Undercliff Street and said east and west center line; thence South 33 degrees 15 minutes
5.33 West 9.60 chains, being a triangular piece of land; all of Block 14, except Lot 1 of said
5.34 Block 14; Lots 11, 12, 13, 14, 15, 16, 17, 18, and 19 of Block 15, except so much of Lot
5.35 11 in said Block 15 (in a triangular form) as lies between the west end of Lots 2 and 3 of
5.36 said Block 15 and the east line of Bluff Street, all in the town of Frontenac according to

6.1 the accepted and recorded map of said town of Frontenac now on file and of record in the
6.2 Office of the Register of Deeds in and for said County of Goodhue;

6.3 (2) that part of the West Half of the Northeast Quarter of Section 6, Township 112
6.4 North, Range 13 West, Goodhue County, Minnesota, described as follows: Commencing
6.5 at the northeast corner of the West Half of the Northeast Quarter of said Section 6; thence
6.6 South 01 degree 11 minutes 39 seconds East, assumed bearing, along the east line of
6.7 said West Half of the Northeast Quarter of Section 6, a distance of 1,100.00 feet to the
6.8 point of beginning of the land to be described; thence North 01 degree 11 minutes 39
6.9 seconds West, along said east line, a distance of 400.00 feet; thence South 89 degrees 01
6.10 minute 10 seconds West, a distance of 442.03 feet; thence southwesterly, a distance of
6.11 534.99 feet along a nontangential curve concave to the northwest having a radius of

36.30 North at right angles 435.3 feet; thence South 75 degrees 56 minutes West for 294.4 feet
36.31 to said easterly right-of-way of Minnesota Highway 61; thence South 14 degrees 04
36.32 minutes East along said easterly right-of-way of Minnesota Highway 61 for 375.0 feet to
36.33 the point of the beginning; and

36.34 That part of the Northwest Quarter of the Northeast Quarter, Section 5, Township
36.35 32 North, Range 21 West, Washington County, Minnesota, described as follows:

37.1 commencing at the north quarter corner of Section 5; thence East along the north line of
37.2 Section 5, a distance of 538.8 feet to the easterly right-of-way line of Trunk Highway 61;
37.3 thence southeasterly deflection to the right 76 degrees 00 minutes 20 seconds, along
37.4 said highway right-of-way line, 500.4 feet to the point of beginning; thence continuing
37.5 southeasterly along said highway right-of-way line 293.7 feet to the northwest corner of

37.18 **Sec. 53. LEASE OF TAX-FORFEITED AND STATE LANDS.**

37.19 (a) Notwithstanding Minnesota Statutes, section 282.04, or other law to the contrary,
37.20 St. Louis County may enter a 30-year lease of tax-forfeited land for a wind energy project.

37.21 (b) The commissioner of natural resources may enter a 30-year lease of land
37.22 administered by the commissioner for a wind energy project.
