1.5 Section 1. SUMMARY OF APPROPRIATIONS.

1.6 The sums shown in the columns marked "Appropriations" are appropriated from
1.7 the general fund, or another named fund, to the agencies and for the purposes specified in
1.8 this act, to be available for the fiscal year indicated for each purpose, and are added to
1.9 appropriations in Laws 2007, chapters 135 and 147. The figure "2008," where used in
1.10 this act, means that the appropriation or appropriations listed under it are available for
1.11 the year ending June 30, 2008.
