1.1 A bill for an act
1.2 relating to health; requiring the commissioner to provide information on human
1.3 papillomavirus immunization; amending Minnesota Statutes 2006, section
1.4 121A.23, subdivision 1.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2006, section 121A.23, subdivision 1, is amended to
1.7 read:

1.8 Subdivision 1. **Sexually transmitted infections and diseases program.** The
1.9 commissioner of education, in consultation with the commissioner of health, shall assist
1.10 districts in developing and implementing a program to prevent and reduce the risk of
1.11 sexually transmitted infections and diseases, including but not exclusive to human
1.12 immune deficiency virus and human papilloma virus. Each district must have a program
1.13 that includes at least:

1.14 (1) planning materials, guidelines, and other technically accurate and updated
1.15 information;

1.16 (2) a comprehensive, technically accurate, and updated curriculum that includes
1.17 helping students to abstain from sexual activity until marriage;

1.18 (3) cooperation and coordination among districts and SCs;

1.19 (4) a targeting of adolescents, especially those who may be at high risk of contracting
1.20 sexually transmitted infections and diseases, for prevention efforts;

1.21 (5) involvement of parents and other community members;

1.22 (6) in-service training for appropriate district staff and school board members;

2.1 (7) collaboration with state agencies and organizations having a sexually transmitted
2.2 infection and disease prevention or sexually transmitted infection and disease risk
2.3 reduction program;

2.4 (8) collaboration with local community health services, agencies and organizations
2.5 having a sexually transmitted infection and disease prevention or sexually transmitted
2.6 infection and disease risk reduction program; ~~and~~

2.7 (9) participation by state and local student organizations; and

2.8 (10) providing information about human papillomavirus and the vaccine for human
2.9 papillomavirus to parents and guardians of students in kindergarten through grade 12. The
2.10 information must at least include the following:

2.11 (i) the risks associated with human papillomavirus;

2.12 (ii) the availability, effectiveness, and potential risks of immunization for human
2.13 papillomavirus;

2.14 (iii) sources where parents and guardians may obtain additional information about
2.15 human papillomavirus; and

2.16 (iv) sources where parents and guardians may obtain vaccination of a child against
2.17 human papillomavirus.

2.18 The department may provide assistance at a neutral site to a nonpublic school
2.19 participating in a district's program. District programs must not conflict with the health
2.20 and wellness curriculum developed under Laws 1987, chapter 398, article 5, section 2,
2.21 subdivision 7.

2.22 If a district fails to develop and implement a program to prevent and reduce the
2.23 risk of sexually transmitted infection and disease, the department must assist the service
2.24 cooperative in the region serving that district to develop or implement the program.
