1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 Section 1. Minnesota Statutes 2006, section 176.011, subdivision 9, is amended to read:

1.11 Subd. 9. **Employee.** "Employee" means any person who performs services for

1.12 another for hire including the following:

1.13 (1) an alien;

1.14 (2) a minor;

1.15 (3) a sheriff, deputy sheriff, police officer, firefighter, county highway engineer, and

1.16 peace officer while engaged in the enforcement of peace or in the pursuit or capture of a

1.17 person charged with or suspected of crime;

1.18 (4) a person requested or commanded to aid an officer in arresting or retaking a

1.19 person who has escaped from lawful custody, or in executing legal process, in which

1.20 cases, for purposes of calculating compensation under this chapter, the daily wage of the

1.21 person shall be the prevailing wage for similar services performed by paid employees;

1.22 (5) a county assessor;

1.23 (6) an elected or appointed official of the state, or of a county, city, town, school

1.24 district, or governmental subdivision in the state. An officer of a political subdivision

1.25 elected or appointed for a regular term of office, or to complete the unexpired portion of a

2.1 regular term, shall be included only after the governing body of the political subdivision  
2.2 has adopted an ordinance or resolution to that effect;

2.3 (7) an executive officer of a corporation, except those executive officers excluded  
2.4 by section 176.041;

2.5 (8) a voluntary uncompensated worker, other than an inmate, rendering services in  
2.6 state institutions under the commissioners of human services and corrections similar to  
2.7 those of officers and employees of the institutions, and whose services have been accepted  
2.8 or contracted for by the commissioner of human services or corrections as authorized by  
2.9 law. In the event of injury or death of the worker, the daily wage of the worker, for the  
2.10 purpose of calculating compensation under this chapter, shall be the usual wage paid at  
2.11 the time of the injury or death for similar services in institutions where the services are  
2.12 performed by paid employees;

2.13 (9) a voluntary uncompensated worker engaged in emergency management as  
2.14 defined in section 12.03, subdivision 4, who is:

2.15 (i) registered with the state or any political subdivision of it, according to the  
2.16 procedures set forth in the state or political subdivision emergency operations plan; and

2.17 (ii) acting under the direction and control of, and within the scope of duties approved  
2.18 by, the state or political subdivision.

2.19 The daily wage of the worker, for the purpose of calculating compensation under this  
2.20 chapter, shall be the usual wage paid at the time of the injury or death for similar services  
2.21 performed by paid employees;

2.22 (10) a voluntary uncompensated worker participating in a program established by a  
2.23 local social services agency. For purposes of this clause, "local social services agency"  
2.24 means any agency established under section 393.01. In the event of injury or death of the  
2.25 worker, the wage of the worker, for the purpose of calculating compensation under this  
2.26 chapter, shall be the usual wage paid in the county at the time of the injury or death for  
2.27 similar services performed by paid employees working a normal day and week;

2.28 (11) a voluntary uncompensated worker accepted by the commissioner of natural  
2.29 resources who is rendering services as a volunteer pursuant to section 84.089. The daily  
2.30 wage of the worker for the purpose of calculating compensation under this chapter, shall  
2.31 be the usual wage paid at the time of injury or death for similar services performed by  
2.32 paid employees;

2.33 (12) a voluntary uncompensated worker in the building and construction industry  
2.34 who renders services for joint labor-management nonprofit community service projects.  
2.35 The daily wage of the worker for the purpose of calculating compensation under this

3.1 chapter shall be the usual wage paid at the time of injury or death for similar services  
3.2 performed by paid employees;

3.3 (13) a member of the military forces, as defined in section 190.05, while in state  
3.4 active service, as defined in section 190.05, subdivision 5a. The daily wage of the member  
3.5 for the purpose of calculating compensation under this chapter shall be based on the  
3.6 member's usual earnings in civil life. If there is no evidence of previous occupation or  
3.7 earning, the trier of fact shall consider the member's earnings as a member of the military  
3.8 forces;

3.9 (14) a voluntary uncompensated worker, accepted by the director of the Minnesota  
3.10 Historical Society, rendering services as a volunteer, pursuant to chapter 138. The daily  
3.11 wage of the worker, for the purposes of calculating compensation under this chapter,  
3.12 shall be the usual wage paid at the time of injury or death for similar services performed  
3.13 by paid employees;

3.14 (15) a voluntary uncompensated worker, other than a student, who renders services  
3.15 at the Minnesota State Academy for the Deaf or the Minnesota State Academy for the  
3.16 Blind, and whose services have been accepted or contracted for by the commissioner of  
3.17 education, as authorized by law. In the event of injury or death of the worker, the daily  
3.18 wage of the worker, for the purpose of calculating compensation under this chapter, shall  
3.19 be the usual wage paid at the time of the injury or death for similar services performed in  
3.20 institutions by paid employees;

3.21 (16) a voluntary uncompensated worker, other than a resident of the veterans home,  
3.22 who renders services at a Minnesota veterans home, and whose services have been  
3.23 accepted or contracted for by the commissioner of veterans affairs, as authorized by law.  
3.24 In the event of injury or death of the worker, the daily wage of the worker, for the purpose  
3.25 of calculating compensation under this chapter, shall be the usual wage paid at the time of  
3.26 the injury or death for similar services performed in institutions by paid employees;

3.27 (17) a worker ~~who renders in-home attendant care services to a physically disabled~~  
3.28 ~~person, and who is paid directly by the commissioner of human services for these services;~~  
3.29 ~~shall be an employee of the state within the meaning of this subdivision, but for no other~~  
3.30 ~~purpose; performing services under section 256B.0655 for a recipient in the home of the~~  
3.31 recipient or in the community under section 256B.0625, subdivision 19a, who is paid from  
3.32 government funds through a fiscal intermediary under section 256B.0655, subdivision  
3.33 7. For purposes of maintaining workers' compensation insurance, the employer of the  
3.34 worker is as designated in law by the commissioner of the Department of Human Services,  
3.35 notwithstanding any other law to the contrary.

4.1 (18) students enrolled in and regularly attending the Medical School of the  
4.2 University of Minnesota in the graduate school program or the postgraduate program. The  
4.3 students shall not be considered employees for any other purpose. In the event of the  
4.4 student's injury or death, the weekly wage of the student for the purpose of calculating  
4.5 compensation under this chapter, shall be the annualized educational stipend awarded to  
4.6 the student, divided by 52 weeks. The institution in which the student is enrolled shall  
4.7 be considered the "employer" for the limited purpose of determining responsibility for  
4.8 paying benefits under this chapter;

4.9 (19) a faculty member of the University of Minnesota employed for an academic  
4.10 year is also an employee for the period between that academic year and the succeeding  
4.11 academic year if:

4.12 (a) the member has a contract or reasonable assurance of a contract from the  
4.13 University of Minnesota for the succeeding academic year; and

4.14 (b) the personal injury for which compensation is sought arises out of and in the  
4.15 course of activities related to the faculty member's employment by the University of  
4.16 Minnesota;

4.17 (20) a worker who performs volunteer ambulance driver or attendant services is an  
4.18 employee of the political subdivision, nonprofit hospital, nonprofit corporation, or other  
4.19 entity for which the worker performs the services. The daily wage of the worker for the  
4.20 purpose of calculating compensation under this chapter shall be the usual wage paid at the  
4.21 time of injury or death for similar services performed by paid employees;

4.22 (21) a voluntary uncompensated worker, accepted by the commissioner of  
4.23 administration, rendering services as a volunteer at the Department of Administration. In  
4.24 the event of injury or death of the worker, the daily wage of the worker, for the purpose of  
4.25 calculating compensation under this chapter, shall be the usual wage paid at the time of the  
4.26 injury or death for similar services performed in institutions by paid employees;

4.27 (22) a voluntary uncompensated worker rendering service directly to the Pollution  
4.28 Control Agency. The daily wage of the worker for the purpose of calculating compensation  
4.29 payable under this chapter is the usual going wage paid at the time of injury or death for  
4.30 similar services if the services are performed by paid employees;

4.31 (23) a voluntary uncompensated worker while volunteering services as a first  
4.32 responder or as a member of a law enforcement assistance organization while acting under  
4.33 the supervision and authority of a political subdivision. The daily wage of the worker for  
4.34 the purpose of calculating compensation payable under this chapter is the usual going  
4.35 wage paid at the time of injury or death for similar services if the services are performed  
4.36 by paid employees; ~~and~~

5.1 (24) a voluntary uncompensated member of the civil air patrol rendering service on  
5.2 the request and under the authority of the state or any of its political subdivisions. The  
5.3 daily wage of the member for the purposes of calculating compensation payable under this  
5.4 chapter is the usual going wage paid at the time of injury or death for similar services if  
5.5 the services are performed by paid employees; and

5.6 (25) a Minnesota Responds Medical Reserve Corps volunteer, as provided in  
5.7 sections 145A.04 and 145A.06, responding at the request of or engaged in training  
5.8 conducted by the commissioner of health. The daily wage of the volunteer for the purposes  
5.9 of calculating compensation payable under this chapter is established in section 145A.06.  
5.10 A person who qualifies under this clause and who may also qualify under another clause  
5.11 of this subdivision shall receive benefits in accordance with this clause.

5.12 If it is difficult to determine the daily wage as provided in this subdivision, the trier  
5.13 of fact may determine the wage upon which the compensation is payable.

5.14 **EFFECTIVE DATE.** Clause (25) is effective the day that amendments to  
5.15 Minnesota Statutes, sections 145A.04 to 145A.06, related to Medical Reserve Corps  
5.16 volunteers, are effective. The other amendments to this section are effective the day  
5.17 following final enactment.

5.18 Sec. 2. Minnesota Statutes 2006, section 176.041, subdivision 1, is amended to read:

5.19 Subdivision 1. **Employments excluded.** This chapter does not apply to any of  
5.20 the following:

5.21 (a) a person employed by a common carrier by railroad engaged in interstate or  
5.22 foreign commerce and who is covered by the Federal Employers' Liability Act, United  
5.23 States Code, title 45, sections 51 to 60, or other comparable federal law;

5.24 (b) a person employed by a family farm as defined by section 176.011, subdivision  
5.25 11a;

5.26 (c) the spouse, parent, and child, regardless of age, of a farmer-employer working  
5.27 for the farmer-employer;

5.28 (d) a sole proprietor, or the spouse, parent, and child, regardless of age, of a sole  
5.29 proprietor;

5.30 (e) a partner engaged in a farm operation or a partner engaged in a business and the  
5.31 spouse, parent, and child, regardless of age, of a partner in the farm operation or business;

5.32 (f) an executive officer of a family farm corporation;

5.33 (g) an executive officer of a closely held corporation having less than 22,880 hours  
5.34 of payroll in the preceding calendar year, if that executive officer owns at least 25 percent  
5.35 of the stock of the corporation;

6.1 (h) a spouse, parent, or child, regardless of age, of an executive officer of a family  
6.2 farm corporation as defined in section 500.24, subdivision 2, and employed by that  
6.3 family farm corporation;

6.4 (i) a spouse, parent, or child, regardless of age, of an executive officer of a closely  
6.5 held corporation who is referred to in paragraph (g);

6.6 (j) another farmer or a member of the other farmer's family exchanging work with  
6.7 the farmer-employer or family farm corporation operator in the same community;

6.8 (k) a person whose employment at the time of the injury is casual and not in the  
6.9 usual course of the trade, business, profession, or occupation of the employer;

6.10 (l) persons who are independent contractors as defined by section 181.723 and any  
6.11 rules adopted by the commissioner pursuant to section 176.83 except that ~~this exclusion~~  
6.12 does these exclusions do not apply to an employee of an independent contractor;

6.13 (m) an officer or a member of a veterans' organization whose employment  
6.14 relationship arises solely by virtue of attending meetings or conventions of the veterans'  
6.15 organization, unless the veterans' organization elects by resolution to provide coverage  
6.16 under this chapter for the officer or member;

6.17 (n) a person employed as a household worker in, for, or about a private home  
6.18 or household who earns less than \$1,000 in cash in a three-month period from a single  
6.19 private home or household provided that a household worker who has earned \$1,000 or  
6.20 more from the household worker's present employer in a three-month period within the  
6.21 previous year is covered by this chapter regardless of whether or not the household worker  
6.22 has earned \$1,000 in the present quarter;

6.23 (o) persons employed by a closely held corporation who are related by blood or  
6.24 marriage, within the third degree of kindred according to the rules of civil law, to an  
6.25 officer of the corporation, who is referred to in paragraph (g), if the corporation files a  
6.26 written election with the commissioner to exclude such individuals. A written election is  
6.27 not required for a person who is otherwise excluded from this chapter by this section;

6.28 (p) a nonprofit association which does not pay more than \$1,000 in salary or wages  
6.29 in a year;

6.30 (q) persons covered under the Domestic Volunteer Service Act of 1973, as amended,  
6.31 United States Code, title 42, sections 5011, et seq.;

6.32 (r) a manager of a limited liability company having ten or fewer members and  
6.33 having less than 22,880 hours of payroll in the preceding calendar year, if that manager  
6.34 owns at least a 25 percent membership interest in the limited liability company;

6.35 (s) a spouse, parent, or child, regardless of age, of a manager of a limited liability  
6.36 company described in paragraph (r);

- 7.1 (t) persons employed by a limited liability company having ten or fewer members  
7.2 and having less than 22,880 hours of payroll in the preceding calendar year who are related  
7.3 by blood or marriage, within the third degree of kindred according to the rules of civil law,  
7.4 to a manager of a limited liability company described in paragraph (r), if the company files  
7.5 a written election with the commissioner to exclude these persons. A written election is  
7.6 not required for a person who is otherwise excluded from this chapter by this section; or  
7.7 (u) members of limited liability companies who satisfy the requirements of  
7.8 paragraph (l).

7.9 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.10 Sec. 3. Minnesota Statutes 2006, section 176.101, subdivision 1, is amended to read:

7.11 Subdivision 1. **Temporary total disability.** (a) For injury producing temporary total  
7.12 disability, the compensation is 66-2/3 percent of the weekly wage at the time of injury.

7.13 (b)(1) Commencing on October 1, ~~2000~~ 2008, the maximum weekly compensation  
7.14 payable is ~~\$750~~ \$850 per week.

7.15 (2) The Workers' Compensation Advisory Council may consider adjustment  
7.16 increases and make recommendations to the legislature.

7.17 (c) The minimum weekly compensation payable is \$130 per week or the injured  
7.18 employee's actual weekly wage, whichever is less.

7.19 (d) Temporary total compensation shall be paid during the period of disability  
7.20 subject to the cessation and recommencement conditions in paragraphs (e) to (l).

7.21 (e) Temporary total disability compensation shall cease when the employee returns  
7.22 to work. Except as otherwise provided in section 176.102, subdivision 11, temporary  
7.23 total disability compensation may only be recommenced following cessation under this  
7.24 paragraph, paragraph (h), or paragraph (j) prior to payment of ~~104~~ 130 weeks of temporary  
7.25 total disability compensation and only as follows:

7.26 (1) if temporary total disability compensation ceased because the employee returned  
7.27 to work, it may be recommenced if the employee is laid off or terminated for reasons other  
7.28 than misconduct if the layoff or termination occurs prior to 90 days after the employee  
7.29 has reached maximum medical improvement. Recommenced temporary total disability  
7.30 compensation under this clause ceases when any of the cessation events in paragraphs  
7.31 (e) to (l) occurs; or

7.32 (2) if temporary total disability compensation ceased because the employee returned  
7.33 to work or ceased under paragraph (h) or (j), it may be recommenced if the employee is  
7.34 medically unable to continue at a job due to the injury. Where the employee is medically  
7.35 unable to continue working due to the injury, temporary total disability compensation

8.1 may continue until any of the cessation events in paragraphs (e) to (l) occurs following  
8.2 recommencement. If an employee who has not yet received temporary total disability  
8.3 compensation becomes medically unable to continue working due to the injury after  
8.4 reaching maximum medical improvement, temporary total disability compensation shall  
8.5 commence and shall continue until any of the events in paragraphs (e) to (l) occurs  
8.6 following commencement. For purposes of commencement or recommencement under  
8.7 this clause only, a new period of maximum medical improvement under paragraph  
8.8 (j) begins when the employee becomes medically unable to continue working due to  
8.9 the injury. Temporary total disability compensation may not be recommenced under  
8.10 this clause and a new period of maximum medical improvement does not begin if the  
8.11 employee is not actively employed when the employee becomes medically unable to  
8.12 work. All periods of initial and recommenced temporary total disability compensation are  
8.13 included in the ~~104-week~~ 130-week limitation specified in paragraph (k).

8.14 (f) Temporary total disability compensation shall cease if the employee withdraws  
8.15 from the labor market. Temporary total disability compensation may be recommenced  
8.16 following cessation under this paragraph only if the employee reenters the labor market  
8.17 prior to 90 days after the employee reached maximum medical improvement and  
8.18 prior to payment of ~~104~~ 130 weeks of temporary total disability compensation. Once  
8.19 recommenced, temporary total disability ceases when any of the cessation events in  
8.20 paragraphs (e) to (l) occurs.

8.21 (g) Temporary total disability compensation shall cease if the total disability ends  
8.22 and the employee fails to diligently search for appropriate work within the employee's  
8.23 physical restrictions. Temporary total disability compensation may be recommenced  
8.24 following cessation under this paragraph only if the employee begins diligently searching  
8.25 for appropriate work within the employee's physical restrictions prior to 90 days after  
8.26 maximum medical improvement and prior to payment of ~~104~~ 130 weeks of temporary total  
8.27 disability compensation. Once recommenced, temporary total disability compensation  
8.28 ceases when any of the cessation events in paragraphs (e) to (l) occurs.

8.29 (h) Temporary total disability compensation shall cease if the employee has been  
8.30 released to work without any physical restrictions caused by the work injury.

8.31 (i) Temporary total disability compensation shall cease if the employee refuses an  
8.32 offer of work that is consistent with a plan of rehabilitation filed with the commissioner  
8.33 which meets the requirements of section 176.102, subdivision 4, or, if no plan has been  
8.34 filed, the employee refuses an offer of gainful employment that the employee can do in the  
8.35 employee's physical condition. Once temporary total disability compensation has ceased  
8.36 under this paragraph, it may not be recommenced.

9.1 (j) Temporary total disability compensation shall cease 90 days after the employee  
9.2 has reached maximum medical improvement, except as provided in section 176.102,  
9.3 subdivision 11, paragraph (b). For purposes of this subdivision, the 90-day period after  
9.4 maximum medical improvement commences on the earlier of: (1) the date that the  
9.5 employee receives a written medical report indicating that the employee has reached  
9.6 maximum medical improvement; or (2) the date that the employer or insurer serves the  
9.7 report on the employee and the employee's attorney, if any. Once temporary total disability  
9.8 compensation has ceased under this paragraph, it may not be recommenced except if the  
9.9 employee returns to work and is subsequently medically unable to continue working  
9.10 as provided in paragraph (e), clause (2).

9.11 (k) Temporary total disability compensation shall cease entirely when ~~104~~ 130 weeks  
9.12 of temporary total disability compensation have been paid, except as provided in section  
9.13 176.102, subdivision 11, paragraph (b). Notwithstanding anything in this section to the  
9.14 contrary, initial and recommenced temporary total disability compensation combined shall  
9.15 not be paid for more than ~~104~~ 130 weeks, regardless of the number of weeks that have  
9.16 elapsed since the injury, except that if the employee is in a retraining plan approved under  
9.17 section 176.102, subdivision 11, the ~~104-week~~ 130-week limitation shall not apply during  
9.18 the retraining, but is subject to the limitation before the plan begins and after the plan ends.

9.19 (l) Paragraphs (e) to (k) do not limit other grounds under law to suspend or  
9.20 discontinue temporary total disability compensation provided under this chapter.

9.21 (m) Once an employee has been paid 52 weeks of temporary total compensation,  
9.22 the employer or insurer must notify the employee in writing of the ~~104-week~~ 130-week  
9.23 limitation on payment of temporary total compensation. A copy of this notice must also  
9.24 be filed with the department.

9.25 **EFFECTIVE DATE.** This section is effective for injuries occurring on or after  
9.26 October 1, 2008.

9.27 Sec. 4. Minnesota Statutes 2006, section 176.102, subdivision 2, is amended to read:

9.28 Subd. 2. **Administrators.** (a) The commissioner shall hire a director of  
9.29 rehabilitation services in the classified service. The commissioner shall monitor and  
9.30 supervise rehabilitation services, including, but not limited to, making determinations  
9.31 regarding the selection and delivery of rehabilitation services and the criteria used to  
9.32 approve qualified rehabilitation consultants and rehabilitation vendors. The commissioner  
9.33 may also make determinations regarding fees for rehabilitation services and shall by  
9.34 rule establish a fee schedule or otherwise limit fees charged by qualified rehabilitation  
9.35 consultants and vendors. The commissioner shall annually review the fees and give notice

10.1 of any adjustment in the State Register. ~~By March 1, 1993, the commissioner shall report~~  
10.2 ~~to the legislature on the status of the commission's monitoring of rehabilitation services.~~  
10.3 The commissioner may hire qualified personnel to assist in the commissioner's duties  
10.4 under this section and may delegate the duties and performance.

10.5 (b) On October 1, 2008, the maximum hourly rate for rehabilitation services under

10.14 Sec. 5. Minnesota Statutes 2006, section 176.102, subdivision 11, is amended to read:

10.15 Subd. 11. **Retraining; compensation.** (a) Retraining is limited to 156 weeks.  
10.16 An employee who has been approved for retraining may petition the commissioner  
10.17 or compensation judge for additional compensation not to exceed 25 percent of the  
10.18 compensation otherwise payable. If the commissioner or compensation judge determines  
10.19 that this additional compensation is warranted due to unusual or unique circumstances of  
10.20 the employee's retraining plan, the commissioner may award additional compensation in  
10.21 an amount not to exceed the employee's request. This additional compensation shall cease  
10.22 at any time the commissioner or compensation judge determines the special circumstances  
10.23 are no longer present.

10.24 (b) If the employee is not employed during a retraining plan that has been  
10.25 specifically approved under this section, temporary total compensation is payable for up  
10.26 to 90 days after the end of the retraining plan; except that, payment during the 90-day  
10.27 period is subject to cessation in accordance with section 176.101. If the employee is  
10.28 employed during the retraining plan but earning less than at the time of injury, temporary
