A bill for an act

relating to commerce; regulating certain transactions with homeowners whose homes are in foreclosure; amending Minnesota Statutes 2006, sections 325N.01; 325N.03; 325N.04; 325N.10, subdivisions 3, 4, by adding a subdivision; 325N.13; 325N.14; 325N.17; 325N.18, by adding a subdivision; Laws 2004, chapter 263, section 26.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2006, section 325N.01, is amended to read:

325N.01 DEFINITIONS.

The definitions in paragraphs (a) to (h) apply to sections 325N.01 to 325N.09.

(a) "Foreclosure consultant" means any person who, directly or indirectly, makes any solicitation, representation, or offer to any owner to perform for compensation or who, for compensation, performs any service which the person in any manner represents will in any manner do any of the following:

- (1) stop or postpone the foreclosure sale;
- (2) obtain any forbearance from any beneficiary or mortgagee;
- (3) assist the owner to exercise the right of reinstatement provided in section 580.30;
- (4) obtain any extension of the period within which the owner may reinstate the owner's obligation;
- (5) obtain any waiver of an acceleration clause contained in any promissory note or contract secured by a mortgage on a residence in foreclosure or contained in the mortgage;
- (6) assist the owner in foreclosure or loan default to obtain a loan or advance of funds;
- (7) avoid or ameliorate the impairment of the owner's credit resulting from the recording of a notice of default or the conduct of a foreclosure sale; or

- 2.1 (8) save the owner's residence from foreclosure.
- 2.2 (b) A foreclosure consultant does not include any of the following:
- 2.3 (1) a person licensed to practice law in this state when the person renders service
- 2.4 in the course of his or her practice as an attorney-at-law;
- 2.5 (2) a person licensed as a debt prorater under sections 332.12 to 332.29, when the
- 2.6 person is acting as a debt prorater as defined in these sections;
- 2.7 (3) a person licensed as a real estate broker or salesperson under chapter 82 when the
- 2.8 person engages in acts whose performance requires licensure under that chapter unless the
- 2.9 person is engaged in offering services designed to, or purportedly designed to, enable the
- 2.10 owner to retain possession of the residence in foreclosure;
- 2.11 (4) a person licensed as an accountant under chapter 326A when the person is acting
- 2.12 in any capacity for which the person is licensed under those provisions;
- 2.13 (5) a person or the person's authorized agent acting under the express authority
- 2.14 or written approval of the Department of Housing and Urban Development or other
- 2.15 department or agency of the United States or this state to provide services;
- 2.16 (6) a person who holds or is owed an obligation secured by a lien on any residence
- 2.17 in foreclosure when the person performs services in connection with this obligation or lien
- 2.18 if the obligation or lien did not arise as the result of or as part of a proposed foreclosure
- 2.19 reconveyance;
- 2.20 (7) any person or entity doing business under any law of this state, or of the United
- 2.21 States relating to banks, trust companies, savings and loan associations, industrial loan and
- 2.22 thrift companies, regulated lenders, credit unions, insurance companies, or a mortgagee
- 2.23 which is a United States Department of Housing and Urban Development approved
- 2.24 mortgagee and any subsidiary or affiliate of these persons or entities, and any agent or
- 2.25 employee of these persons or entities while engaged in the business of these persons
- 2.26 or entities;
- 2.27 (8) a person licensed as a residential mortgage originator or servicer pursuant to
- 2.28 chapter 58, when acting under the authority of that license ~~or a foreclosure purchaser as~~
- 2.29 ~~defined in section 325N.10;~~
- 2.30 (9) a nonprofit agency or organization that offers counseling or advice to an owner
- 2.31 of a home in foreclosure or loan default if they do not contract for services with for-profit
- 2.32 lenders or foreclosure purchasers; ~~and~~
- 2.33 (10) a judgment creditor of the owner, to the extent that the judgment creditor's claim
- 2.34 accrued prior to the personal service of the foreclosure notice required by section 580.03,
- 2.35 but excluding a person who purchased the claim after such personal service; and
- 2.36 (11) a foreclosure purchaser as defined in section 325N.10.

3.1 (c) "Foreclosure reconveyance" means a transaction involving:

3.2 (1) the transfer of title to real property by a foreclosed homeowner during a
3.3 foreclosure proceeding, either by transfer of interest from the foreclosed homeowner or
3.4 by creation of a mortgage or other lien or encumbrance during the foreclosure process
3.5 that allows the acquirer to obtain title to the property by redeeming the property as
3.6 a junior lienholder; and

3.7 (2) the subsequent conveyance, or promise of a subsequent conveyance, of
3.8 an interest back to the foreclosed homeowner by the acquirer or a person acting in
3.9 participation with the acquirer that allows the foreclosed homeowner to possess either
3.10 the residence in foreclosure or any other real property following the completion of the
3.11 foreclosure proceeding, which interest includes, but is not limited to, an interest in a
3.12 contract for deed, purchase agreement, option to purchase, or lease.

3.13 (d) "Person" means any individual, partnership, corporation, limited liability
3.14 company, association, or other group, however organized.

3.15 (e) "Service" means and includes, but is not limited to, any of the following:

3.16 (1) debt, budget, or financial counseling of any type;

3.17 (2) receiving money for the purpose of distributing it to creditors in payment or
3.18 partial payment of any obligation secured by a lien on a residence in foreclosure;

3.19 (3) contacting creditors on behalf of an owner of a residence in foreclosure;

3.20 (4) arranging or attempting to arrange for an extension of the period within which
3.21 the owner of a residence in foreclosure may cure the owner's default and reinstate his or
3.22 her obligation pursuant to section 580.30;

3.23 (5) arranging or attempting to arrange for any delay or postponement of the time of
3.24 sale of the residence in foreclosure;

3.25 (6) advising the filing of any document or assisting in any manner in the preparation
3.26 of any document for filing with any bankruptcy court; or

3.27 (7) giving any advice, explanation, or instruction to an owner of a residence in
3.28 foreclosure, which in any manner relates to the cure of a default in or the reinstatement
3.29 of an obligation secured by a lien on the residence in foreclosure, the full satisfaction of
3.30 that obligation, or the postponement or avoidance of a sale of a residence in foreclosure,
3.31 pursuant to a power of sale contained in any mortgage.

3.32 (f) "Residence in foreclosure" means residential real property consisting of one to
3.33 four family dwelling units, one of which the owner occupies as his or her principal place
3.34 of residence, ~~and against which there is an outstanding notice of pendency of foreclosure,~~
3.35 ~~recorded pursuant to section 580.032, or against which a summons and complaint has been~~
3.36 ~~served under chapter 581~~ where there is a delinquency or default on any loan payment

4.1 or debt secured by or attached to the residential real property including, but not limited
4.2 to, contract for deed payments.

4.3 (g) "Owner" means the record owner of the residential real property in foreclosure at
4.4 the time the notice of pendency was recorded, or the summons and complaint served.

4.5 (h) "Contract" means any agreement, or any term in any agreement, between
4.6 a foreclosure consultant and an owner for the rendition of any service as defined in
4.7 paragraph (e).

4.8 Sec. 2. Minnesota Statutes 2006, section 325N.03, is amended to read:

4.9 **325N.03 CONTRACT.**

4.10 (a) Every contract must be in writing and must fully disclose the exact nature of the
4.11 foreclosure consultant's services and the total amount and terms of compensation.

4.12 (b) The following notice, printed in at least 14-point boldface type and completed
4.13 with the name of the foreclosure consultant, must be printed immediately above the
4.14 statement required by paragraph (c):

4.15 "NOTICE REQUIRED BY MINNESOTA LAW
4.16 (Name) or anyone working for him
4.17 or her CANNOT:
4.18 (1) Take any money from you or ask you for money
4.19 until (Name) has completely finished
4.20 doing everything he or she said he or she would do;
4.21 and
4.22 (2) Ask you to sign or have you sign any lien,
4.23 mortgage, or deed."

4.24 (c) The contract must be written in the same language as principally used by the
4.25 foreclosure consultant to describe his or her services or to negotiate the contract, must
4.26 be dated and signed by the owner, and must contain in immediate proximity to the space
4.27 reserved for the owner's signature a conspicuous statement in a size equal to at least
4.28 10-point boldface type, as follows:

4.29 "You, the owner, may cancel this transaction at any time prior to midnight of the
4.30 third business day after the date of this transaction. See the attached notice of
4.31 cancellation form for an explanation of this right."

4.32 (d) The notice of cancellation must contain, and the contract must contain on the
4.33 first page, in a type size no smaller than that generally used in the body of the document,
4.34 each of the following:

4.35 (1) the name and physical address of the foreclosure consultant to which the notice
4.36 of cancellation is to be mailed or otherwise delivered. A post office box may be designated
4.37 for delivery by mail only if it is accompanied by a physical address at which the notice

5.1 could be delivered by a method other than mail. An e-mail address may be included, in
5.2 addition to the physical address; and

5.3 (2) the date the owner signed the contract.

5.4 (e) Cancellation occurs when the foreclosed homeowner delivers, by any means,
5.5 written notice of cancellation to the address specified in the contract. If cancellation is
5.6 mailed, delivery is effective upon mailing. If e-mailed, cancellation is effective upon
5.7 transmission. The contract must be accompanied by a completed form in duplicate,
5.8 captioned "notice of cancellation," which must be attached to the contract, must be easily
5.9 detachable, and must contain in at least 10-point type the following statement written in
5.10 the same language as used in the contract:

5.11 "NOTICE OF CANCELLATION

5.12
5.13 (Enter date of transaction) (Date)

5.14 You may cancel this transaction, without any penalty
5.15 or obligation, within three business days from the
5.16 above date.

5.17 To cancel this transaction, you may use any of the
5.18 following methods: (1) mail or otherwise deliver a
5.19 signed and dated copy of this cancellation notice, or
5.20 any other written notice of cancellation; or (2) e-mail
5.21 a notice of cancellation

5.36 (f) The foreclosure consultant shall provide the owner with a copy of the contract
5.37 and the attached notice of cancellation immediately upon execution of the contract.

5.38 (g) The three business days during which the owner may cancel the contract shall
5.39 not begin to run until the foreclosure consultant has complied with this section.

5.40 Sec. 3. Minnesota Statutes 2006, section 325N.04, is amended to read:

5.41 **325N.04 VIOLATIONS.**

6.1 It is a violation for a foreclosure consultant to:

6.2 (1) claim, demand, charge, collect, or receive any compensation until after the
6.3 foreclosure consultant has fully performed each and every service the foreclosure
6.4 consultant contracted to perform or represented he or she would perform;

6.5 (2) claim, demand, charge, collect, or receive any fee, interest, or any other
6.6 compensation for any reason which exceeds eight percent per annum of the amount of
6.7 any loan which the foreclosure consultant may make to the owner. Such a loan must not,
6.8 as provided in clause (3), be secured by the residence in foreclosure or any other real or
6.9 personal property;

6.10 (3) take any wage assignment, any lien of any type on real or personal property, or
6.11 other security to secure the payment of compensation. Any such security is void and
6.12 unenforceable;

6.13 (4) receive any consideration from any third party in connection with services
6.14 rendered to an owner unless the consideration is first fully disclosed to the owner;

6.15 (5) acquire any interest, directly or indirectly, or by means of a subsidiary or affiliate
6.16 in a residence in foreclosure from an owner with whom the foreclosure consultant has
6.17 contracted;

6.18 (6) take any power of attorney from an owner for any purpose, except to inspect
6.19 documents as provided by law; or

6.20 (7) induce or attempt to induce any owner to enter a contract which does not comply
6.21 in all respects with sections 325N.02 and 325N.03.

6.22 Sec. 4. Minnesota Statutes 2006, section 325N.10, subdivision 3, is amended to read:

6.23 Subd. 3. **Foreclosure reconveyance.** "Foreclosure reconveyance" means a
6.24 transaction involving:

6.25 (1) the transfer of title to real property by a foreclosed homeowner during a
6.26 foreclosure proceeding, either by transfer of interest from the foreclosed homeowner or
6.27 by creation of a mortgage or other lien or encumbrance during the foreclosure process
6.28 that allows the acquirer to obtain title to the property by redeeming the property as
6.29 a junior lienholder; and

6.30 (2) the subsequent conveyance, or promise of a subsequent conveyance, of
6.31 an interest back to the foreclosed homeowner by the acquirer or a person acting in
6.32 participation with the acquirer that allows the foreclosed homeowner to possess either the
6.33 residence in foreclosure or other real property following the completion of the foreclosure
6.34 proceeding, which interest includes, but is not limited to, an interest in a contract for deed,

7.1 Sec. 5. Minnesota Statutes 2006, section 325N.10, subdivision 4, is amended to read:

7.2 Subd. 4. **Foreclosure purchaser.** "Foreclosure purchaser" means a person that has
7.3 acted as the acquirer in ~~more than one~~ a foreclosure reconveyance during any 24-month
7.4 period. Foreclosure purchaser also includes a person that has acted in joint venture or joint
7.5 enterprise with one or more acquirers in ~~more than one~~ a foreclosure reconveyance during
7.6 any 24-month period. A foreclosure purchaser does not include: (i) a natural person
7.7 who shows that the natural person is not in the business of foreclosure purchasing and
7.8 has a prior personal relationship with the foreclosed homeowner, or (ii) a federal or state
7.9 chartered bank, savings bank, thrift, or credit union is not a foreclosure purchaser.

7.10 Sec. 6. Minnesota Statutes 2006, section 325N.10, is amended by adding a subdivision
7.11 to read:

7.12 Subd. 7. **Residence in foreclosure.** "Residence in foreclosure" means residential
7.13 real property consisting of one to four family dwelling units, one of which the owner
7.14 occupies as the owner's principal place of residence, where there is a delinquency or
7.15 default on any loan payment or debt secured by or attached to the residential real property,
7.16 including, but not limited to, contract for deed payments.

7.17 Sec. 7. Minnesota Statutes 2006, section 325N.13, is amended to read:

7.18 **325N.13 CONTRACT CANCELLATION.**

7.19 (a) In addition to any other right of rescission, the foreclosed homeowner has
7.20 the right to cancel any contract with a foreclosure purchaser until midnight of the fifth
7.21 business day following the day on which the foreclosed homeowner signs a contract that
7.22 complies with sections 325N.10 to 325N.15 or until 8:00 a.m. on the last day of the period
7.23 during which the foreclosed homeowner has a right of redemption, whichever occurs first.

7.24 (b) Cancellation occurs when the foreclosed homeowner delivers, by any means,
7.25 written notice of cancellation ~~to the address specified in the contract,~~ provided that, at a
7.26 minimum, the contract and the notice of cancellation must contain a physical address to
7.27 which notice of cancellation may be mailed or otherwise delivered. A post office box may
7.28 be designated for delivery by mail only if it is accompanied by a physical address at which
7.29 the notice could be delivered by a method other than mail. An e-mail address may be
7.30 provided in addition to the physical address. If cancellation is mailed, delivery is effective
7.31 upon mailing. If e-mailed, cancellation is effective upon transmission.

7.32 (c) A notice of cancellation given by the foreclosed homeowner need not take the
7.33 particular form as provided with the contract.

8.1 (d) Within ten days following receipt of a notice of cancellation given in accordance
 8.2 with this section, the foreclosure purchaser shall return without condition any original
 8.3 contract and any other documents signed by the foreclosed homeowner.

8.4 Sec. 8. Minnesota Statutes 2006, section 325N.14, is amended to read:

8.5 **325N.14 NOTICE OF CANCELLATION.**

8.6 (a) The contract must contain in immediate proximity to the space reserved for the
 8.7 foreclosed homeowner's signature a conspicuous statement in a size equal to at least
 8.8 14-point boldface type, if the contract is printed, or in capital letters, if the contract is
 8.9 typed, as follows:

8.10 "You may cancel this contract for the sale of
 8.11 your house without any penalty or obligation
 8.12 at any time before

 8.14 (Date and time of day)

8.15 See the attached notice of cancellation form
 8.16 for an explanation of this right."

8.17 The foreclosure purchaser shall accurately enter the date and time of day on which the
 8.18 cancellation right ends.

8.19 (b) The contract must be accompanied by a completed form in duplicate, captioned
 8.20 "notice of cancellation" in a size equal to a 12-point boldface type if the contract is
 8.21 printed, or in capital letters, if the contract is typed, followed by a space in which the
 8.22 foreclosure purchaser shall enter the date on which the foreclosed homeowner executes
 8.23 any the contract. This form must be attached to the contract, must be easily detachable,
 8.24 and must contain in type of at least 10 points, if the contract is printed or in capital
 8.25 letters if the contract is typed, the following statement written in the same language as
 8.26 used in the contract:

8.27 "NOTICE OF CANCELLATION

8.30 You may cancel this contract for the sale of
 8.31 your house, without any penalty or obligation,

9.14 (c) The foreclosure purchaser shall provide the foreclosed homeowner with a copy
 9.15 of the contract and the attached notice of cancellation at the time the contract is executed
 9.16 by all parties.

9.17 (d) The five business days during which the foreclosed homeowner may cancel the
 9.18 contract must not begin to run until all parties to the contract have executed the contract
 9.19 and the foreclosure purchaser has complied with this section.

9.20 Sec. 9. Minnesota Statutes 2006, section 325N.17, is amended to read:

9.21 **325N.17 PROHIBITED PRACTICES.**

9.22 A foreclosure purchaser shall not:

9.23 (a) enter into, or attempt to enter into, a foreclosure reconveyance with a foreclosed
 9.24 homeowner unless:

9.25 (1) the foreclosure purchaser verifies and can demonstrate that the foreclosed
 9.26 homeowner has a reasonable ability to pay for the subsequent conveyance of an interest
 9.27 back to the foreclosed homeowner. In the case of a lease with an option to purchase,
 9.28 payment ability also includes the reasonable ability to make the lease payments and
 9.29 purchase the property within the term of the option to purchase. There is a rebuttable
 9.30 presumption that a homeowner is reasonably able to pay for the subsequent conveyance
 9.31 if the owner's payments for primary housing expenses and regular principal and interest
 9.32 payments on other personal debt, on a monthly basis, do not exceed 60 percent of
 9.33 the owner's monthly gross income. For the purposes of this section, "primary housing
 9.34 expenses" means the sum of payments for regular principal, interest, rent, utilities, hazard
 9.35 insurance, real estate taxes, and association dues. There is a rebuttable presumption that
 9.36 the foreclosure purchaser has not verified reasonable payment ability if the foreclosure
 9.37 purchaser has not obtained documents other than a statement by the foreclosed homeowner
 9.38 of assets, liabilities, and income;

10.1 (2) the foreclosure purchaser and the foreclosed homeowner complete a closing
10.2 for any foreclosure reconveyance in which the foreclosure purchaser obtains a deed or
10.3 mortgage from a foreclosed homeowner. For purposes of this section, "closing" means an
10.4 in-person meeting to complete final documents incident to the sale of the real property
10.5 or creation of a mortgage on the real property conducted by a closing agent, as defined
10.6 in section 82.17, who is not employed by or an affiliate of the foreclosure purchaser, or
10.7 employed by such an affiliate, and who does not have a business or personal relationship
10.8 with the foreclosure purchaser other than the provision of real estate settlement services;

10.9 (3) the foreclosure purchaser obtains the written consent of the foreclosed
10.10 homeowner to a grant by the foreclosure purchaser of any interest in the property during
10.11 such times as the foreclosed homeowner maintains any interest in the property; and

10.12 (4) the foreclosure purchaser complies with the requirements ~~of~~ for disclosure, loan
10.13 terms, and conduct in the federal Home Ownership Equity Protection Act, United States
10.14 Code, title 15, section 1639, or its implementing regulation, Code of Federal Regulations,
10.15 title 12, sections 226.31 to, 226.32, and 226.34, for any foreclosure reconveyance in which
10.16 the foreclosed homeowner obtains a vendee interest in a contract for deed, regardless of
10.17 whether the terms of the contract for deed meet the annual percentage rate or points and
10.18 fees requirements for a covered loan in Code of Federal Regulations, title 12, sections
10.19 226.32 (a) and (b);

10.20 (b) fail to either:

10.21 (1) ensure that title to the subject dwelling has been reconveyed to the foreclosed
10.22 homeowner; or

10.23 (2) make a payment to the foreclosed homeowner such that the foreclosed
10.24 homeowner has received consideration in an amount of at least 82 percent of the
10.25 fair market value of the property within 150 days of either the eviction or voluntary
10.26 relinquishment of possession of the dwelling by the foreclosed homeowner. The
10.27 foreclosure purchaser shall make a detailed accounting of the basis for the payment
10.28 amount, or a detailed accounting of the reasons for failure to make a payment,
10.29 including providing written documentation of expenses, within this 150-day period. The
10.30 accounting shall be on a form prescribed by the attorney general, in consultation with
10.31 the commissioner of commerce, without being subject to the rulemaking procedures of
10.32 chapter 14. For purposes of this provision, the following applies:

10.33 (i) there is a rebuttable presumption that an appraisal by a person licensed or certified
10.34 by an agency of the federal government or this state to appraise real estate constitutes the
10.35 fair market value of the property;

11.1 (ii) the time for determining the fair market value amount shall be determined in the
11.2 foreclosure reconveyance contract as either at the time of the execution of the foreclosure
11.3 reconveyance contract or at resale. If the contract states that the fair market value shall
11.4 be determined at the time of resale, the fair market value shall be the resale price if
11.5 it is sold within 120 days of the eviction or voluntary relinquishment of the property
11.6 by the foreclosed homeowner. If the contract states that the fair market value shall be
11.7 determined at the time of resale, and the resale is not completed within 120 days of the
11.8 eviction or voluntary relinquishment of the property by the foreclosed homeowner, the fair
11.9 market value shall be determined by an appraisal conducted during this 120-day period
11.10 and payment, if required, shall be made to the homeowner, but the fair market value
11.11 shall be recalculated as the resale price on resale and an additional payment amount, if
11.12 appropriate based on the resale price, shall be made to the foreclosed homeowner within
11.13 15 days of resale, and a detailed accounting of the basis for the payment amount, or a
11.14 detailed accounting of the reasons for failure to make additional payment, shall be made
11.15 within 15 days of resale, including providing written documentation of expenses. The
11.16 accounting shall be on a form prescribed by the attorney general, in consultation with
11.17 the commissioner of commerce, without being subject to the rulemaking procedures
11.18 of chapter 14;

11.19 (iii) "consideration" shall mean any payment or thing of value provided to the
11.20 foreclosed homeowner, including unpaid rent or contract for deed payments owed by the
11.21 foreclosed homeowner prior to the date of eviction or voluntary relinquishment of the
11.22 property, reasonable costs paid to third parties necessary to complete the foreclosure
11.23 reconveyance transaction, payment of money to satisfy a debt or legal obligation of the
11.24 foreclosed homeowner, or the reasonable cost of repairs for damage to the dwelling caused
11.25 by the foreclosed homeowner; or a penalty imposed by a court for the filing of a frivolous

13.7 to 325N.17; or (iii) asserts a claim or affirmative defense of fraud, false pretense, false
13.8 promise, misrepresentation, misleading statement, or deceptive practice, in connection

13.11 (3) conveyed title to the foreclosed residence to a third party upon a promise that the

13.33 may impose a sanction against the defendant of \$500 plus reasonable attorney fees.
