1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2008, section 144.1501, subdivision 1, is amended to
1.12 read:

1.13 Subdivision 1. Definitions. (a) For purposes of this section, the following definitions
1.14 apply.

1.15 (b) "Dentist" means an individual who is licensed to practice dentistry.

1.16 (c) "Designated rural area" means:

1.17 (1) an area in Minnesota outside the counties of Anoka, Carver, Dakota, Hennepin,
1.18 Ramsey, Scott, and Washington, excluding the cities of Duluth, Mankato, Moorhead,
1.19 Rochester, and St. Cloud; or

1.20 (2) a municipal corporation, as defined under section 471.634, that is physically
1.21 located, in whole or in part, in an area defined as a designated rural area under clause (1).

1.22 (d) "Emergency circumstances" means those conditions that make it impossible for
1.23 the participant to fulfill the service commitment, including death, total and permanent
1.24 disability, or temporary disability lasting more than two years.

1.25 (e) "Medical resident" means an individual participating in a medical residency in
1.26 family practice, internal medicine, obstetrics and gynecology, pediatrics, or psychiatry.

2.1 (f) "Midlevel practitioner" means a nurse practitioner, nurse-midwife, nurse
2.2 anesthetist, advanced clinical nurse specialist, or physician assistant.

2.3 (g) "Nurse" means an individual who has completed training and received all
2.4 licensing or certification necessary to perform duties as a licensed practical nurse or
2.5 registered nurse.

2.6 (h) "Nurse-midwife" means a registered nurse who has graduated from a program of
2.7 study designed to prepare registered nurses for advanced practice as nurse-midwives.

2.8 (i) "Nurse practitioner" means a registered nurse who has graduated from a program
2.9 of study designed to prepare registered nurses for advanced practice as nurse practitioners.

2.10 (j) "Pharmacist" means an individual with a valid license issued under chapter 151.

2.11 (k) "Physician" means an individual who is licensed to practice medicine in the areas
2.12 of family practice, internal medicine, obstetrics and gynecology, pediatrics, or psychiatry.

2.13 (l) "Physician assistant" means a person ~~registered~~ licensed under chapter 147A.

2.14 (m) "Qualified educational loan" means a government, commercial, or foundation
2.15 loan for actual costs paid for tuition, reasonable education expenses, and reasonable living
2.16 expenses related to the graduate or undergraduate education of a health care professional.

2.17 (n) "Underserved urban community" means a Minnesota urban area or population
2.18 included in the list of designated primary medical care health professional shortage areas
2.19 (HPSAs), medically underserved areas (MUAs), or medically underserved populations
2.20 (MUPs) maintained and updated by the United States Department of Health and Human
2.21 Services.

2.22 Sec. 2. Minnesota Statutes 2008, section 144E.001, subdivision 3a, is amended to read:

2.23 Subd. 3a. **Ambulance service personnel.** "Ambulance service personnel" means
2.24 individuals who are authorized by a licensed ambulance service to provide emergency
2.25 care for the ambulance service and are:

2.26 (1) EMTs, EMT-Is, or EMT-Ps;

2.27 (2) Minnesota registered nurses who are: (i) EMTs, are currently practicing
2.28 nursing, and have passed a paramedic practical skills test, as approved by the board
2.29 and administered by a training program approved by the board; (ii) on the roster of an
2.30 ambulance service on or before January 1, 2000; or (iii) after petitioning the board,
2.31 deemed by the board to have training and skills equivalent to an EMT, as determined on
2.32 a case-by-case basis; or

2.33 (3) Minnesota ~~registered~~ licensed physician assistants who are: (i) EMTs, are
2.34 currently practicing as physician assistants, and have passed a paramedic practical skills
2.35 test, as approved by the board and administered by a training program approved by the

3.1 board; (ii) on the roster of an ambulance service on or before January 1, 2000; or (iii) after
3.2 petitioning the board, deemed by the board to have training and skills equivalent to an
3.3 EMT, as determined on a case-by-case basis.

3.4 Sec. 3. Minnesota Statutes 2008, section 144E.001, subdivision 9c, is amended to read:

3.5 Subd. 9c. **Physician assistant.** "Physician assistant" means a person ~~registered~~
3.6 licensed to practice as a physician assistant under chapter 147A.

3.7 Sec. 4. Minnesota Statutes 2008, section 147.09, is amended to read:

3.8 **147.09 EXEMPTIONS.**

3.9 Section 147.081 does not apply to, control, prevent or restrict the practice, service,
3.10 or activities of:

3.11 (1) A person who is a commissioned medical officer of, a member of, or employed
3.12 by, the armed forces of the United States, the United States Public Health Service, the
3.13 Veterans Administration, any federal institution or any federal agency while engaged in
3.14 the performance of official duties within this state, if the person is licensed elsewhere.

3.15 (2) A licensed physician from a state or country who is in actual consultation here.

3.16 (3) A licensed or registered physician who treats the physician's home state patients
3.17 or other participating patients while the physicians and those patients are participating
3.18 together in outdoor recreation in this state as defined by section 86A.03, subdivision 3.
3.19 A physician shall first register with the board on a form developed by the board for that
3.20 purpose. The board shall not be required to promulgate the contents of that form by rule.
3.21 No fee shall be charged for this registration.

3.22 (4) A student practicing under the direct supervision of a preceptor while the student
3.23 is enrolled in and regularly attending a recognized medical school.

3.24 (5) A student who is in continuing training and performing the duties of an intern or
3.25 resident or engaged in postgraduate work considered by the board to be the equivalent of
3.26 an internship or residency in any hospital or institution approved for training by the board,
3.27 provided the student has a residency permit issued by the board under section 147.0391.

3.28 (6) A person employed in a scientific, sanitary, or teaching capacity by the state
3.29 university, the Department of Education, a public or private school, college, or other
3.30 bona fide educational institution, a nonprofit organization, which has tax-exempt status
3.31 in accordance with the Internal Revenue Code, section 501(c)(3), and is organized and
3.32 operated primarily for the purpose of conducting scientific research directed towards
3.33 discovering the causes of and cures for human diseases, or the state Department of Health,
3.34 whose duties are entirely of a research, public health, or educational character, while

4.1 engaged in such duties; provided that if the research includes the study of humans, such
4.2 research shall be conducted under the supervision of one or more physicians licensed
4.3 under this chapter.

4.4 (7) Physician's assistants ~~registered~~ licensed in this state.

4.5 (8) A doctor of osteopathy duly licensed by the state Board of Osteopathy under
4.6 Minnesota Statutes 1961, sections 148.11 to 148.16, prior to May 1, 1963, who has not
4.7 been granted a license to practice medicine in accordance with this chapter provided that
4.8 the doctor confines activities within the scope of the license.

4.9 (9) Any person licensed by a health-related licensing board, as defined in section
4.10 214.01, subdivision 2, or registered by the commissioner of health pursuant to section
4.11 214.13, including psychological practitioners with respect to the use of hypnosis; provided
4.12 that the person confines activities within the scope of the license.

4.13 (10) A person who practices ritual circumcision pursuant to the requirements or
4.14 tenets of any established religion.

4.15 (11) A Christian Scientist or other person who endeavors to prevent or cure disease
4.16 or suffering exclusively by mental or spiritual means or by prayer.

4.17 (12) A physician licensed to practice medicine in another state who is in this state
4.18 for the sole purpose of providing medical services at a competitive athletic event. The
4.19 physician may practice medicine only on participants in the athletic event. A physician
4.20 shall first register with the board on a form developed by the board for that purpose. The
4.21 board shall not be required to adopt the contents of the form by rule. The physician shall
4.22 provide evidence satisfactory to the board of a current unrestricted license in another state.
4.23 The board shall charge a fee of \$50 for the registration.

4.24 (13) A psychologist licensed under section 148.907 or a social worker licensed
4.25 under chapter 148D who uses or supervises the use of a penile or vaginal plethysmograph
4.26 in assessing and treating individuals suspected of engaging in aberrant sexual behavior
4.27 and sex offenders.

4.28 (14) Any person issued a training course certificate or credentialed by the Emergency
4.29 Medical Services Regulatory Board established in chapter 144E, provided the person
4.30 confines activities within the scope of training at the certified or credentialed level.

4.31 (15) An unlicensed complementary and alternative health care practitioner practicing
4.32 according to chapter 146A.

4.33 Sec. 5. Minnesota Statutes 2008, section 147A.01, is amended to read:

4.34 **147A.01 DEFINITIONS.**

5.1 Subdivision 1. **Scope.** For the purpose of this chapter the terms defined in this
5.2 section have the meanings given them.

5.3 ~~Subd. 2. **Active status.** "Active status" means the status of a person who has met all
5.4 the qualifications of a physician assistant, has a physician-physician assistant agreement in
5.5 force, and is registered.~~

5.6 Subd. 3. **Administer.** "Administer" means the delivery by a physician assistant
5.7 authorized to prescribe legend drugs, a single dose of a legend drug, including controlled
5.8 substances, to a patient by injection, inhalation, ingestion, or by any other immediate
5.9 means, and the delivery by a physician assistant ordered by a physician a single dose of a
5.10 legend drug by injection, inhalation, ingestion, or by any other immediate means.

5.11 Subd. 4. **Agreement.** "Agreement" means the document described in section
5.12 147A.20.

5.13 Subd. 5. **Alternate supervising physician.** "Alternate supervising physician"
5.14 means a Minnesota licensed physician listed in the physician-physician assistant
5.15 delegation agreement, or supplemental listing, who is responsible for supervising
5.16 the physician assistant when the ~~main~~ primary supervising physician is unavailable.
5.17 The alternate supervising physician shall accept full medical responsibility for the
5.18 performance, practice, and activities of the physician assistant while under the supervision
5.19 of the alternate supervising physician.

5.20 Subd. 6. **Board.** "Board" means the Board of Medical Practice or its designee.

5.21 Subd. 7. **Controlled substances.** "Controlled substances" has the meaning given it
5.22 in section 152.01, subdivision 4.

5.23 ~~Subd. 8. **Delegation form.** "Delegation form" means the form used to indicate the
5.24 categories of drugs for which the authority to prescribe, administer, and dispense has been
5.25 delegated to the physician assistant and signed by the supervising physician, any alternate
5.26 supervising physicians, and the physician assistant. This form is part of the agreement
5.27 described in section 147A.20, and shall be maintained by the supervising physician and
5.28 physician assistant at the address of record. Copies shall be provided to the board upon
5.29 request. "Addendum to the delegation form" means a separate listing of the schedules
5.30 and categories of controlled substances, if any, for which the physician assistant has been
5.31 delegated the authority to prescribe, administer, and dispense. The addendum shall be
5.32 maintained as a separate document as described above.~~

5.33 Subd. 9. **Diagnostic order.** "Diagnostic order" means a directive to perform
5.34 a procedure or test, the purpose of which is to determine the cause and nature of a
5.35 pathological condition or disease.

6.1 Subd. 10. **Drug.** "Drug" has the meaning given it in section 151.01, subdivision 5,
6.2 including controlled substances as defined in section 152.01, subdivision 4.

6.3 Subd. 11. **Drug category.** "Drug category" means one of the categories listed on the
6.4 physician-physician assistant delegation form agreement.

6.5 Subd. 12. **Inactive status.** "Inactive status" means ~~the status of a person who has~~
6.6 ~~met all the qualifications of a physician assistant, and is registered, but does not have a~~
6.7 ~~physician-physician assistant agreement in force~~ a licensed physician assistant whose
6.8 license has been placed on inactive status under section 147A.05.

6.9 ~~Subd. 13. **Internal protocol.** "Internal protocol" means a document written by~~
6.10 ~~the supervising physician and the physician assistant which specifies the policies and~~
6.11 ~~procedures which will apply to the physician assistant's prescribing, administering,~~
6.12 ~~and dispensing of legend drugs and medical devices, including controlled substances~~
6.13 ~~as defined in section 152.01, subdivision 4, and lists the specific categories of drugs~~
6.14 ~~and medical devices, with any exceptions or conditions, that the physician assistant~~
6.15 ~~is authorized to prescribe, administer, and dispense. The supervising physician and~~
6.16 ~~physician assistant shall maintain the protocol at the address of record. Copies shall be~~
6.17 ~~provided to the board upon request.~~

6.18 Subd. 14. **Legend drug.** "Legend drug" has the meaning given it in section 151.01,
6.19 subdivision 17.

6.20 Subd. 14a. **Licensed.** "Licensed" means meeting the qualifications in section
6.21 147A.02 and being issued a license by the board.

6.22 Subd. 14b. **Licensure.** "Licensure" means the process by which the board
6.23 determines that an applicant has met the standards and qualifications in this chapter.

6.24 ~~Subd. 15. **Locum tenens permit.** "Locum tenens permit" means time specific~~
6.25 ~~temporary permission for a physician assistant to practice as a physician assistant in~~
6.26 ~~a setting other than the practice setting established in the physician-physician assistant~~
6.27 ~~agreement.~~

6.28 Subd. 16. **Medical device.** "Medical device" means durable medical equipment and
6.29 assistive or rehabilitative appliances, objects, or products that are required to implement
6.30 the overall plan of care for the patient and that are restricted by federal law to use upon
6.31 prescription by a licensed practitioner.

6.32 Subd. 16a. **Notice of intent to practice.** "Notice of intent to practice" means
6.33 a document sent to the board by a licensed physician assistant that documents the
6.34 adoption of a physician-physician assistant delegation agreement and provides the names,
6.35 addresses, and information required by section 147A.20.

7.1 Subd. 17. **Physician.** "Physician" means a person currently licensed in good
7.2 standing as a physician or osteopath under chapter 147.

7.3 Subd. 17a. **Physician-physician assistant delegation agreement.**

7.4 "Physician-physician assistant delegation agreement" means the document prepared and
7.5 signed by the physician and physician assistant affirming the supervisory relationship and
7.6 defining the physician assistant scope of practice. Alternate supervising physicians must be
7.7 identified on the delegation agreement or a supplemental listing with signed attestation that
7.8 each shall accept full medical responsibility for the performance, practice, and activities of
7.9 the physician assistant while under the supervision of the alternate supervising physician.
7.10 The physician-physician assistant delegation agreement outlines the role of the physician
7.11 assistant in the practice, describes the means of supervision, and specifies the categories of
7.12 drugs, controlled substances, and medical devices that the supervising physician delegates
7.13 to the physician assistant to prescribe. The physician-physician assistant delegation
7.14 agreement must comply with the requirements of section 147A.20, be kept on file at the
7.15 address of record, and be made available to the board or its representative upon request.

7.16 Subd. 18. **Physician assistant or ~~registered~~ licensed physician assistant.**

7.17 "Physician assistant" or "~~registered~~ licensed physician assistant" means a person ~~registered~~
7.18 ~~licensed~~ pursuant to this chapter who ~~is qualified by academic or practical training or~~
7.19 ~~both to provide patient services as specified in this chapter, under the supervision of a~~
7.20 ~~supervising physician~~ meets the qualifications in section 147A.02.

7.21 ~~Subd. 19. **Practice setting description.** "Practice setting description" means a~~
7.22 ~~signed record submitted to the board on forms provided by the board, on which:~~

7.23 ~~(1) the supervising physician assumes full medical responsibility for the medical~~
7.24 ~~care rendered by a physician assistant;~~

7.25 ~~(2) is recorded the address and phone number of record of each supervising~~
7.26 ~~physician and alternate, and the physicians' medical license numbers and DEA number;~~

7.27 ~~(3) is recorded the address and phone number of record of the physician assistant~~
7.28 ~~and the physician assistant's registration number and DEA number;~~

7.29 ~~(4) is recorded whether the physician assistant has been delegated prescribing,~~
7.30 ~~administering, and dispensing authority;~~

7.31 ~~(5) is recorded the practice setting, address or addresses and phone number or~~
7.32 ~~numbers of the physician assistant; and~~

7.34 Subd. 20. **Prescribe.** "Prescribe" means to direct, order, or designate by means of a
7.35 prescription the preparation, use of, or manner of using a drug or medical device.

8.1 Subd. 21. **Prescription.** "Prescription" means a signed written order, ~~or~~ an oral
8.2 order reduced to writing, or an electronic order meeting current and prevailing standards
8.3 given by a physician assistant authorized to prescribe drugs for patients in the course
8.4 of the physician assistant's practice, issued for an individual patient and containing the
8.5 information required in the physician-physician assistant delegation form agreement.

8.6 ~~Subd. 22. **Registration.** "Registration" is the process by which the board determines~~
8.7 ~~that an applicant has been found to meet the standards and qualifications found in this~~
8.8 ~~chapter.~~

8.9 Subd. 23. **Supervising physician.** "Supervising physician" means a Minnesota
8.10 licensed physician who accepts full medical responsibility for the performance, practice,
8.11 and activities of a physician assistant under an agreement as described in section 147A.20.
8.12 The supervising physician who completes and signs the delegation agreement may be
8.13 referred to as the primary supervising physician. A supervising physician shall not
8.14 supervise more than ~~two~~ five full-time equivalent physician assistants simultaneously.
8.15 With the approval of the board, or in a disaster or emergency situation as defined in section
8.16 147A.23, a supervising physician may supervise more than five full-time equivalent
8.17 physician assistants simultaneously.

8.18 Subd. 24. **Supervision.** "Supervision" means overseeing the activities of, and
8.19 accepting responsibility for, the medical services rendered by a physician assistant. The
8.20 constant physical presence of the supervising physician is not required so long as the
8.21 supervising physician and physician assistant are or can be easily in contact with one
8.22 another by radio, telephone, or other telecommunication device. The scope and nature of
8.23 the supervision shall be defined by the individual physician-physician assistant delegation
8.24 agreement.

8.25 Subd. 25. **Temporary registration license.** ~~"Temporary registration" means the~~
8.26 ~~status of a person who has satisfied the education requirement specified in this chapter;~~
8.27 ~~is enrolled in the next examination required in this chapter; or is awaiting examination~~
8.28 ~~results; has a physician-physician assistant agreement in force as required by this chapter;~~
8.29 ~~and has submitted a practice setting description to the board. Such provisional registration~~
8.30 ~~shall expire 90 days after completion of the next examination sequence, or after one year,~~
8.31 ~~whichever is sooner, for those enrolled in the next examination; and upon receipt of the~~
8.32 ~~examination results for those awaiting examination results. The registration shall be~~
8.33 ~~granted by the board or its designee.~~ "Temporary license" means a license granted to a
8.34 physician assistant who meets all of the qualifications for licensure but has not yet been
8.35 approved for licensure at a meeting of the board.

9.1 Subd. 26. **Therapeutic order.** "Therapeutic order" means an order given to another
 9.2 for the purpose of treating or curing a patient in the course of a physician assistant's
 9.3 practice. Therapeutic orders may be written or verbal, but do not include the prescribing
 9.4 of legend drugs or medical devices unless prescribing authority has been delegated within
 9.5 the physician-physician assistant delegation agreement.

9.6 Subd. 27. **Verbal order.** "Verbal order" means an oral order given to another for
 9.7 the purpose of treating or curing a patient in the course of a physician assistant's practice.
 9.8 Verbal orders do not include the prescribing of legend drugs unless prescribing authority
 9.9 has been delegated within the physician-physician assistant delegation agreement.

9.10 Sec. 6. Minnesota Statutes 2008, section 147A.02, is amended to read:

9.11 **147A.02 QUALIFICATIONS FOR ~~REGISTRATION~~ LICENSURE.**

9.12 Except as otherwise provided in this chapter, an individual shall be ~~registered~~
 9.13 licensed by the board before the individual may practice as a physician assistant.

9.14 The board may grant ~~registration~~ a license as a physician assistant to an applicant
 9.15 who:

9.16 (1) submits an application on forms approved by the board;

9.17 (2) pays the appropriate fee as determined by the board;

9.18 (3) has current certification from the National Commission on Certification of
 9.19 Physician Assistants, or its successor agency as approved by the board;

9.20 (4) certifies that the applicant is mentally and physically able to engage safely in
 9.21 practice as a physician assistant;

9.22 (5) has no licensure, certification, or registration as a physician assistant under
 9.23 current discipline, revocation, suspension, or probation for cause resulting from the
 9.24 applicant's practice as a physician assistant, unless the board considers the condition
 9.25 and agrees to licensure;

9.26 (6) submits any other information the board deems necessary to evaluate the
 9.27 applicant's qualifications; and

9.28 (7) has been approved by the board.

9.29 All persons registered as physician assistants as of June 30, 1995, are eligible for
 9.30 continuing ~~registration~~ license renewal. All persons applying for ~~registration~~ licensure
 9.31 after that date shall be ~~registered~~ licensed according to this chapter.

9.32 Sec. 7. Minnesota Statutes 2008, section 147A.03, is amended to read:

9.33 **147A.03 PROTECTED TITLES AND RESTRICTIONS ON USE.**

10.1 Subdivision 1. **Protected titles.** No individual may use the titles "Minnesota
 10.2 ~~Registered Licensed~~ Physician Assistant," "~~Registered Licensed~~ Physician Assistant,"
 10.3 "Physician Assistant," or "PA" in connection with the individual's name, or any other
 10.4 words, letters, abbreviations, or insignia indicating or implying that the individual is
 10.5 ~~registered with~~ licensed by the state unless they have been ~~registered~~ licensed according
 10.6 to this chapter.

10.7 Subd. 2. **Health care practitioners.** Individuals practicing in a health care
 10.8 occupation are not restricted in the provision of services included in this chapter as long as
 10.9 they do not hold themselves out as physician assistants by or through the titles provided in
 10.10 subdivision 1 in association with provision of these services.

10.11 ~~Subd. 3. **Identification of registered practitioners.** Physician assistants in~~
 10.12 ~~Minnesota shall wear name tags which identify them as physician assistants.~~

10.13 Subd. 4. **Sanctions.** Individuals who hold themselves out as physician assistants by
 10.14 or through any of the titles provided in subdivision 1 without prior ~~registration~~ licensure
 10.15 shall be subject to sanctions or actions against continuing the activity according to section
 10.16 214.11, or other authority.

10.17 Sec. 8. Minnesota Statutes 2008, section 147A.04, is amended to read:

10.18 **147A.04 TEMPORARY ~~PERMIT~~ LICENSE.**

10.19 The board may issue a temporary ~~permit~~ license to practice to a physician assistant
 10.20 eligible for ~~registration~~ licensure under this chapter only if the application for ~~registration~~
 10.21 licensure is complete, all requirements have been met, and a nonrefundable fee set by
 10.22 the board has been paid. The ~~permit~~ temporary license remains valid only until the
 10.23 next meeting of the board at which a decision is made on the application for ~~registration~~
 10.24 licensure.

10.25 Sec. 9. Minnesota Statutes 2008, section 147A.05, is amended to read:

10.26 **147A.05 INACTIVE ~~REGISTRATION~~ LICENSE.**

10.27 Physician assistants who notify the board in writing ~~on forms prescribed by the board~~
 10.28 may elect to place their ~~registrations~~ license on an inactive status. Physician assistants
 10.29 with an inactive ~~registration~~ license shall be excused from payment of renewal fees and
 10.30 shall not practice as physician assistants. Persons who engage in practice while their
 10.31 ~~registrations are~~ license is lapsed or on inactive status shall be considered to be practicing
 10.32 without ~~registration~~ a license, which shall be grounds for discipline under section 147A.13.
 10.33 Physician assistants who provide care under the provisions of section 147A.23 shall not
