1.6	Section 1. [168.1299] SPECIAL "MISSISSIPPI RIVER" PLATES.
1.7	Subdivision 1. General requirements and procedures. (a) Notwithstanding
1.8	section 168.1293, the commissioner shall issue special "Mississippi River" license plates
1.9	to an applicant who:
1.10	(1) is a registered owner of a passenger automobile, one-ton pickup truck,
1.11	recreational vehicle, or motorcycle;
1.12	(2) pays a fee of \$10 for each set of plates to cover the costs of handling and
1.13	manufacturing the plates;
1.14	(3) pays the registration tax required under section 168.013;
1.15	(4) pays the fees required under this chapter;
1.16	(5) contributes a minimum of \$30 annually to the Mississippi River donation
1.17	account; and
1.18	(6) complies with laws and rules governing registration and licensing of vehicles
1.19	and drivers.
1.20	(b) The license application under this section must state that the annual contribution
1.21	specified under paragraph (a), clause (5), is a minimum contribution to receive the plates

2.2	natural resources and transportation shall jointly select a suitable symbol for use by the
2.3	commissioner to design the special plate.
2.4	Subd. 3. No refund. Contributions under this section must not be refunded.
2.5	Subd. 4. Plate transfers. On payment of a transfer fee of \$5, plates issued under
2.6	this section may be transferred to another eligible vehicle as specified in subdivision 1,
2.7	paragraph (a), clause (1), that is owned by the individual to whom the special plates
2.8	were issued.
2.9	Subd. 5. Contribution and fees credited. Contributions under subdivision 1,
