.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
.5	Section 1. [4.046] OFFICE OF EARLY LEARNING.
.6	(a) An Office of Early Learning is established to coordinate a high-quality early
.7	childhood system in Minnesota to make such programs more effective and to improve
.8	the educational outcomes of all children. The governor must appoint, and the senate
.9	must confirm, a director who is a recognized expert in the field of early childhood care
.10	and education who will facilitate communication and coordinate prekindergarten and
.11	child care programs under the administration of the Departments of Education, Health,
.12	and Human Services.
.13	(b) The director of the Office of Early Learning must coordinate Departments of
.14	Education, Health, and Human Services staff efforts to:
.15	(1) consolidate and coordinate resources and public funding streams for early
.16	childhood education and child care, and ensure the accountability and coordinated
.17	development of all early childhood education and child care services to children from
.18	birth to age five;
.19	(2) work with the Departments of Education, Health, and Human Services and the
.20	Minnesota Early Learning Foundation (MELF) to create common standards for quality
.21	early childhood programming and rules for teacher training and certification;

2.24	also must present to these same legislative committees by February 1, 2009, a detailed
2.25	plan, with an implementation timeline, to colocate state early childhood education and
2.26	child care assistance programs and services.
