1.10	for this purpose, Advocating Change Together, in cooperation with the network of
1.11	self-advocacy groups called Self-Advocates Minnesota, shall conduct self-advocacy
1.12	activities for persons with developmental disabilities. These activities shall include, but
1.13	not be limited to, training on individual rights, decision making, self determination,
1.14	prevention of abuse, and participation in quality assurance monitoring. The commissioner
1.15	shall obtain federal financial participation for eligible activity by Advocating Change
