1.32 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.33 Section 1. **[16A.647] TAX CREDIT AND INTEREST SUBSIDY BONDS.**

2.1 Subdivision 1. **Authority to issue.** When authorized by law to issue state general  
2.2 obligation bonds, the commissioner may issue all or part of the bonds as tax credit bonds  
2.3 or as interest subsidy bonds or a combination of the two.

2.4 Subd. 2. **Definitions.** (a) For purposes of this section, the following terms have  
2.5 the meanings given them.

2.6 (b) "Tax credit bonds" means bonds, the interest on which is includable in the  
2.7 income of the owner of the bonds for federal income tax purposes, but for which the  
2.8 owner is entitled to a federal tax credit.

2.9 (c) "Interest subsidy bonds" means bonds, the interest on which is includable in the  
2.10 income of the owner of the bonds for federal income tax purposes, but for which the  
2.11 issuer is entitled to federal interest subsidy payments based on a percentage of the interest  
2.12 payable on the interest subsidy bonds.

2.13 Subd. 3. **Method of sale.** Notwithstanding the provisions of section 16A.641,  
2.14 subdivision 4, the commissioner may sell any series of tax credit bonds or interest  
2.15 subsidy bonds at negotiated sale upon the terms and conditions and the restrictions  
2.16 the commissioner prescribes. The commissioner may contract for investment banking  
2.17 and banking services only after receiving competitive proposals for the services. The  
2.18 commissioner may enter into all contracts deemed necessary or desirable to accomplish  
2.19 the sale in a cost-effective manner.

2.20 Subd. 4. **Sinking fund.** The commissioner's order authorizing the issuance of  
2.21 interest subsidy bonds must establish a separate sinking fund account for the interest  
2.22 subsidy bonds in the state bond fund. There is annually appropriated, as received, to each  
2.23 interest subsidy bond account, in addition to amounts appropriated under section 16A.641,  
2.24 the interest subsidy payments received from the federal government with respect to that  
2.25 issue of interest subsidy bonds in that year.

2.26 Subd. 5. **Sale.** Tax credit bonds and interest subsidy bonds must be sold at a price  
2.27 not less than 98 percent of their stated principal amount. No state trunk highway bond  
2.28 may be sold for a price of less than par and accrued interest.

2.29 Sec. 2. Minnesota Statutes 2008, section 37.31, subdivision 1, is amended to read:

2.30 Subdivision 1. **Bonding authority.** The society may issue negotiable bonds in  
2.31 a principal amount that the society determines necessary to provide sufficient money  
2.32 for achieving its purposes, including the payment of interest on bonds of the society,  
2.33 the establishment of reserves to secure its bonds, the payment of fees to a third party  
2.34 providing credit enhancement, and the payment of all other expenditures of the society  
2.35 incident to and necessary or convenient to carry out its corporate purposes and powers.

3.1 Bonds of the society may be issued as bonds or notes or in any other form authorized by  
 3.2 law. ~~The principal amount of bonds issued and outstanding under this section at any time~~  
 3.3 ~~may not exceed \$20,000,000, excluding bonds for which refunding bonds or crossover~~  
 3.4 ~~refunding bonds have been issued.~~

3.5 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.6 Sec. 3. Minnesota Statutes 2008, section 37.31, subdivision 7, is amended to read:

3.7 Subd. 7. ~~**Approval Notification; commissioner of finance.** Before~~ Within 30 days  
 3.8 after issuing and selling bonds under this section, the society must ~~obtain the approval~~  
 3.9 notify, in writing, of the commissioner of finance of the date of issuance, principal amount,  
 3.10 true interest cost, final maturity date of the issue, and credit rating as applicable.

3.11 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.12 Sec. 4. Minnesota Statutes 2008, section 37.33, subdivision 3, is amended to read:

3.13 Subd. 3. **Investment.** Money in a debt service reserve fund not required for  
 3.14 immediate use may be invested in accordance with section ~~37.07~~ 37.34.

3.15 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.16 Sec. 5. Minnesota Statutes 2008, section 37.34, is amended to read:

3.17 **37.34 MONEY OF THE SOCIETY.**

3.18 The society may contract with the holders of any of its bonds as to the custody,  
 3.19 collection, securing, investment, and payment of money of the society or money held in  
 3.20 trust or otherwise for the payment of bonds, and to carry out the contract. Money held in  
 3.21 trust or otherwise for the payment of bonds or in any way to secure bonds and deposits of  
 3.22 the money may be invested in accordance with chapter 118A and may be secured in the  
 3.23 same manner as money of the society, and all banks and trust companies are authorized  
 3.24 to give security for the deposits.

3.25 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.26 Sec. 6. Minnesota Statutes 2008, section 126C.55, subdivision 4, is amended to read:

3.27 Subd. 4. **Pledge of district's full faith and credit.** If, at the request of a school  
 3.28 district or intermediate school district, the state has paid part or all of the principal or  
 3.29 interest due on a district's debt obligation on a specific date, the pledge of the full faith and  
 3.30 credit and unlimited taxing powers of the school district or the member districts of the

4.1 intermediate district to repay the principal and interest due on those debt obligations shall  
4.2 also, without an election or the requirement of a further authorization, become a pledge of  
4.3 the full faith and credit and unlimited taxing powers of the school district or the member  
4.4 districts of the intermediate district to repay to the state the amount paid, with interest.  
4.5 Amounts paid by the state must be repaid in the order in which the state payments were  
4.6 made. Whenever the state pays under this section interest on bonds for which the issuer is  
4.7 entitled to federal interest subsidy payments, the state is subrogated to the issuer's rights to  
4.8 any federal interest subsidy payments relating to the interest paid by the state, unless and  
4.9 until the state has been reimbursed by the issuer in full.

4.10 Sec. 7. Minnesota Statutes 2008, section 204B.46, is amended to read:

4.11 **204B.46 MAIL ELECTIONS; QUESTIONS.**

4.12 A county, municipality, or school district submitting questions to the voters at a  
4.13 special election may conduct an election by mail with no polling place other than the office  
4.14 of the auditor or clerk. ~~No more than two questions may be submitted at a mail election~~  
4.15 ~~and no~~ offices may be voted on at a mail election. Notice of the election must be given  
4.16 to the county auditor at least 53 days prior to the election. This notice shall also fulfill  
4.17 the requirements of Minnesota Rules, part 8210.3000. The special mail ballot procedures  
4.18 must be posted at least six weeks prior to the election. No earlier than 20 or later than 14  
4.19 days prior to the election, the auditor or clerk shall mail ballots by nonforwardable mail  
4.20 to all voters registered in the county, municipality, or school district. Eligible voters not  
4.21 registered at the time the ballots are mailed may apply for ballots pursuant to chapter 203B.

4.22 Sec. 8. Minnesota Statutes 2008, section 275.065, subdivision 6, is amended to read:

4.23 Subd. 6. **Public hearing; adoption of budget and levy.** (a) For purposes of this  
4.24 section, the following terms shall have the meanings given:

4.25 (1) "Initial hearing" means the first and primary hearing held to discuss the taxing  
4.26 authority's proposed budget and proposed property tax levy for taxes payable in the  
4.27 following year, or, for school districts, the current budget and the proposed property tax  
4.28 levy for taxes payable in the following year.

4.29 (2) "Continuation hearing" means a hearing held to complete the initial hearing, if  
4.30 the initial hearing is not completed on its scheduled date.

4.31 (3) "Subsequent hearing" means the hearing held to adopt the taxing authority's final  
4.32 property tax levy, and, in the case of taxing authorities other than school districts, the final  
4.33 budget, for taxes payable in the following year.

5.1 (b) Between November 29 and December 20, the governing bodies of a city that has a  
5.2 population over 500, county, metropolitan special taxing districts as defined in subdivision  
5.3 3, paragraph (i), and regional library districts shall each hold an initial public hearing  
5.4 to discuss and seek public comment on its final budget and property tax levy for taxes  
5.5 payable in the following year, and the governing body of the school district shall hold an  
5.6 initial public hearing to review its current budget and proposed property tax levy for taxes  
5.7 payable in the following year. The metropolitan special taxing districts shall be required to  
5.8 hold only a single joint initial public hearing, the location of which will be determined by  
5.9 the affected metropolitan agencies. A city, county, metropolitan special taxing district as  
5.10 defined in subdivision 3, paragraph (i), regional library district established under section  
5.11 134.201, or school district is not required to hold a public hearing under this subdivision  
5.12 unless its proposed property tax levy for taxes payable in the following year, as certified  
5.13 under subdivision 1, has increased over its final property tax levy for taxes payable in the  
5.14 current year by a percentage that is greater than the percentage increase in the implicit  
5.15 price deflator for government consumption expenditures and gross investment for state  
5.16 and local governments prepared by the Bureau of Economic Analysts of the United States  
5.17 Department of Commerce for the 12-month period ending March 31 of the current year.

5.18 (c) The initial hearing must be held after 5:00 p.m. if scheduled on a day other than  
5.19 Saturday. No initial hearing may be held on a Sunday.

5.20 (d) At the initial hearing under this subdivision, the percentage increase in property  
5.21 taxes proposed by the taxing authority, if any, and the specific purposes for which property  
5.22 tax revenues are being increased must be discussed. During the discussion, the governing  
5.23 body shall hear comments regarding a proposed increase and explain the reasons for the  
5.24 proposed increase. The public shall be allowed to speak and to ask questions. At the public  
5.25 hearing, the school district must also provide and discuss information on the distribution  
5.26 of its revenues by revenue source, and the distribution of its spending by program area.

5.27 (e) If the initial hearing is not completed on its scheduled date, the taxing authority  
5.28 must announce, prior to adjournment of the hearing, the date, time, and place for the  
5.29 continuation of the hearing. The continuation hearing must be held at least five business  
5.30 days but no more than 14 business days after the initial hearing. A continuation hearing  
5.31 may not be held later than December 20 except as provided in paragraphs (f) and (g).  
5.32 A continuation hearing must be held after 5:00 p.m. if scheduled on a day other than  
5.33 Saturday. No continuation hearing may be held on a Sunday.

5.34 (f) The governing body of a county shall hold its initial hearing on the first Thursday  
5.35 in December each year, and may hold additional initial hearings on other dates before  
5.36 December 20 if necessary for the convenience of county residents. If the county needs a

6.1 continuation of its hearing, the continuation hearing shall be held on the third Tuesday  
6.2 in December. If the third Tuesday in December falls on December 21, the county's  
6.3 continuation hearing shall be held on Monday, December 20.

6.4 (g) The metropolitan special taxing districts shall hold a joint initial public hearing  
6.5 on the first Wednesday of December. A continuation hearing, if necessary, shall be held on  
6.6 the second Wednesday of December even if that second Wednesday is after December 10.

6.7 (h) The county auditor shall provide for the coordination of initial and continuation  
6.8 hearing dates for all school districts and cities within the county to prevent conflicts under  
6.9 clauses (i) and (j).

6.10 (i) By August 10, each school board and the board of the regional library district  
6.11 shall certify to the county auditors of the counties in which the school district or regional  
6.12 library district is located the dates on which it elects to hold its initial hearing and any  
6.13 continuation hearing. If a school board or regional library district does not certify these  
6.14 dates by August 10, the auditor will assign the initial and continuation hearing dates. The  
6.15 dates elected or assigned must not conflict with the initial and continuation hearing dates  
6.16 of the county or the metropolitan special taxing districts.

6.17 (j) By August 20, the county auditor shall notify the clerks of the cities within the  
6.18 county of the dates on which school districts and regional library districts have elected to  
6.19 hold their initial and continuation hearings. At the time a city certifies its proposed levy  
6.20 under subdivision 1 it shall certify the dates on which it elects to hold its initial hearing and  
6.21 any continuation hearing. Until September 15, the first and second Mondays of December  
6.22 are reserved for the use of the cities. If a city does not certify its hearing dates by  
6.23 September 15, the auditor shall assign the initial and continuation hearing dates. The dates  
6.24 elected or assigned for the initial hearing must not conflict with the initial hearing dates  
6.25 of the county, metropolitan special taxing districts, regional library districts, or school  
6.26 districts within which the city is located. To the extent possible, the dates of the city's  
6.27 continuation hearing should not conflict with the continuation hearing dates of the county,  
6.28 metropolitan special taxing districts, regional library districts, or school districts within  
6.29 which the city is located. This paragraph does not apply to cities of 500 population or less.

6.30 (k) The county initial hearing date and the city, metropolitan special taxing district,  
6.31 regional library district, and school district initial hearing dates must be designated on  
6.32 the notices required under subdivision 3. The continuation hearing dates need not be  
6.33 stated on the notices.

6.34 (l) At a subsequent hearing, each county, school district, city over 500 population,  
6.35 and metropolitan special taxing district may amend its proposed property tax levy  
6.36 and must adopt a final property tax levy. Each county, city over 500 population, and

7.1 metropolitan special taxing district may also amend its proposed budget and must adopt a  
7.2 final budget at the subsequent hearing. The final property tax levy must be adopted prior  
7.3 to adopting the final budget. A school district is not required to adopt its final budget at the  
7.4 subsequent hearing. The subsequent hearing of a taxing authority must be held on a date  
7.5 subsequent to the date of the taxing authority's initial public hearing. If a continuation  
7.6 hearing is held, the subsequent hearing must be held either immediately following the  
7.7 continuation hearing or on a date subsequent to the continuation hearing. The subsequent  
7.8 hearing may be held at a regularly scheduled board or council meeting or at a special  
7.9 meeting scheduled for the purposes of the subsequent hearing. The subsequent hearing  
7.10 of a taxing authority does not have to be coordinated by the county auditor to prevent a  
7.11 conflict with an initial hearing, a continuation hearing, or a subsequent hearing of any  
7.12 other taxing authority. All subsequent hearings must be held prior to five working days  
7.13 after December 20 of the levy year. The date, time, and place of the subsequent hearing  
7.14 must be announced at the initial public hearing or at the continuation hearing.

7.15 (m) The property tax levy certified under section 275.07 by a city of any population,  
7.16 county, metropolitan special taxing district, regional library district, or school district  
7.17 must not exceed the proposed levy determined under subdivision 1, except by an amount  
7.18 up to the sum of the following amounts:

7.19 (1) the amount of a school district levy whose voters approved a referendum to  
7.20 increase taxes under section 123B.63, subdivision 3, or 126C.17, subdivision 9, after  
7.21 the proposed levy was certified;

7.22 (2) the amount of a city or county levy approved by the voters after the proposed  
7.23 levy was certified;

7.24 (3) the amount of a levy to pay principal and interest on bonds approved by the  
7.25 voters under section 475.58 after the proposed levy was certified;

7.26 (4) the amount of a levy to pay costs due to a natural disaster occurring after the  
7.27 proposed levy was certified, if that amount is approved by the commissioner of revenue  
7.28 under subdivision 6a;

7.29 (5) the amount of a levy to pay tort judgments against a taxing authority that become  
7.30 final after the proposed levy was certified, if the amount is approved by the commissioner  
7.31 of revenue under subdivision 6a;

7.32 (6) the amount of an increase in levy limits certified to the taxing authority by the  
7.33 commissioner of education or the commissioner of revenue after the proposed levy was  
7.34 certified; ~~and~~

7.35 (7) the amount required under section 126C.55; and

8.1 (8) the levy to pay emergency debt certificates under section 475.755 authorized and  
8.2 issued after the proposed levy was certified.

8.3 (n) This subdivision does not apply to towns and special taxing districts other than  
8.4 regional library districts and metropolitan special taxing districts.

8.5 (o) Notwithstanding the requirements of this section, the employer is required to  
8.6 meet and negotiate over employee compensation as provided for in chapter 179A.

8.7 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.8 Sec. 9. Minnesota Statutes 2008, section 360.036, subdivision 2, is amended to read:

8.9 Subd. 2. **Issuance of bonds.** (a) Bonds to be issued by a municipality under sections  
8.10 360.011 to 360.076, shall be authorized and issued in the manner and within the limitation  
8.11 prescribed by laws or the charter of the municipality for the issuance and authorization of  
8.12 bonds for public purposes generally, except as provided in paragraphs (b) and (c).

8.13 (b) No election is required to authorize the issuance of the bonds if:

8.14 (1) a board organized under section 360.042 recommends by a resolution adopted  
8.15 by a vote of not less than 60 percent of its members the issuance of bonds, and the  
8.16 bonds are authorized by a resolution of the governing body of each of the municipalities  
8.17 acting jointly pursuant to section 360.042, adopted by a vote of not less than 60 percent  
8.18 of its members; or

8.19 (2) the bonds are authorized by a resolution of the governing body of the  
8.20 municipality, adopted by a vote of not less than 60 percent of its members; or

8.21 (3) the bonds are being issued for the purpose of financing the costs of constructing,  
8.22 enlarging, or improving airports and other air navigation facilities; and

8.23 (i) the governing body estimates that passenger facility charges and other revenues  
8.24 pledged to the payment thereof will be at least 20 percent of the debt service payable  
8.25 on the bonds in any year;

8.26 (ii) the project will be funded in part by a state or federal grant for airport  
8.27 development; and

8.28 (iii) the principal amount of the bonds issued under this clause does not exceed 25  
8.29 percent of the amount of the state or federal grant.

8.30 (c) If the bonds are general obligations of the municipality, the levy of taxes required  
8.31 by section 475.61 to pay principal and interest on the bonds is not included in computing  
8.32 or applying any levy limitation applicable to the municipality.

8.33 Sec. 10. Minnesota Statutes 2008, section 366.095, subdivision 1, is amended to read:



9.1 Subdivision 1. **Certificates of indebtedness.** The town board may issue certificates  
9.2 of indebtedness within the debt limits for a town purpose otherwise authorized by law.  
9.3 The certificates shall be payable in not more than ~~five~~ ten years and be issued on the terms  
9.4 and in the manner as the board may determine. If the amount of the certificates to be  
9.5 issued exceeds 0.25 percent of the market value of the town, they shall not be issued for at  
9.6 least ten days after publication in a newspaper of general circulation in the town of the  
9.7 board's resolution determining to issue them. If within that time, a petition asking for an  
9.8 election on the proposition signed by voters equal to ten percent of the number of voters  
9.9 at the last regular town election is filed with the clerk, the certificates shall not be issued  
9.10 until their issuance has been approved by a majority of the votes cast on the question at  
9.11 a regular or special election. A tax levy shall be made to pay the principal and interest  
9.12 on the certificates as in the case of bonds.

9.13 Sec. 11. Minnesota Statutes 2008, section 373.01, subdivision 3, is amended to read:

9.14 Subd. 3. **Capital notes.** (a) A county board may, by resolution and without  
9.15 referendum, issue capital notes subject to the county debt limit to purchase capital  
9.16 equipment useful for county purposes that has an expected useful life at least equal to the  
9.17 term of the notes. The notes shall be payable in not more than ten years and shall be  
9.18 issued on terms and in a manner the board determines. A tax levy shall be made for  
9.19 payment of the principal and interest on the notes, in accordance with section 475.61,  
9.20 as in the case of bonds.

9.21 (b) For purposes of this subdivision, "capital equipment" means:

9.22 (1) public safety, ambulance, road construction or maintenance, ~~and~~ medical  
9.23 equipment, and other capital equipment; and

9.24 (2) computer hardware and software, whether bundled with machinery or equipment  
9.25 or unbundled, together with application development services and training related to the  
9.26 use of the computer hardware and software and fiber-optic cable or other means of voice  
9.27 and data transmission among municipal buildings, provided that software, application,  
9.28 and development services and training shall be deemed to have the same useful life as the  
9.29 computer equipment to which they are related.

9.30 Sec. 12. Minnesota Statutes 2008, section 373.40, subdivision 1, is amended to read:

9.31 Subdivision 1. **Definitions.** For purposes of this section, the following terms have  
9.32 the meanings given.

9.33 (a) "Bonds" means an obligation as defined under section 475.51.

10.1 (b) "Capital improvement" means acquisition or betterment of public lands,  
10.2 buildings, or other improvements within the county for the purpose of a county  
10.3 courthouse, administrative building, health or social service facility, correctional facility,  
10.4 jail, law enforcement center, hospital, morgue, library, park, qualified indoor ice arena,  
10.5 roads and bridges, public works facilities, fairgrounds buildings, fiber-optic cable or other  
10.6 means of voice and data transmission among municipal buildings, and the acquisition  
10.7 of development rights in the form of conservation easements under chapter 84C. An  
10.8 improvement must have an expected useful life of five years or more to qualify. "Capital  
10.9 improvement" does not include light rail transit or any activity related to it or a recreation  
10.10 or sports facility building (such as, but not limited to, a gymnasium, ice arena, racquet  
10.11 sports facility, swimming pool, exercise room or health spa), unless the building is part of  
10.12 an outdoor park facility and is incidental to the primary purpose of outdoor recreation.

10.13 (c) "Metropolitan county" means a county located in the seven-county metropolitan  
10.14 area as defined in section 473.121 or a county with a population of 90,000 or more.

10.15 (d) "Population" means the population established by the most recent of the  
10.16 following (determined as of the date the resolution authorizing the bonds was adopted):

10.17 (1) the federal decennial census,

10.18 (2) a special census conducted under contract by the United States Bureau of the  
10.19 Census, or

10.20 (3) a population estimate made either by the Metropolitan Council or by the state  
10.21 demographer under section 4A.02.

Sec. 12. TOWN OF WHITE, ST. LOUIS COUNTY.

Subd. 4. **Name.** The public name of the buildings and improvements located on the real property legally described in subdivision 1 shall always include the words "White community."
