1.18 Subd. 3. **Application.** "Application" means the submission to a county agency, by
1.19 or on behalf of a family, of a completed, signed, and dated;

1.20 (1) child care assistance universal application form that indicates the family's desire
1.21 to receive assistance; or

1.22 (2) child care addendum form in combination with a combined application form
1.23 for MFIP, DWP, or food support.

1.24 Sec. 2. Minnesota Statutes 2008, section 119B.08, subdivision 2, is amended to read:

1.25 Subd. 2. **Quarterly Monthly payments.** ~~The commissioner may make payments~~
1.26 ~~to each county in quarterly installments. The commissioner may certify an advance~~

2.1 ~~up to 25 percent of the allocation. Subsequent~~ The commissioner shall make monthly
 2.2 ~~payments shall be made~~ on a reimbursement basis for ~~reported~~ expenditures ~~and may be~~

 2.4 administer child care assistance. Payments may be withheld if ~~quarterly~~ monthly reports

2.7 Subdivision 1. **General eligibility requirements for all applicants for child**
 2.8 **care assistance.** (a) Child care services must be available to families who need child
 2.9 care to find or keep employment or to obtain the training or education necessary to find
 2.10 employment and who:

2.11 (1) have household income less than or equal to 67 percent of the state median
 2.12 income, adjusted for family size, and meet the requirements of section 119B.05; receive
 2.13 MFIP assistance; and are participating in employment and training services under chapter
 2.14 256J; or

2.15 (2) have household income less than or equal to 47 percent of the state median
 2.16 income, adjusted for family size, at program entry and less than or equal to 67 percent of
 2.17 the state median income, adjusted for family size, at program exit.

2.18 (b) Child care services must be made available as in-kind services.

2.19 (c) All applicants for child care assistance and families currently receiving child care
 2.20 assistance must be assisted and required to cooperate in establishment of paternity and
 2.21 enforcement of child support obligations for all children in the family as a condition
 2.22 of program eligibility. For purposes of this section, a family is considered to meet the
 2.23 requirement for cooperation when the family complies with the requirements of section
 2.24 256.741.

2.25 Sec. 4. Minnesota Statutes 2008, section 119B.12, subdivision 1, is amended to read:

2.26 Subdivision 1. **Fee schedule.** ~~In setting the sliding fee schedule, the commissioner~~
 2.27 ~~shall exclude from the amount of income used to determine eligibility an amount for~~
 2.28 ~~federal and state income and Social Security taxes attributable to that income level~~
 2.29 ~~according to federal and state standardized tax tables. The commissioner shall base the~~

3.41 Subd. 6. **Provider payments.** ~~(a) Counties or the state shall make vendor payments~~
3.42 ~~to the child care provider or pay the parent directly for eligible child care expenses.~~

4.1 ~~(b) If payments for child care assistance are made to providers,~~ (a) The provider
 4.2 shall bill ~~the county~~ for services provided within ten days of the end of the service period.
 4.3 If bills are submitted within ten days of the end of the service period, ~~a county or the state~~
 4.4 ~~shall issue payment to the provider of child care payments~~ under the child care fund shall
 4.5 be made within 30 days of receiving a bill from the provider. Counties or the state may

5.20 Section 1. Minnesota Statutes 2008, section 256.014, subdivision 1, is amended to read:

5.21 Subdivision 1. **Establishment of systems.** (a) The commissioner of human services
5.22 shall establish and enhance computer systems necessary for the efficient operation of the
5.23 programs the commissioner supervises, including:

5.24 (1) management and administration of the food stamp, food support, and income
5.25 maintenance programs, including the electronic distribution of benefits;

5.26 (2) management and administration of the child support enforcement program; and

5.27 (3) administration of medical assistance and general assistance medical care.

5.28 (b) The commissioner's development costs incurred by computer systems for
5.29 statewide programs administered by that computer system and mandated by state or
5.30 federal law must not be assessed against county agencies. The commissioner may
5.31 charge a county for development and operating costs incurred by computer systems for
5.32 functions requested by the county and not mandated by state or federal law for programs
5.33 administered by the computer system incurring the cost.

5.34 (c) The commissioner shall distribute the nonfederal share of the costs of operating
5.35 and maintaining the systems to the commissioner and to the counties participating in the

6.1 system in a manner that reflects actual system usage, except that the nonfederal share of

 6.3 statewide programs administered by those systems and mandated by state or federal law

6.6 The commissioner may enter into contractual agreements with federally recognized
 6.7 Indian tribes with a reservation in Minnesota to participate in state-operated computer
 6.8 systems related to the management and administration of the food stamp, food support,
 6.9 income maintenance, child support enforcement, and medical assistance and general
 6.10 assistance medical care programs to the extent necessary for the tribe to operate a federally
 6.11 approved family assistance program or any other program under the supervision of the
 6.12 commissioner.

6.13 Sec. 2. Minnesota Statutes 2008, section 256.0471, subdivision 1, is amended to read:

6.14 Subdivision 1. **Qualifying overpayment.** Any overpayment for assistance granted
 6.15 under chapter 119B, the MFIP program formerly codified under sections 256.031 to
 6.16 256.0361, and the AFDC program formerly codified under sections 256.72 to 256.871;
 6.17 chapters 256B for state-funded medical assistance, 256D, 256I, 256J, and 256K, and 256L
 6.18 for state-funded MinnesotaCare; and the food stamp or food support program, except
 6.19 agency error claims, become a judgment by operation of law 90 days after the notice of
 6.20 overpayment is personally served upon the recipient in a manner that is sufficient under
 6.21 rule 4.03(a) of the Rules of Civil Procedure for district courts, or by certified mail, return
 6.22 receipt requested. This judgment shall be entitled to full faith and credit in this and any
 6.23 other state.

6.26 Subd. 6a. **Administrative renewal of overpayment judgments.** Overpayment
 6.27 judgments may be renewed by service of notice upon the debtor. Service must be by first
 6.28 class mail at the last known address of the debtor, with service deemed complete upon
 6.29 mailing in that manner designated, or in the manner provided for the service of civil
 6.30 process. Upon filing of the notice and proof of service, the court administrator shall
 6.31 administratively renew the judgment for the overpayment without any additional filing
 6.32 fee in the same court file as the original overpayment judgment. The judgment must be
 6.33 renewed in an amount equal to the unpaid principle plus the accrued unpaid interest.

7.11 shelters under section 611A.31, the recipient is not eligible for a full general assistance
7.12 standard. The state standard of assistance for those recipients who have personal needs not

7.19 state standard of assistance is \$519.

7.20 (b) If an applicant married couple or recipient married couple who live together,
7.21 does not reside with others, the state standard of assistance is \$778.

7.22 (c) If an applicant or recipient resides with another person or persons, the state
7.23 standard of assistance is \$395.

7.24 (d) If an applicant married couple or recipient married couple who live together,
7.25 resides with others, the state standard of assistance is \$519.

7.26 (e) Married couples, living together who do not reside with others and were
7.27 receiving MSA prior to January 1, 1994, and whose eligibility has not been terminated a
7.28 full calendar month, the state standard of assistance is \$793.

7.29 (f) Married couples living together who reside with others and were receiving MSA
7.30 prior to January 1, 1994, and whose eligibility has not been terminated a full calendar
7.31 month, the state standard of assistance is \$782.

7.32 (g) For an individual who (1) receives Social Security insurance under federal
7.33 living arrangement D or (2) is a resident of a nursing home, a regional treatment center
7.34 or a group licensed residential housing facility and has unmet personal needs, the state

8.1 standard of assistance is the personal needs allowance for medical assistance recipients
8.2 under section 256B.35.

8.4 Subd. 2a. **License required.** A county agency may not enter into an agreement with
8.5 an establishment to provide group residential housing unless:

8.6 (1) the establishment is licensed by the Department of Health as a hotel and
8.7 restaurant; a board and lodging establishment; a residential care home; a boarding care
8.8 home before March 1, 1985; or a supervised living facility, and the service provider
8.9 for residents of the facility is licensed under chapter 245A. However, an establishment
8.10 licensed by the Department of Health to provide lodging need not also be licensed to
8.11 provide board if meals are being supplied to residents under a contract with a food vendor
8.12 who is licensed by the Department of Health;

8.32 (1) for group residential housing establishments licensed under Minnesota Rules,
8.33 parts 9525.0215 to 9525.0355, provided the facility is needed to meet the census reduction
8.34 targets for persons with developmental disabilities at regional treatment centers;

9.1 (2) to ensure compliance with the federal Omnibus Budget Reconciliation Act
9.2 alternative disposition plan requirements for inappropriately placed persons with
9.3 developmental disabilities or mental illness;

9.4 (3) up to 80 beds in a single, specialized facility located in Hennepin County that will
9.5 provide housing for chronic inebriates who are repetitive users of detoxification centers
9.6 and are refused placement in emergency shelters because of their state of intoxication,
9.7 and planning for the specialized facility must have been initiated before July 1, 1991,
9.8 in anticipation of receiving a grant from the Housing Finance Agency under section
9.9 462A.05, subdivision 20a, paragraph (b);

9.10 (4) notwithstanding the provisions of subdivision 2a, for up to 190 supportive
9.11 housing units in Anoka, Dakota, Hennepin, or Ramsey County for homeless adults with a
9.12 mental illness, a history of substance abuse, or human immunodeficiency virus or acquired
9.13 immunodeficiency syndrome. For purposes of this section, "homeless adult" means a
9.14 person who is living on the street or in a shelter or discharged from a regional treatment
9.15 center, community hospital, or residential treatment program and has no appropriate
9.16 housing available and lacks the resources and support necessary to access appropriate
9.17 housing. At least 70 percent of the supportive housing units must serve homeless adults
9.18 with mental illness, substance abuse problems, or human immunodeficiency virus or
9.19 acquired immunodeficiency syndrome who are about to be or, within the previous six
9.20 months, has been discharged from a regional treatment center, or a state-contracted
9.21 psychiatric bed in a community hospital, or a residential mental health or chemical
9.22 dependency treatment program. If a person meets the requirements of subdivision 1,
9.23 paragraph (a), and receives a federal or state housing subsidy, the group residential housing
9.24 rate for that person is limited to the supplementary rate under section 256I.05, subdivision
9.25 1a, and is determined by subtracting the amount of the person's countable income that
9.26 exceeds the MSA equivalent rate from the group residential housing supplementary rate.
9.27 A resident in a demonstration project site who no longer participates in the demonstration
9.28 program shall retain eligibility for a group residential housing payment in an amount
9.29 determined under section 256I.06, subdivision 8, using the MSA equivalent rate. Service
9.30 funding under section 256I.05, subdivision 1a, will end June 30, 1997, if federal matching
9.31 funds are available and the services can be provided through a managed care entity. If
9.32 federal matching funds are not available, then service funding will continue under section
9.33 256I.05, subdivision 1a;

9.34 (5) for group residential housing beds in settings meeting the requirements of
9.35 subdivision 2a, clauses (1) and (3), which are used exclusively for recipients receiving
9.36 home and community-based waiver services under sections 256B.0915, 256B.092,

10.1 subdivision 5, 256B.093, and 256B.49, and who resided in a nursing facility for the six
10.2 months immediately prior to the month of entry into the group residential housing setting.
10.3 The group residential housing rate for these beds must be set so that the monthly group
10.4 residential housing payment for an individual occupying the bed when combined with the
10.5 nonfederal share of services delivered under the waiver for that person does not exceed
10.6 the nonfederal share of the monthly medical assistance payment made for the person to
10.7 the nursing facility in which the person resided prior to entry into the group residential
10.8 housing establishment. The rate may not exceed the MSA equivalent rate plus \$426.37
10.9 for any case;

10.10 (6) for an additional two beds, resulting in a total of 32 beds, for a facility located in
10.11 Hennepin County providing services for recovering and chemically dependent men that
10.12 has had a group residential housing contract with the county and has been licensed as a
10.13 board and lodge facility with special services since 1980;

10.14 (7) for a group residential housing provider located in ~~Stearns County~~ the city
10.15 of St. Cloud, or a county contiguous to the city of St. Cloud, that operates a 40-bed
10.16 facility, that received financing through the Minnesota Housing Finance Agency Ending
10.17 Long-Term Homelessness Initiative and serves chemically dependent clientele, providing
10.18 24-hour-a-day supervision;

10.19 (8) for a new 65-bed facility in Crow Wing County that will serve chemically
10.20 dependent persons, operated by a group residential housing provider that currently
10.21 operates a 304-bed facility in Minneapolis, and a 44-bed facility in Duluth;

10.22 (9) for a group residential housing provider that operates two ten-bed facilities, one
10.23 located in Hennepin County and one located in Ramsey County, that provide community
10.24 support and 24-hour-a-day supervision to serve the mental health needs of individuals
10.25 who have chronically lived unsheltered; and

10.26 (10) for a group residential facility in Hennepin County with a capacity of up to 48
10.27 beds that has been licensed since 1978 as a board and lodging facility and that until August
10.28 1, 2007, operated as a licensed chemical dependency treatment program.

10.29 (b) A county agency may enter into a group residential housing agreement for beds
10.30 with rates in excess of the MSA equivalent rate in addition to those currently covered
10.31 under a group residential housing agreement if the additional beds are only a replacement
10.32 of beds with rates in excess of the MSA equivalent rate which have been made available
10.33 due to closure of a setting, a change of licensure or certification which removes the beds
10.34 from group residential housing payment, or as a result of the downsizing of a group
10.35 residential housing setting. The transfer of available beds from one county to another can
10.36 only occur by the agreement of both counties.

 11.4 ~~2007~~ 2009, a county agency shall negotiate a supplementary service rate in addition
 11.5 to the rate specified in subdivision 1, not to exceed \$700 per month, including any
 11.6 legislatively authorized inflationary adjustments, for a group residential housing
 11.7 provider located in Stearns, Sherburne, or Benton County that operates a 40-bed
 11.8 facility, that received financing through the Minnesota Housing Finance Agency Ending
 11.9 Long-Term Homelessness Initiative and serves chemically dependent clientele, providing

11.14 Subd. 5. **MFIP transitional standard.** The MFIP transitional standard is based
 11.15 on the number of persons in the assistance unit eligible for both food and cash assistance
