1.5	Section 1. [116J.438] MINNESOTA GREEN ENTERPRISE AUTHORITY.
1.6	(a) The Minnesota Green Enterprise Authority is created to advise, promote, market,
1.7	coordinate, and mandate collaboration on green enterprise and green economy projects, as
1.8	defined in section 116J.437, with state agencies, local governments, and the business and
1.9	agricultural communities. The authority is charged with utilizing existing resources and
1.10	breaking across administrative agency barriers to expedite the delivery of grants, licenses,
1.11	permits, and other requirements for implementing green economy projects.
1.12	(b) The authority consists of:
1.13	(1) three primary members dedicated full time to activities on behalf of the goals of
1.14	the authority, which include (i) a member employed in the Department of Employment and
