1.1 A bill for an act  
1.2 relating to taxes; modifying provisions relating to lawful gambling taxes;  
1.3 amending Minnesota Statutes 2008, sections 297E.01, subdivisions 7, 8;  
1.4 297E.02, subdivisions 1, 2, 3, 7, 10; 297E.13, subdivision 5; 349.12, subdivision  
1.5 25; 349.19, subdivision 2; repealing Minnesota Statutes 2008, sections 297E.02,  
1.6 subdivisions 4, 6, 11; 349.15, subdivision 3; 349.19, subdivision 2a.

1.7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.8 Section 1. Minnesota Statutes 2008, section 297E.01, subdivision 7, is amended to read:

1.9 Subd. 7. **Gambling product.** "Gambling product" means bingo hard cards, bingo  
1.10 paper sheets, facsimiles of bingo paper sheets, or linked bingo paper sheets; pull-tabs;  
1.11 tipboards; paddle tickets and paddle ticket cards; raffle tickets; or any other ticket, card,  
1.12 board, placard, device, or token that represents a chance, for which consideration is paid,  
1.13 to win a prize.

1.14 Sec. 2. Minnesota Statutes 2008, section 297E.01, subdivision 8, is amended to read:

1.15 Subd. 8. **Gross receipts.** "Gross receipts" means all receipts derived from lawful  
1.16 gambling activity including, but not limited to, the following items:

1.17 (1) gross sales of bingo hard cards and paper sheets before reduction for prizes,  
1.18 expenses, shortages, free plays, or any other charges or offsets;

1.19 (2) the ideal gross of pull-tab and tipboard deals or games less the value of unsold  
1.20 and defective tickets and before reduction for prizes, expenses, shortages, free plays,  
1.21 or any other charges or offsets;

1.22 (3) gross sales of raffle tickets and paddle tickets before reduction for prizes,  
1.23 expenses, shortages, free plays, or any other charges or offsets;

2.1 (4) admission, commission, cover, or other charges imposed on participants in  
2.2 lawful gambling activity as a condition for or cost of participation; and

2.3 (5) interest, dividends, annuities, profit from transactions, or other income derived  
2.4 from the accumulation or use of gambling proceeds.

2.5 Gross receipts does not include rental proceeds from ~~rental under section 349.18;~~  
2.6 ~~subdivision 3~~ premises owned by an organization and leased to one or more other  
2.7 organizations for the purposes of conducting lawful gambling.

2.8 Sec. 3. Minnesota Statutes 2008, section 297E.02, subdivision 1, is amended to read:

2.9 Subdivision 1. **Imposition.** (a) A tax is imposed on all lawful gambling ~~other than~~  
2.10 ~~(1) pull-tab deals or games; (2) tipboard deals or games; and (3) items listed in section~~  
2.11 ~~297E.01, subdivision 8, clauses (4) and (5);~~ at the rate of ~~8.5~~ 3.75 percent on the gross  
2.12 receipts as defined in section 297E.01, subdivision 8, ~~less prizes actually paid.~~

2.13 (b) The tax imposed by this subdivision is in lieu of the tax imposed by section  
2.14 297A.62 and all local taxes ~~and license fees,~~ except a local investigation fee authorized  
2.15 under section 349.16, subdivision 8, ~~or a tax authorized under subdivision 5~~ or a local  
2.16 gambling tax authorized under section 349.213, subdivision 3.

2.17 (c) The tax imposed under this subdivision is payable by the organization or party  
2.18 conducting, directly or indirectly, the gambling.

2.19 (d) The liability for the tax imposed by this section is incurred when the gambling  
2.20 product is received by a customer from a licensed distributor.

2.21 Sec. 4. Minnesota Statutes 2008, section 297E.02, subdivision 2, is amended to read:

2.22 Subd. 2. ~~Tax-exempt gambling~~ **Exemptions from tax.** The tax imposed by this  
2.23 section is not imposed on the following:

2.24 (1) an organization's receipts from lawful gambling that are excluded or exempt  
2.25 from licensing under section 349.166, are not subject to the tax imposed by this section or  
2.26 section 297A.62. This exclusion from tax is only valid if at the time of the event giving rise  
2.27 to the tax the organization either has an exclusion under section 349.166, subdivision 1, or  
2.28 has applied for and received a valid exemption from the lawful gambling control board;

2.29 (2) sales to the governing body of an Indian tribal organization for use on an Indian  
2.30 reservation;

2.31 (3) sales to distributors licensed under the laws of another state or of a province of  
2.32 Canada, as long as all statutory and regulatory requirements are met in the other state or  
2.33 province; and

2.34 (4) sales of promotional tickets as defined in section 349.12.

3.1 Sec. 5. Minnesota Statutes 2008, section 297E.02, subdivision 3, is amended to read:

3.2 Subd. 3. **Collection; disposition.** (a) Taxes imposed by this section other than in  
3.3 subdivision 4 and the monthly regulatory fee required under chapter 349 are due and  
3.4 payable to the commissioner when with the gambling tax return that is required to be  
3.5 filed. Taxes imposed by subdivision 4 are due and payable to the commissioner on or  
3.6 before the last business day of the month following the month in which the taxable sale  
3.7 was made. Returns covering the taxes imposed under this section must be filed with the  
3.8 commissioner on or before the 20th day of the month following the close of the previous  
3.9 calendar month or last sale of a lawful gambling game.

3.10 (b) The commissioner may require that the returns be filed via magnetic media or  
3.11 electronic data transfer.

3.12 (c) The proceeds, along with the revenue received from all license fees and other  
3.13 fees under sections 349.11 to 349.191, 349.211, and 349.213, taxes received under this  
3.14 section must be paid to the commissioner of finance for deposit in the general fund.

3.15 (d) The monthly regulatory fee received under this section must be deposited in the  
3.16 lawful gambling regulation account in the special revenue fund according to section  
3.17 349.151.

3.18 Sec. 6. Minnesota Statutes 2008, section 297E.02, subdivision 7, is amended to read:

3.19 Subd. 7. **Untaxed Tax on illegal or lost gambling product.** (a) In addition to  
3.20 penalties or criminal sanctions imposed by this chapter, a person, organization, or business  
3.21 entity possessing, playing, or selling a pull-tab or tipboard upon which the tax imposed by  
3.22 subdivision 4 has not been paid for which:

3.23 (1) they are not authorized under chapter 349 to have in their possession;

3.24 (2) they do not possess a valid invoice from a licensed distributor; or

3.25 (3) the game does not conform with the standards as set forth in chapter 349,  
3.26 including the bar code information;

3.27 is liable for a tax of six percent of the ideal gross of each pull-tab or tipboard. The tax  
3.28 on a partial deal must be assessed as if it were a full deal.

3.29 (b) In addition to penalties and criminal sanctions imposed by this chapter, a person  
3.30 not licensed by the board who conducts bingo, raffles, or paddle wheel games is liable for  
3.31 a tax of six percent of the gross receipts from that activity.

3.32 (c) In addition to penalties or criminal sanctions imposed by this chapter, a licensed  
3.33 organization or a licensed distributor is liable for a tax of 3.75 percent of the ideal gross  
3.34 receipts for lawful gambling equipment registered with the state in inventory but later  
3.35 found to be missing or lost.

4.1           (d) The tax must be assessed by the commissioner. An assessment must be  
 4.2 considered a jeopardy assessment or jeopardy collection as provided in section 270C.36.  
 4.3 The commissioner shall assess the tax based on personal knowledge or information  
 4.4 available to the commissioner. The commissioner shall mail to the taxpayer at the  
 4.5 taxpayer's last known address, or serve in person, a written notice of the amount of tax,  
 4.6 demand its immediate payment, and, if payment is not immediately made, collect the tax  
 4.7 by any method described in chapter 270C, except that the commissioner need not await the  
 4.8 expiration of the times specified in chapter 270C. The tax assessed by the commissioner  
 4.9 is presumed to be valid and correctly determined and assessed. The burden is upon the  
 4.10 taxpayer to show its incorrectness or invalidity. The tax imposed under this subdivision  
 4.11 does not apply to gambling that is exempt from taxation under subdivision 2.

4.12           Sec. 7. Minnesota Statutes 2008, section 297E.02, subdivision 10, is amended to read:

4.13           Subd. 10. **Refunds; appropriation.** (a) A person who has, under this chapter, paid  
 4.14 to the commissioner an amount of tax for a period in excess of the amount legally due for  
 4.15 that period, may file with the commissioner a claim for a refund of the excess.

4.16           (b) An organization licensed under section 349.16 may file with the commissioner a  
 4.17 claim for a refund or credit of taxes paid under subdivision 1 if the organization's gross  
 4.18 receipts for the previous calendar year were \$100,000 or less. Organizations claiming a  
 4.19 refund or credit with less than 12 months of activity from the previous calendar year will  
 4.20 be evaluated on a prorated basis. The refund or credit provided under this section must be  
 4.21 filed as part of the organization's February monthly tax return.

4.22           (c) The amount necessary to pay the refunds under this subdivision ~~and subdivision~~  
 4.23 ~~4, paragraph (d)~~; is appropriated from the general fund to the commissioner.

4.24           Sec. 8. Minnesota Statutes 2008, section 297E.13, subdivision 5, is amended to read:

4.25           Subd. 5. **Untaxed gambling equipment.** It is a gross misdemeanor for a person  
 4.26 to possess gambling equipment for resale in this state that has not been stamped or  
 4.27 bar-coded in accordance with this chapter and chapter 349 and in compliance with section  
 4.28 297E.02, subdivision 7, and upon which the taxes imposed by chapter 297A or section  
 4.29 297E.02, subdivision 4, have not been paid. The director of alcohol and gambling  
 4.30 enforcement or the commissioner or the designated inspectors and employees of the  
 4.31 director or commissioner may seize in the name of the state of Minnesota any unregistered  
 4.32 or untaxed gambling equipment.

4.33           Sec. 9. Minnesota Statutes 2008, section 349.12, subdivision 25, is amended to read:

5.1 Subd. 25. **Lawful purpose.** (a) "Lawful purpose" means one or more of the  
5.2 following:

5.3 (1) any expenditure by or contribution to a 501(c)(3) or festival organization, as  
5.4 defined in subdivision 15a, provided that the organization and expenditure or contribution  
5.5 are in conformity with standards prescribed by the board under section 349.154, which  
5.6 standards must apply to both types of organizations in the same manner and to the same  
5.7 extent;

5.8 (2) a contribution to or expenditure for goods and services for an individual or  
5.9 family suffering from poverty, homelessness, or disability, which is used to relieve the  
5.10 effects of that suffering;

5.11 (3) a contribution to a program recognized by the Minnesota Department of Human  
5.12 Services for the education, prevention, or treatment of problem gambling;

5.13 (4) a contribution to or expenditure on a public or private nonprofit educational

5.24 limit on the amount of reasonable and necessary expenditures made to support:

5.25 (i) members of a military marching or color guard unit for activities conducted  
5.26 within the state;

5.27 (ii) members of an organization solely for services performed by the members at  
5.28 funeral services;

6.2 United States on receipts from lawful gambling, the taxes imposed by section 297E.02,  
6.3 ~~subdivisions subdivisions 1, 4, 5, and 6~~, and the tax imposed on unrelated business income  
6.4 by section 290.05, subdivision 3;

6.5 (9) payment of real estate taxes and assessments on permitted gambling premises  
6.6 owned by the licensed organization paying the taxes, or wholly leased by a licensed  
6.7 veterans organization under a national charter recognized under section 501(c)(19) of the  
6.8 Internal Revenue Code;

6.9 (10) a contribution to the United States, this state or any of its political subdivisions,  
6.10 or any agency or instrumentality thereof other than a direct contribution to a law  
6.11 enforcement or prosecutorial agency;

6.12 (11) a contribution to or expenditure by a nonprofit organization which is a church  
6.13 or body of communicants gathered in common membership for mutual support and  
6.14 edification in piety, worship, or religious observances;

6.15 (12) payment of the reasonable costs of an audit required in section 297E.06,  
6.16 subdivision 4, provided the annual audit is filed in a timely manner with the Department of  
6.17 Revenue and paid prior to June 30, 2006;

6.18 (13) a contribution to or expenditure on projects or activities approved by the  
6.19 commissioner of natural resources for:

6.20 (i) wildlife management projects that benefit the public at large;

6.21 (ii) grant-in-aid trail maintenance and grooming established under sections 84.83  
6.22 and 84.927, and other trails open to public use, including purchase or lease of equipment  
6.23 for this purpose; and

6.24 (iii) supplies and materials for safety training and educational programs coordinated

6.32 organization for payment of water, fuel for heating, electricity, and sewer costs for a  
6.33 building wholly owned or wholly leased by and used as the primary headquarters of the

6.35 (17) expenditure by a licensed veterans organization of up to \$5,000 in a calendar  
6.36 year in net costs to the organization for meals and other membership events, limited to

7.8 or local community.

7.9 (b) Notwithstanding paragraph (a), "lawful purpose" does not include:

7.10 (1) any expenditure made or incurred for the purpose of influencing the nomination  
7.11 or election of a candidate for public office or for the purpose of promoting or defeating a  
7.12 ballot question;

7.13 (2) any activity intended to influence an election or a governmental decision-making  
7.14 process;

7.15 (3) the erection, acquisition, improvement, expansion, repair, or maintenance of real  
7.16 property or capital assets owned or leased by an organization, unless the board has first  
7.17 specifically authorized the expenditures after finding that (i) the real property or capital  
7.18 assets will be used exclusively for one or more of the purposes in paragraph (a); (ii)  
7.19 with respect to expenditures for repair or maintenance only, that the property is or will  
7.20 be used extensively as a meeting place or event location by other nonprofit organizations  
7.21 or community or service groups and that no rental fee is charged for the use; (iii) with  
7.22 respect to expenditures, including a mortgage payment or other debt service payment,  
7.23 for erection or acquisition only, that the erection or acquisition is necessary to replace  
7.24 with a comparable building, a building owned by the organization and destroyed or  
7.25 made uninhabitable by fire or catastrophe, provided that the expenditure may be only  
7.26 for that part of the replacement cost not reimbursed by insurance; (iv) with respect to  
7.27 expenditures, including a mortgage payment or other debt service payment, for erection or  
7.28 acquisition only, that the erection or acquisition is necessary to replace with a comparable  
7.29 building a building owned by the organization that was acquired from the organization by  
7.30 eminent domain or sold by the organization to a purchaser that the organization reasonably  
7.31 believed would otherwise have acquired the building by eminent domain, provided  
7.32 that the expenditure may be only for that part of the replacement cost that exceeds the  
7.33 compensation received by the organization for the building being replaced; or (v) with  
7.34 respect to an expenditure to bring an existing building into compliance with the Americans  
7.35 with Disabilities Act under item (ii), an organization has the option to apply the amount of

8.1 the board-approved expenditure to the erection or acquisition of a replacement building  
8.2 that is in compliance with the Americans with Disabilities Act;

8.3 (4) an expenditure by an organization which is a contribution to a parent  
8.4 organization, foundation, or affiliate of the contributing organization, if the parent  
8.5 organization, foundation, or affiliate has provided to the contributing organization within  
8.6 one year of the contribution any money, grants, property, or other thing of value;

8.7 (5) a contribution by a licensed organization to another licensed organization unless  
8.8 the board has specifically authorized the contribution. The board must authorize such a  
8.9 contribution when requested to do so by the contributing organization unless it makes an  
8.10 affirmative finding that the contribution will not be used by the recipient organization for  
8.11 one or more of the purposes in paragraph (a); or

8.12 (6) a contribution to a statutory or home rule charter city, county, or town by a  
8.13 licensed organization with the knowledge that the governmental unit intends to use the  
8.14 contribution for a pension or retirement fund.

8.15 Sec. 10. Minnesota Statutes 2008, section 349.19, subdivision 2, is amended to read:

8.16 Subd. 2. **Accounts.** Gross receipts from lawful gambling by each organization must  
8.17 be segregated from all other revenues of the conducting organization and placed in a  
8.18 separate account. All expenditures for expenses, taxes, and lawful purposes must be made  
8.19 from the separate account except (1) in the case of expenditures previously approved  
8.20 by the organization's membership for emergencies as defined by board rule, or (2) ~~as~~  
8.21 ~~provided in subdivision 2a, or (3)~~ when restricted to one electronic fund transaction for  
8.22 the payment of taxes for the organization as a whole, the organization may transfer the  
8.23 amount of taxes related to the conduct of gambling to the general account at the time when  
8.24 due and payable. The name and address of the bank, the account number for the separate  
8.25 account, and the names of organization members authorized as signatories on the separate  
8.26 account must be provided to the board when the application is submitted. Changes in the  
8.27 information must be submitted to the board at least ten days before the change is made.  
8.28 Gambling receipts must be deposited into the gambling bank account within four business  
8.29 days of completion of the bingo occasion, deal, or game from which they are received. A  
8.30 deal of pull-tabs is considered complete when either the last pull-tab of the deal is sold or  
8.31 the organization does not continue the play of the deal during the next scheduled period  
8.32 of time in which the organization will conduct pull-tabs. A tipboard game is considered  
8.33 complete when the seal on the game flare is uncovered. Deposit records must be sufficient  
8.34 to allow determination of deposits made from each bingo occasion, deal, or game at each

9.1 permitted premises. The person who accounts for gambling gross receipts and profits may  
9.2 not be the same person who accounts for other revenues of the organization.

9.3 Sec. 11. **REPEALER.**

9.4 (a) Minnesota Statutes 2008, sections 297E.02, subdivisions 6 and 11; and 349.15,  
9.5 subdivision 3, are repealed.

9.6 (b) Minnesota Statutes 2008, sections 297E.02, subdivision 4; and 349.19,  
9.7 subdivision 2a, are repealed, effective June 30, 2010.

9.8 Sec. 12. **EFFECTIVE DATE.**

9.9 Except as otherwise provided, sections 1 to 11 are effective January 1, 2010.

**297E.02 TAX IMPOSED.**

Subd. 4. **Pull-tab and tipboard tax.** (a) A tax is imposed on the sale of each deal of pull-tabs and tipboards sold by a distributor. The rate of the tax is 1.7 percent of the ideal gross of the pull-tab or tipboard deal. The sales tax imposed by chapter 297A on the sale of the pull-tabs and tipboards by the distributor is imposed on the retail sales price less the tax imposed by this subdivision. The retail sale of pull-tabs or tipboards by the organization is exempt from taxes imposed by chapter 297A and is exempt from all local taxes and license fees except a fee authorized under section 349.16, subdivision 8.

(b) The liability for the tax imposed by this section is incurred when the pull-tabs and tipboards are delivered by the distributor to the customer or to a common or contract carrier for delivery to the customer, or when received by the customer's authorized representative at the distributor's place of business, regardless of the distributor's method of accounting or the terms of the sale.

The tax imposed by this subdivision is imposed on all sales of pull-tabs and tipboards, except the following:

- (1) sales to the governing body of an Indian tribal organization for use on an Indian reservation;
- (2) sales to distributors licensed under the laws of another state or of a province of Canada, as long as all statutory and regulatory requirements are met in the other state or province;
- (3) sales of promotional tickets as defined in section 349.12; and
- (4) pull-tabs and tipboards sold to an organization that sells pull-tabs and tipboards under the exemption from licensing in section 349.166, subdivision 2. A distributor shall require an organization conducting exempt gambling to show proof of its exempt status before making a tax-exempt sale of pull-tabs or tipboards to the organization. A distributor shall identify, on all reports submitted to the commissioner, all sales of pull-tabs and tipboards that are exempt from tax under this subdivision.

(c) A distributor having a liability of \$120,000 or more during a fiscal year ending June 30 must remit all liabilities in the subsequent calendar year by electronic means.

(d) Any customer who purchases deals of pull-tabs or tipboards from a distributor may file an annual claim for a refund or credit of taxes paid pursuant to this subdivision for unsold pull-tab and tipboard tickets. The claim must be filed with the commissioner on a form prescribed by the commissioner by March 20 of the year following the calendar year for which the refund is claimed. The refund must be filed as part of the customer's February monthly return. The refund or credit is equal to 1.7 percent of the face value of the unsold pull-tab or tipboard tickets, provided that the refund or credit will be 1.75 percent of the face value of the unsold pull-tab or tipboard tickets for claims for a refund or credit of taxes filed on the February 2001 monthly return. The refund claimed will be applied as a credit against tax owing under this chapter on the February monthly return. If the refund claimed exceeds the tax owing on the February monthly return, that amount will be refunded. The amount refunded will bear interest pursuant to section 270C.405 from 90 days after the claim is filed.

Subd. 6. **Combined receipts tax.** In addition to the taxes imposed under subdivisions 1 and 4, a tax is imposed on the combined receipts of the organization. As used in this section, "combined receipts" is the sum of the organization's gross receipts from lawful gambling less gross receipts directly derived from the conduct of bingo, raffles, and paddle wheels, as defined in section 297E.01, subdivision 8, for the fiscal year. The combined receipts of an organization are subject to a tax computed according to the following schedule:

If the combined receipts for the fiscal year are:	The tax is:
Not over \$500,000	zero
Over \$500,000, but not over \$700,000	1.7 percent of the amount over \$500,000, but not over \$700,000
Over \$700,000, but not over \$900,000	\$3,400 plus 3.4 percent of the amount over \$700,000, but not over \$900,000
Over \$900,000	\$10,200 plus 5.1 percent of the amount over \$900,000

APPENDIX

Repealed Minnesota Statutes: 09-3024

Subd. 11. **Unplayed or defective pull-tabs or tipboards.** If a deal of pull-tabs or tipboards registered with the board or bar coded in accordance with this chapter and chapter 349 and upon which the tax imposed by subdivision 4 has been paid is returned unplayed to the distributor, the commissioner shall allow a refund of the tax paid.

If a defective deal registered with the board or bar coded in accordance with this chapter and chapter 349 and upon which the taxes have been paid is returned to the manufacturer, the distributor shall submit to the commissioner of revenue certification from the manufacturer that the deal was returned and in what respect it was defective. The certification must be on a form prescribed by the commissioner and must contain additional information the commissioner requires.

The commissioner may require that no refund under this subdivision be made unless the returned pull-tabs or tipboards have been set aside for inspection by the commissioner's employee.

Reductions in previously paid taxes authorized by this subdivision must be made when and in the manner prescribed by the commissioner.

**349.15 USE OF GROSS PROFITS.**

Subd. 3. **Refunds and credits.** For purposes of this section "gross profit" does not include any refund or credit received under section 297E.02, subdivision 4, paragraph (d).

**349.19 RECORDS AND REPORTS.**

Subd. 2a. **Tax refund or credit.** (a) Each organization that receives a refund or credit under section 297E.02, subdivision 4, paragraph (d), must within four business days of receiving a refund under that paragraph deposit the refund in the organization's gambling account.

(b) The organization may expend the tax refund or credit issued under section 297E.02, subdivision 4, paragraph (d), only for lawful purposes, other than lawful purposes described in section 349.12, subdivision 25, paragraph (a), clauses (8), (9), and (12). Amounts subject to this paragraph must be spent for qualifying lawful purposes no later than one year after the refund or credit is received.
