1.1 A bill for an act  
1.2 relating to highways; amending description of trunk highway route; removing  
1.3 route from trunk highway system; amending Minnesota Statutes 2008, section  
1.4 161.115, subdivision 263.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2008, section 161.115, subdivision 263, is amended to  
1.7 read:

1.8 Subd. 263. **Route No. 332.** Beginning at a point on Koochiching County State-Aid  
1.9 Highway 102 at its intersection with Constitutional Route No. 4 and Constitutional Route  
1.10 No. 11, southwesterly of International Falls, thence extending in a general easterly  
1.11 direction generally along the present route of said State-Aid Highway 102 to its junction  
1.12 with Constitutional Route No. 11 southeasterly of International Falls, ~~thence extending~~  
1.13 ~~in a general northerly direction generally along the present route of County State-Aid~~  
1.14 ~~Highway 114, a distance of approximately 2-1/2 miles, thence continuing in a general~~  
1.15 ~~northerly direction to legislative Route No. 158 east of International Falls.~~

1.16 **EFFECTIVE DATE.** This section is effective the day after the commissioner of  
1.17 transportation sends notice to the revisor of statutes electronically or in writing that the  
1.18 conditions required to transfer the route have been satisfied.

1.19 Sec. 2. **LEGISLATIVE ROUTE NO. 297 REMOVED.**

1.20 (a) Minnesota Statutes 2009, section 161.115, subdivision 228, is repealed effective  
1.21 the day after the commissioner of transportation receives a copy of the agreement between  
1.22 the commissioner and the governing body of the city of Fergus Falls to transfer jurisdiction  
1.23 of Legislative Route No. 297 and notifies the revisor of statutes under paragraph (b).

- 2.1 (b) The revisor of statutes shall delete the route identified in paragraph (a) from  
2.2 Minnesota Statutes when the commissioner of transportation sends notice to the revisor  
2.3 electronically or in writing informing the revisor of the effective date and that the  
2.4 conditions required to transfer the route are satisfied.
