3.16 Subdivision 1. **Structure; membership.** (a) The State Guardian Ad Litem Board is
3.17 established in the judicial branch. The board is not subject to the administrative control
3.18 of the judiciary. The State Guardian Ad Litem Board shall consist of seven members
3.19 including:

3.20 (1) three members appointed by the Supreme Court who include two attorneys
3.21 admitted to practice law in the state and one public member; and

3.22 (2) four members appointed by the governor.

3.23 The appointing authorities may not appoint an active judge to be a member of the
3.24 State Guardian Ad Litem Board, but may appoint a retired judge.

3.25 (b) All candidates shall demonstrate an interest in maintaining a high quality,
3.26 independent guardian ad litem program for the advocacy of the best interests of children
3.27 as required in juvenile and family court. The candidates shall be well acquainted with the
3.28 guardian ad litem program. At least three members of the board shall be from judicial
3.29 districts other than the First, Second, Fourth, and Tenth Judicial Districts. The terms,
3.30 compensation, and removal of members shall be as provided in section 15.0575. The
3.31 Supreme Court shall appoint the chair from among the membership for a term of two years.

3.32 Subd. 2. **Duties and responsibilities.** (a) The State Guardian Ad Litem Board shall
3.33 create and administer a statewide, independent guardian ad litem program to advocate for
3.34 the best interests of children, minor parents, and incompetent adults in juvenile and family

4.1 court cases as defined in Rule 901.01 of the Rules of Guardian Ad Litem Procedure in
4.2 Juvenile and Family Court matters.

4.3 (b) The board shall:

4.4 (1) approve and recommend to the legislature a budget for the board and the

4.20 Subd. 3. **State guardian ad litem program administrator.** The State Guardian
4.21 Ad Litem Board shall appoint a program administrator who serves at the pleasure of the
4.22 board. The program administrator is not required to be licensed to practice law. The
4.23 program administrator shall attend all meetings of the board, but may not vote, and shall:

4.24 (1) carry out all administrative functions necessary for the efficient and effective
4.25 operation of the board and the guardian ad litem program, including but not limited to
4.26 hiring, supervising, and disciplining program staff and guardians ad litem;

4.27 (2) implement, as necessary, resolutions, standards, rules, regulations, and policies
4.28 of the board;

4.29 (3) keep the board fully advised as to its financial condition, and prepare and submit
4.30 to the board the annual guardian ad litem program and State Guardian Ad Litem Board
4.31 budget and other financial information as requested by the board;

5.1 Subd. 4. **Administration.** The board may contract with the Office of State Court
5.2 Administrator for administrative support services for the fiscal years following fiscal

5.4 Subd. 5. **Benefits.** Any guardian ad litem employee who transferred to state
5.5 employment on or before July 1, 2005, may retain county benefits elected under section
5.6 480.181.

5.7 Subd. 6. **Access to records.** Access to records of the state guardian ad litem program
5.8 is subject to the Rules of Public Access for Records of the Judicial Branch. The State
5.9 Guardian Ad Litem Board may propose amendments for Supreme Court consideration.

5.10 Subd. 7. **Fees and costs; civil actions on contested case.** Sections 15.039 and
5.11 15.471 to 15.474 apply to the State Guardian Ad Litem Board.

6.2 The State Guardian Ad Litem Board shall be established by October 1, 2010. The
6.3 state guardian ad litem program administrator shall be appointed according to Minnesota
6.4 Statutes, section 480.35, and the operational structure of the board and guardian ad litem
6.5 program shall be established during fiscal year 2011. During fiscal year 2011, the state
6.6 court administrator and judicial district offices shall continue to provide administrative
6.7 support and management oversight services and may authorize program expenditures until
6.8 the board is established, as requested by the State Guardian Ad Litem Board. Existing
6.9 judicial branch policies for guardians ad litem shall apply until those policies are replaced
6.10 by policies of the State Guardian Ad Litem Board.

6.11 Sec. 8. **FUNDING; TRANSFER.**

6.12 (a) All guardian ad litem reimbursement account balances on June 30, 2010, shall be
6.13 transferred to the State Guardian Ad Litem Board from the trial courts and are appropriated

6.15 (b) The appropriation to the State Guardian Ad Litem Board for costs associated
