2.27 The commissioner may not: (1) spend
 2.28 any money from the trunk highway fund
 2.29 for capitol security; or (2) permanently
 2.30 transfer any state trooper from the patrolling
 2.31 highways activity to capitol security.

2.32 The commissioner may not transfer any
 2.33 money: (1) appropriated for Department of

3.1 Public Safety administration, the patrolling of
 3.2 highways, commercial vehicle enforcement,
 3.3 or driver and vehicle services to capitol
 3.4 security; or (2) from capitol security.

3.5 **(d) Vehicle Crimes Unit** 730,000

3.6 This appropriation is for the State Patrol to
 3.7 add at least eight troopers to investigate (1)
 3.8 registration tax and motor vehicle sales tax
 3.9 liabilities from individuals and businesses
 3.10 that currently do not pay all taxes owed; and
 3.11 (2) illegal or improper activity related to sale,
 3.12 transfer, titling, and registration of motor
 3.13 vehicles. This initiative is expected to result
 3.14 in new revenues for the biennium as follows:

3.15 (1) \$..... for the highway user tax
 3.16 distribution fund;

3.17 (2) \$..... for the transit assistance fund; and

3.18 (3) \$..... for the general fund.

3.19 **EFFECTIVE DATE.** This section is effective July 1, 2010.
