1.21 Subd. 14. **State Trail Development** 7,910,000

1.22 To acquire land for and to develop and
1.23 rehabilitate state trails as specified in
1.24 Minnesota Statutes, section 85.015.

1.25 \$1,500,000 is for the Blazing Star Trail
1.26 and, notwithstanding Minnesota Statutes,
1.27 section 16A.642, the bond sale authorization

2.1 and appropriation of bond proceeds for this
2.2 project are available until June 30, 2014.

2.3 \$435,000 is for a segment of the Blufflands
2.4 Trail, from Preston to Forestville.

2.5 \$200,000 is for a segment of the Blufflands
2.6 Trail, from Chester Woods County Park
2.7 to the city limits of Rochester in Olmsted
2.8 County, primarily for nonmotorized riding
2.9 and hiking.

2.10 \$400,000 is for the Douglas Trail.

2.11 \$400,000 is for the Gateway Trail.

2.12 \$725,000 is for the Gitchi Gami Trail.

2.13 \$500,000 is for the Glacial Lakes Trail.

2.14 \$200,000 is for the Goodhue Pioneer Trail.

2.15 \$300,000 is for the Heartland Trail.

2.16 \$300,000 is for the Mill Towns Trail.

2.17 \$100,000 is for the Minnesota River Trail.

2.18 \$2,400,000 is for the Paul Bunyan Trail:

2.19 \$320,000 is for an extension across Excelsior
2.20 Road in the city of Baxter to connect with the
2.21 Oberstar Tunnel and may be used to match
2.22 federal money for the trail; \$900,000 is to
2.23 acquire right-of-way in the city of Bemidji
2.24 and to rehabilitate the trail.

3.4 continuing to the city of Cloquet, along the
3.5 St. Louis River in Carlton County.

3.6 \$260,000 is to provide the state match for the
3.7 cost of the Soo Line Multiuse Recreational
3.8 Bridge project over marked Trunk Highway
3.9 169 in Mille Lacs County.

3.10 \$175,000 is for a grant to the city of Bowlus
3.11 in Morrison County to design, construct,
3.12 furnish, and equip a trailhead center at the
3.13 head of the Soo Line Recreational Trail.

3.14 \$125,000 is for a grant to Morrison
3.15 County to predesign, design, construct,
3.16 furnish, and equip a park-and-ride lot and
3.17 restroom building adjacent to the Soo Line
3.18 Recreational Trail at U.S. Highway 10.

3.19 \$950,000 is for a grant to the St. Louis
3.20 and Lake Counties Regional Railroad
3.21 Authority for land acquisition, engineering,
