.7	Subdivision 1. Conveyance of surplus land. (a) Notwithstanding Minnesota
.8	Statutes, sections 16B.281 to 16B.287, the commissioner of administration may upon
.9	recommendation of the commissioner of human services, convey to the city of St. Peter
.10	for no consideration the surplus land or any state interest in land that is described in
.11	paragraph (c).
.12	(b) The conveyance must be in a form approved by the attorney general. The
.13	attorney general may make changes to the land description to correct errors and ensure
.14	accuracy. The commissioner of administration may grant utility easements for no
.15	consideration in conjunction with the conveyances under this section.
