1.7	(a) The commissioner of natural resources, in consultation with the commissioner
1.8	of management and budget, shall estimate the total amount of funding available from all
1.9	sources for each of the following land management categories: wildlife management
1.10	areas; state forests; scientific and natural areas; aquatic management areas; public water
1.11	access sites; and prairie bank easements. The commissioner of natural resources shall
1.12	prepare a ten-year budget analysis of the department's ongoing land management needs,
