2.16 **PROPERTY TAXES**

2.17 Section 1. Minnesota Statutes 2008, section 82B.035, subdivision 2, is amended to read:

2.18 Subd. 2. **Assessors.** Nothing in this chapter shall be construed as requiring the
 2.19 licensing of persons employed and acting in their capacity as assessors for political
 2.20 subdivisions of the state and performing duties enumerated in section 273.061, subdivision
 2.21 7 or 8.

2.22 **EFFECTIVE DATE.** This section is effective the day following final enactment
 2.23 for testimony offered and opinions or reports prepared in cases or proceedings that have
 2.24 not been finally resolved.

2.25 Sec. 2. Minnesota Statutes 2008, section 270.075, subdivision 1, is amended to read:

2.26 Subdivision 1. **Rate of tax.** The commissioner shall determine the rate of tax to be
 2.27 levied and collected against the net tax capacity as determined pursuant to section 270.074,
 2.28 subdivision ~~2~~ 3, to generate revenues sufficient to fund the airflight property tax portion
 2.29 of each year's state airport fund appropriation, as certified to the commissioner by the
 2.30 commissioner of transportation. The certification shall be presented to the commissioner
 2.31 prior to December 31 of each year. The property tax portion of the state airport fund
 2.32 appropriation is the difference between the total fund appropriation and the estimated total
 2.33 fund revenues from other sources for the state fiscal year in which the tax is payable
 2.34 and may include a portion of the balance in the state airports fund as determined to be
 2.35 available by the commissioner of transportation. ~~If a levy amount has not been certified by~~
 2.36 ~~September 1 of a levy year, the commissioner shall use the last previous certified amount~~
 2.37 ~~to determine the rate of tax.~~ The certification by the commissioner of transportation to
 2.38 the commissioner shall state the total fund appropriation and shall list individually the

3.1 estimated fund revenues including the account carryover balance in the airport fund.
3.2 The difference of these amounts shall be shown as the property tax portion of the state
3.3 airport fund appropriation.

3.4 If a levy amount has not been certified by December 31 of a levy year, the
3.5 commissioner shall use the last previous certified amount to determine the rate of tax, and
3.6 shall notify the chairs and the ranking minority members of the committees of the house
3.7 of representatives and senate having jurisdiction over the Department of Transportation
3.8 that a certification was not made under this subdivision.

3.9 **EFFECTIVE DATE.** This section is effective for taxes payable in 2011 and
3.10 thereafter.

3.11 Sec. 3. Minnesota Statutes 2008, section 270.075, subdivision 2, is amended to read:

3.12 Subd. 2. **Notice of taxes; payment.** As soon as practicable and not later than
3.13 ~~December~~ March 1 next following the levy of the tax, the commissioner shall give actual
3.14 notice to the airline company of the net tax capacity and of the tax. The taxes imposed
3.15 under sections 270.071 to 270.079 shall become due and payable on ~~January~~ April 1
3.16 following the levy thereof. If any tax is not paid on the due date or, if an appeal is made
3.17 pursuant to section 270.076, within 60 days after notice of an increased tax, a late payment
3.18 penalty of five percent of the unpaid tax shall be assessed. If the tax remains unpaid for
3.19 more than 30 days, an additional penalty of five percent of the unpaid tax is imposed for
3.20 each additional 30 days or fraction of 30 days that the tax remains unpaid. The penalty
3.21 imposed under this section must not exceed the lesser of \$25,000 or 25 percent of the

3.27 Sec. 4. Minnesota Statutes 2008, section 270.41, subdivision 5, is amended to read:

3.28 Subd. 5. **Prohibited activity.** A licensed assessor or other person employed by an
3.29 assessment jurisdiction or contracting with an assessment jurisdiction for the purpose
3.30 of valuing or classifying property for property tax purposes is prohibited from making
3.31 appraisals or analyses, accepting an appraisal assignment, or preparing an appraisal report
3.32 as defined in section 82B.02, subdivisions 2 to 5, on any property within the assessment
3.33 jurisdiction where the individual is employed or performing the duties of the assessor

4.1 under contract. Violation of this prohibition shall result in immediate revocation of the
4.2 individual's license to assess property for property tax purposes. This prohibition must
4.3 not be construed to prohibit an individual from carrying out any duties required for the
4.4 proper assessment of property for property tax purposes or performing duties enumerated
4.5 in section 273.061, subdivision 7 or 8. If a formal resolution has been adopted by the
4.6 governing body of a governmental unit, which specifies the purposes for which such
4.7 work will be done, this prohibition does not apply to appraisal activities undertaken on
4.8 behalf of and at the request of the governmental unit that has employed or contracted with
4.9 the individual. The resolution may only allow appraisal activities which are related to
4.10 condemnations, right-of-way acquisitions, or special assessments.

4.13 not been finally resolved.

4.14 Sec. 5. Minnesota Statutes 2008, section 272.0213, is amended to read:

4.15 **272.0213 LEASED SEASONAL-RECREATIONAL LAND.**

4.16 (a) A county board may elect, by resolution, to exempt from taxation, including the
4.17 tax under section 273.19, qualified lands. "Qualified lands" for purposes of this section
4.18 means property that:

4.19 (1) is owned by a county, city, town, or the state,~~or the federal governments;~~

4.20 (2) is rented by the entity for noncommercial seasonal-recreational or noncommercial
4.21 seasonal-recreational residential use; and

4.22 (3) was rented for the purposes specified in clause (2) and was exempt from taxation
4.23 for property taxes payable in 2008.

4.24 (b) Lands owned by the federal government and rented for noncommercial
4.25 seasonal-recreational or noncommercial seasonal-recreational residential use is exempt
4.26 from taxation, including the tax under section 273.19.

4.27 **EFFECTIVE DATE.** This section is effective beginning with taxes payable in 2011.

4.28 Sec. 6. Minnesota Statutes 2008, section 273.061, subdivision 7, is amended to read:

4.29 Subd. 7. **Division of duties between local and county assessor.** The duty of the
4.30 duly appointed local assessor shall be to view and appraise the value of all property as
4.31 provided by law, but all the book work shall be done by the county assessor, or the
4.32 assessor's assistants, and the value of all property subject to assessment and taxation
4.33 shall be determined by the county assessor, except as otherwise hereinafter provided. If

5.1 directed by the county assessor, the local assessor shall perform the duties enumerated
5.2 in subdivision 8, paragraph (16).

5.3 Sec. 7. Minnesota Statutes 2008, section 273.061, subdivision 8, is amended to read:

5.4 Subd. 8. **Powers and duties.** The county assessor shall have the following powers
5.5 and duties:

5.6 (1) To call upon and confer with the township and city assessors in the county, and
5.7 advise and give them the necessary instructions and directions as to their duties under
5.8 the laws of this state, to the end that a uniform assessment of all real property in the
5.9 county will be attained.

5.10 (2) To assist and instruct the local assessors in the preparation and proper use of land
5.11 maps and record cards, in the property classification of real and personal property, and in
5.12 the determination of proper standards of value.

5.13 (3) To keep the local assessors in the county advised of all changes in assessment
5.14 laws and all instructions which the assessor receives from the commissioner of revenue
5.15 relating to their duties.

5.16 (4) To have authority to require the attendance of groups of local assessors at
5.17 sectional meetings called by the assessor for the purpose of giving them further assistance
5.18 and instruction as to their duties.

5.19 (5) To immediately commence the preparation of a large scale topographical land
5.20 map of the county, in such form as may be prescribed by the commissioner of revenue,
5.21 showing thereon the location of all railroads, highways and roads, bridges, rivers and
5.22 lakes, swamp areas, wooded tracts, stony ridges and other features which might affect
5.23 the value of the land. Appropriate symbols shall be used to indicate the best, the fair, and
5.24 the poor land of the county. For use in connection with the topographical land map,
5.25 the assessor shall prepare and keep available in the assessor's office tables showing fair
5.26 average minimum and maximum market values per acre of cultivated, meadow, pasture,
5.27 cutover, timber and waste lands of each township. The assessor shall keep the map and
5.28 tables available in the office for the guidance of town assessors, boards of review, and
5.29 the county board of equalization.

5.30 (6) To also prepare and keep available in the office for the guidance of town
5.31 assessors, boards of review and the county board of equalization, a land valuation map
5.32 of the county, in such form as may be prescribed by the commissioner of revenue. This
5.33 map, which shall include the bordering tier of townships of each county adjoining, shall
5.34 show the average market value per acre, both with and without improvements, as finally

6.1 equalized in the last assessment of real estate, of all land in each town or unorganized
6.2 township which lies outside the corporate limits of cities.

6.3 (7) To regularly examine all conveyances of land outside the corporate limits of
6.4 cities of the first and second class, filed with the county recorder of the county, and keep a
6.5 file, by descriptions, of the considerations shown thereon. From the information obtained
6.6 by comparing the considerations shown with the market values assessed, the assessor
6.7 shall make recommendations to the county board of equalization of necessary changes in
6.8 individual assessments or aggregate valuations.

6.9 (8) To become familiar with the values of the different items of personal property
6.10 so as to be in a position when called upon to advise the boards of review and the county
6.11 board of equalization concerning property, market values thereof.

6.12 (9) While the county board of equalization is in session, to give it every possible
6.13 assistance to enable it to perform its duties. The assessor shall furnish the board with all
6.14 necessary charts, tables, comparisons, and data which it requires in its deliberations, and
6.15 shall make whatever investigations the board may desire.

6.16 (10) At the request of either the board of county commissioners or the commissioner
6.17 of revenue, to investigate applications for reductions of valuation and abatements and
6.18 settlements of taxes, examine the real or personal property involved, and submit written
6.19 reports and recommendations with respect to the applications, in such form as may be
6.20 prescribed by the board of county commissioners and commissioner of revenue.

6.21 (11) To make diligent search each year for real and personal property which has been
6.22 omitted from assessment in the county, and report all such omissions to the county auditor.

6.23 (12) To regularly confer with county assessors in all adjacent counties about the
6.24 assessment of property in order to uniformly assess and equalize the value of similar
6.25 properties and classes of property located in adjacent counties. The conference shall
6.26 emphasize the assessment of agricultural and commercial and industrial property or other
6.27 properties that may have an inadequate number of sales in a single county.

6.28 (13) To render such other services pertaining to the assessment of real and personal
6.29 property in the county as are not inconsistent with the duties set forth in this section, and as
6.30 may be required by the board of county commissioners or by the commissioner of revenue.

6.31 (14) To maintain a record, in conjunction with other county offices, of all transfers of
6.32 property to assist in determining the proper classification of property, including but not
6.33 limited to, transferring homestead property and name changes on homestead property.

6.34 (15) To determine if a homestead application is required due to the transfer of
6.35 homestead property or an owner's name change on homestead property.

7.1 (16) To perform appraisals of property, review the original assessment and determine
7.2 the accuracy of the original assessment, prepare an appraisal or appraisal report, and
7.3 testify before any court or other body as an expert or otherwise on behalf of the assessor's
7.4 jurisdiction with respect to properties in that jurisdiction.

7.5 **EFFECTIVE DATE.** This section is effective the day following final enactment
7.6 for testimony offered and opinions or reports prepared in cases or proceedings that have
7.7 not been finally resolved.

7.8 Sec. 8. Minnesota Statutes 2008, section 273.1231, subdivision 1, is amended to read:

7.9 Subdivision 1. **Applicability.** For purposes of sections 273.1231 to ~~273.1235~~
7.10 273.1236, the following words, terms, and phrases have the meanings given them in this
7.11 section unless the language or context clearly indicates that a different meaning is intended.

7.12 **EFFECTIVE DATE.** This section is effective for assessment year 2010 and
7.13 thereafter.

7.14 Sec. 9. Minnesota Statutes 2008, section 273.1232, subdivision 1, is amended to read:

7.15 Subdivision 1. **Reassessments required.** For the purposes of sections 273.1231 to
7.16 ~~273.1235~~ 273.1236, the county assessor must reassess all damaged property in a disaster
7.17 or emergency area, except that the commissioner of revenue shall reassess all property
7.18 for which an application is submitted to the commissioner under section 273.1233 or
7.19 273.1235. As soon as practical, the assessor or commissioner of revenue must report
7.20 the reassessed value to the county auditor.

7.21 **EFFECTIVE DATE.** This section is effective for assessment year 2010 and
7.22 thereafter.

7.23 Sec. 10. **[273.1236] DISASTER-DAMAGED HOMES; PARTIAL VALUATION**
7.24 **EXCLUSION.**

7.25 (a) A homestead property that (1) sustained physical damage from a disaster or
7.26 emergency resulting in a reassessed market value that is at least \$15,000 less than the
7.27 market value of the property established for the January 2 assessment in the year in which
7.28 the damage occurred, (2) has been substantially restored or rebuilt by the end of the
7.29 year following the year in which the damage occurred, (3) has a gross living area after
7.30 reconstruction that does not exceed 130 percent of the gross living area prior to the disaster
7.31 or emergency, and (4) has an estimated market value for the assessment year following the
7.32 year in which the restoration or reconstruction was substantially completed that exceeds

8.1 its estimated market value established for the January 2 assessment in the year in which
8.2 the damage occurred by at least \$25,000 due to the restoration or reconstruction, is eligible
8.3 for a valuation exclusion under this section for the two assessment years immediately
8.4 following the year in which the restoration or reconstruction was completed.

8.5 (b) The assessor shall determine the difference between the estimated market value
8.6 established for the January 2 assessment in the year in which the damage occurred and the
8.7 estimated market value established for the January 2 assessment in the year following the
8.8 completion of the restoration or reconstruction.

8.9 (c) In the first assessment year following the restoration or reconstruction, all of the
8.10 difference identified under paragraph (b) shall be excluded in determining taxable market
8.11 value. In the second assessment year following the restoration or reconstruction, half of
8.12 the difference identified under paragraph (b) shall be excluded in determining taxable
8.13 market value.

8.14 (d) For the purposes of this section, "gross living area" includes only above-grade
8.15 living area, and does not include any finished basement living area.

8.16 (e) Application for the valuation exclusion under this section must be filed by
8.17 January 2 of the year following the year in which the restoration or reconstruction was
8.18 substantially completed. The application must be filed with the assessor of the county in
8.19 which the property is located on the form prescribed by the commissioner of revenue.

8.20 **EFFECTIVE DATE.** This section is effective for assessment year 2010 and
8.21 thereafter. The application deadline in paragraph (e) is extended to June 30, 2010, for
8.22 restoration or reconstruction substantially completed in 2009.

8.23 Sec. 11. Minnesota Statutes 2008, section 273.124, subdivision 1, is amended to read:

8.24 Subdivision 1. **General rule.** (a) Residential real estate that is occupied and used
8.25 for the purposes of a homestead by its owner, who must be a Minnesota resident, is
8.26 a residential homestead.

8.27 Agricultural land, as defined in section 273.13, subdivision 23, that is occupied and
8.28 used as a homestead by its owner, who must be a Minnesota resident, is an agricultural
8.29 homestead.

8.30 Dates for establishment of a homestead and homestead treatment provided to
8.31 particular types of property are as provided in this section.

8.32 Property held by a trustee under a trust is eligible for homestead classification if the
8.33 requirements under this chapter are satisfied.

8.34 The assessor shall require proof, as provided in subdivision 13, of the facts upon
8.35 which classification as a homestead may be determined. Notwithstanding any other law,

9.1 the assessor may at any time require a homestead application to be filed in order to verify
9.2 that any property classified as a homestead continues to be eligible for homestead status.
9.3 Notwithstanding any other law to the contrary, the Department of Revenue may, upon
9.4 request from an assessor, verify whether an individual who is requesting or receiving
9.5 homestead classification has filed a Minnesota income tax return as a resident for the most
9.6 recent taxable year for which the information is available.

9.7 When there is a name change or a transfer of homestead property, the assessor may
9.8 reclassify the property in the next assessment unless a homestead application is filed to
9.9 verify that the property continues to qualify for homestead classification.

9.10 (b) For purposes of this section, homestead property shall include property which
9.11 is used for purposes of the homestead but is separated from the homestead by a road,
9.12 street, lot, waterway, or other similar intervening property. The term "used for purposes
9.13 of the homestead" shall include but not be limited to uses for gardens, garages, or other
9.14 outbuildings commonly associated with a homestead, but shall not include vacant land
9.15 held primarily for future development. In order to receive homestead treatment for
9.16 the noncontiguous property, the owner must use the property for the purposes of the
9.17 homestead, and must apply to the assessor, both by the deadlines given in subdivision
9.18 9. After initial qualification for the homestead treatment, additional applications for
9.19 subsequent years are not required.

9.20 (c) Residential real estate that is occupied and used for purposes of a homestead by a
9.21 relative of the owner is a homestead but only to the extent of the homestead treatment
9.22 that would be provided if the related owner occupied the property. For purposes of this
9.23 paragraph and paragraph (g), "relative" means a parent, stepparent, child, stepchild,
9.24 grandparent, grandchild, brother, sister, uncle, aunt, nephew, or niece. This relationship
9.25 may be by blood or marriage. Property that has been classified as seasonal residential
9.26 recreational property at any time during which it has been owned by the current owner or
9.27 spouse of the current owner will not be reclassified as a homestead unless it is occupied as
9.28 a homestead by the owner; this prohibition also applies to property that, in the absence of
9.29 this paragraph, would have been classified as seasonal residential recreational property at
9.30 the time when the residence was constructed. Neither the related occupant nor the owner
9.31 of the property may claim a property tax refund under chapter 290A for a homestead
9.32 occupied by a relative. In the case of a residence located on agricultural land, only the
9.33 house, garage, and immediately surrounding one acre of land shall be classified as a
9.34 homestead under this paragraph, except as provided in paragraph (d). In the case of
9.35 nonagricultural property, this paragraph only applies to applications approved before
9.36 December 16, 2010.

10.1 (d) Agricultural property that is occupied and used for purposes of a homestead by
10.2 a relative of the owner, is a homestead, only to the extent of the homestead treatment
10.3 that would be provided if the related owner occupied the property, and only if all of the
10.4 following criteria are met:

10.5 (1) the relative who is occupying the agricultural property is a son, daughter, brother,
10.6 sister, grandson, granddaughter, father, or mother of the owner of the agricultural property
10.7 or a son, daughter, brother, sister, grandson, or granddaughter of the spouse of the owner
10.8 of the agricultural property;

10.9 (2) the owner of the agricultural property must be a Minnesota resident;

10.10 (3) the owner of the agricultural property must not receive homestead treatment on
10.11 any other agricultural property in Minnesota; and

10.12 (4) the owner of the agricultural property is limited to only one agricultural
10.13 homestead per family under this paragraph.

10.14 Neither the related occupant nor the owner of the property may claim a property
10.15 tax refund under chapter 290A for a homestead occupied by a relative qualifying under
10.16 this paragraph. For purposes of this paragraph, "agricultural property" means the house,

53.2 under Minnesota Statutes, section 469.1731;

55.16 Subdivision 1. **Creation.** The Council on Local Results and Innovation consists of
 55.17 11 members, as follows:

55.18 (1) the state auditor;

55.19 (2) two persons who are not members of the legislature, appointed by the chair of the
 55.20 Property and Local Sales Tax Division of the house of representatives Taxes Committee;

55.21 (3) two persons who are not members of the legislature, appointed by the designated
 55.22 lead minority member of the Property and Local Sales Tax Division of the house of
 55.23 representatives Taxes Committee;

55.24 (4) two persons who are not members of the legislature, appointed by the chair of
 55.25 the Taxes Division on Property Taxes of the senate Taxes Committee;

55.26 (5) two persons who are not members of the legislature, appointed by the designated
 55.27 lead minority member of the Taxes Division on Property Taxes of the senate Taxes
 55.28 Committee;

55.29 (6) one person who is not a member of the legislature, appointed by the Association
 55.30 of Minnesota Counties; and

55.31 (7) one person who is not a member of the legislature, appointed by the League
 55.32 of Minnesota Cities.

55.33 Each appointment under clauses (2) to (5) must include one person with expertise
 55.34 or interest in county government and one person with expertise or interest in city

56.1 government. The appointing authorities must use their best efforts to ensure that a majority
56.2 of council members have experience with local performance measurement systems. The
56.3 membership of the council must include geographically balanced representation as well as
56.4 representation balanced between large and small jurisdictions. The appointments under
56.5 clauses (2) to (7) must be made within two months of the date of enactment.

56.6 Appointees to the council under clauses (2) to (5) serve terms of four years, except

57.1 implement a system of local performance measurement. The council may highlight and
57.2 promote systems that are innovative, or are ones that it deems to be best practices of local
57.3 performance measurement systems across the state and nation. The council should give
57.4 preference in its recommendations to systems that are results-oriented. The council may,
57.5 with the cooperation of the state auditor, establish and foster a collaborative network
57.6 of practitioners of local performance measurement systems. The council may support
57.7 the Association of Minnesota Counties and the League of Minnesota Cities to seek and
57.8 receive private funding to provide expert technical assistance to local governments for
57.9 the purposes of replicating best practices.

57.10 Subd. 3. **Reports.** (a) The council shall report its initial set of standard performance
57.11 measures to the Property and Local Sales Tax Division of the house of representatives
57.12 Taxes Committee and the Taxes Division on Property Taxes of the senate Taxes Committee
57.13 by February 28, 2011.

57.14 (b) By February 1 of each subsequent year, the council shall report to the committees
57.15 with jurisdiction over taxes in the house of representatives and the senate on participation
57.16 in and results of the performance measurement system, along with any revisions in the
57.17 standard set of performance measures for the upcoming year. These reports may be made
57.18 by the state auditor in lieu of the council if agreed to by the auditor and the council.

57.19 Subd. 4. **Operation of council.** (a) The state auditor shall convene the initial
57.20 meeting of the council.

57.21 (b) The chair of the council shall be elected by the members. Once elected, a chair
57.22 shall serve a term of two years.

57.23 (c) Members of the council serve without compensation.

57.24 (d) Council members shall share and rotate responsibilities for administrative

57.35 Sec. 2. **[6.91] LOCAL PERFORMANCE MEASUREMENT AND REPORTING.**

58.1 **Subdivision 1. Reports of local performance measures.** (a) A county or city
58.2 that elects to participate in the standard measures program must report its results to its
58.3 citizens annually through publication, direct mailing, posting on the jurisdiction's Web
58.4 site, or through a public hearing at which the budget and levy will be discussed and public
58.5 input allowed.

58.6 (b) Each year, jurisdictions participating in the local performance measurement
58.7 and improvement program must file a report with the state auditor by July 1, in a form
58.8 prescribed by the auditor. All reports must include a declaration that the jurisdiction has

58.17 thereafter, jurisdictions participating in the comprehensive performance measurement
58.18 program must submit a statement approved by its local governing body affirming that

58.21 **Subd. 2. Benefits of participation.** (a) A county or city that elects to participate in
58.22 the standard measures program for 2011 is: (1) eligible for per capita reimbursement of
58.23 \$0.14 per capita, but not to exceed \$25,000 for any government entity; and (2) exempt
58.24 from levy limits under sections 275.70 to 275.74 for taxes payable in 2012, if levy limits
58.25 are in effect.

58.26 (b) Any county or city that elects to participate in the standard measures program
58.27 for 2012 is eligible for per capita reimbursement of \$0.14 per capita, but not to exceed
58.28 \$25,000 for any government entity. Any jurisdiction participating in the comprehensive
58.29 performance measurement program is exempt from levy limits under sections 275.70 to
58.30 275.74 for taxes payable in 2013 if levy limits are in effect.

58.31 (c) Any county or city that elects to participate in the standard measures program for
58.32 2013 or any year thereafter is eligible for per capita reimbursement of \$0.14 per capita,
58.33 but not to exceed \$25,000 for any government entity. Any jurisdiction participating in
58.34 the comprehensive performance measurement program for 2013 or any year thereafter is
58.35 exempt from levy limits under sections 275.70 to 275.74 for taxes payable in the following
58.36 year, if levy limits are in effect.

59.1 Subd. 3. **Certification of participation.** (a) The state auditor shall certify to
 59.2 the commissioner of revenue by August 1 of each year the counties and cities that are
 59.3 participating in the standard measures program and the comprehensive performance
 59.4 measurement program.

59.5 (b) The commissioner of revenue shall make per capita aid payments under this
 59.6 section on the second payment date specified in section 477A.015, in the same year that
 59.7 the measurements were reported.

59.8 (c) The commissioner of revenue shall notify each county and city that is entitled to

59.17 Sec. 3. **[270C.991] PROPERTY TAX SYSTEM BENCHMARKS AND**
 59.18 **CRITICAL INDICATORS.**

59.19 Subdivision 1. **Purpose.** State policy makers should be provided with the tools to
 59.20 create a more accountable and efficient property tax system. This section provides the
 59.21 principles and available tools necessary to work toward achieving that goal.

59.22 Subd. 2. **Property tax principles.** To better evaluate the various property tax
 59.23 proposals that come before the legislature, the following basic property tax principles
 59.24 should be taken into consideration. The property taxes proposed should be:

59.25 (1) transparent and understandable;

59.26 (2) simple and efficient;

59.27 (3) equitable;

59.28 (4) stable and predictable;

59.29 (5) compliance and accountability;

59.30 (6) competitive, both nationally and globally; and

59.31 (7) responsive to economic conditions.

59.32 Subd. 3. **Major indicators.** There are many different types of indicators available to
 59.33 legislators to evaluate tax legislation. Indicators are useful to have available as benchmarks
 59.34 when legislators are contemplating changes. Each tool has its own limitation, and no one
 59.35 tool is perfect or should be used independently. Some of the tools measure the global

60.1 characteristics of the entire tax system, while others are only a measure of the property tax
 60.2 impacts and its administration. The following is a list of the available major indicators:

60.3 (1) property tax principles scale, the components of which are listed in subdivision
 60.4 2, as they relate to the various features of the property tax system;

60.5 (2) price of government report, as required under section 16A.102;

60.6 (3) tax incidence report, as required under section 270C.13;

60.7 (4) tax expenditure budget and report, as required under section 270C.11;

60.8 (5) state tax rankings;

60.9 (6) property tax levy plus aid data, and market value and net tax capacity data, by
 60.10 taxing district for current and past years;

60.11 (7) effective tax rate (tax as a percent of market value) and the equalized effective
 60.12 tax rate (effective tax rate adjusted for assessment differences);

60.13 (8) assessment sales ratio study, as required under section 127A.48;

60.14 (9) "Voss" database, which matches homeowner property taxes and household
 60.15 income;

60.16 (10) revenue estimates under section 270C.11, subdivision 5, and state fiscal notes
 60.17 under section 477A.03, subdivision 2b; and

60.18 (11) local impact notes under section 3.987.

60.19 Subd. 4. **Property tax working group.** (a) A property tax working group is
 60.20 established as provided in this subdivision. The goals of the working group are:

60.21 (1) to investigate ways to simplify the property tax system and make advisory
 60.22 recommendations on ways to make the system more understandable;

60.23 (2) to reexamine the property tax calendar to determine what changes could be made
 60.24 to shorten the two-year cycle from assessment through property tax collection; and

60.25 (3) to determine the cost versus the benefits of the various property tax components,
 60.26 including property classifications, credits, aids, exclusions, exemptions, and abatements,
 60.27 and to suggest ways to achieve some of the goals in simpler and more cost-efficient ways.

60.28 (b) The 13-member working group shall consist of the following members:

60.29 (1) two state representatives, both appointed by the chair of the house of
 60.30 representatives Taxes Committee, one from the majority party and one from the minority
 60.31 party;

60.32 (2) two senators, both appointed by the chair of the senate Taxes Committee, one
 60.33 from the majority party and one from the minority party;

60.34 (3) the commissioner of revenue, or designee;

60.35 (4) one person, appointed by the Association of Minnesota Counties;

60.36 (5) one person, appointed by the League of Minnesota Cities;

- 61.1 (6) one person, appointed by the Minnesota Association of Townships;
61.2 (7) one person, appointed by the Minnesota Chamber of Commerce;
61.3 (8) one person, appointed by the Minnesota Association of Assessing Officers;
61.4 (9) two homeowners, one who is under 65 years of age, and one who is 65 years of
61.5 age or older, both appointed by the commissioner of revenue; and
61.6 (10) one person, jointly appointed by the Minnesota Farm Bureau and the Minnesota
61.7 Farmers Union.

61.8 The commissioner of revenue shall chair the initial meeting, and the working
61.9 group shall elect a chair at that initial meeting. The working group will meet at the call

282.01 TAX-FORFEITED LANDS; CLASSIFICATION, SALE.

Subd. 9. **Ratification of old sales of tax-forfeited lands.** Where a sale of tax-forfeited land under Mason's Supplement 1940, section 2139-15, was made prior to December 31, 1942, without first having the appraised value of the timber thereon approved by the commissioner of natural resources as therein provided, such sale may be ratified by the commissioner of revenue in the manner herein provided, if prior to the making of application therefor the entire purchase price of said tax-forfeited land has been paid.

Subd. 10. **Ratification application, approval, effect.** The purchaser at such sale or the county auditor of the county in which said land is located shall file an application for the ratification of the sale with the board of county commissioners of said county, submitting therewith a statement of the facts of the case and satisfactory proof that the purchase price of such land at the sale has been paid in full. Such application shall be considered by the county board and shall thereafter be submitted by it to the commissioner of revenue with the recommendation of the county board and of the county auditor in all cases wherein the auditor is not the applicant. The commissioner of revenue shall consider said application and, on determining that the conditions above referred to exist, shall make an order ratifying the sale of said tax-forfeited land and transmit a copy thereof to the county auditor of the county in which said tax-forfeited land is located. If any such sale be ratified by the commissioner of revenue, it shall not thereafter be subject to attack for failure to have the timber appraisal approved before the sale. If no conveyance by the state has theretofore been made, the county auditor, upon receipt of said order, shall request the issuance of an appropriate conveyance as provided for in said section 2139-15. If a conveyance has been made by the state of said land pursuant to said section 2139-15, said conveyance shall not thereafter be subject to attack on account of the failure to have the timber appraisal approved before the sale.

Subd. 11. **Pending actions not affected.** The provisions of subdivisions 9 to 11 shall not apply so as to prejudice the rights of any person in any action or proceeding heretofore commenced to the sale in any court of this state.

297I.30 DUE DATES FOR FILING RETURNS.

Subd. 4. **Persons, firms, or corporations licensed to procure insurance from unlicensed foreign companies.** On or before 30 days following the expiration date of a license issued under section 297I.05, subdivision 9, a person, firm, or corporation licensed to obtain insurance from a company not authorized to do business in Minnesota shall file a return with the commissioner for the preceding 12-month period setting forth any information the commissioner reasonably requires on forms prescribed by the commissioner.

Subd. 5. **Joint self-insurance plans.** On or before 60 days following the conclusion of their fiscal year, a plan subject to tax under section 297I.05, subdivision 12, paragraph (b) or (c), shall file a return with the commissioner for the preceding fiscal year setting forth any information the commissioner reasonably requires on forms prescribed by the commissioner.

Subd. 6. **Persons, firms, or corporations procuring insurance from an unlicensed foreign company.** Within 30 days after the date the insurance was procured, continued, or renewed, a taxpayer required to pay the tax under section 297I.05, subdivision 10, shall file a return setting forth any information the commissioner reasonably requires on forms prescribed by the commissioner.

383A.76 TAX-FORFEITED LANDS.

Subdivision 1. **Sale; valuation.** The Ramsey County board may sell tax-forfeited lands in the county to an organized or incorporated governmental subdivision of the state for any public purpose for which the subdivision is authorized to acquire property. In the case of tax-forfeited land in the county which a governmental subdivision has requested for housing purposes, the county board may sell that property to the requesting subdivision for the specified housing use at a value, which may be less than its appraised value, as determined by the county board. Factors that may be considered by the county board in determining value for lands to be held for a permitted public purpose or redeveloped under chapter 469 include the projected gap financing and public subsidy needed for a redevelopment project, expected increases in property taxes, before and after redevelopment appraised values, the potential use of the property for affordable housing, environmental contamination and pollution, site preparation and infrastructure costs, and any other relevant factors. The commissioner of revenue shall convey by deed in the name of the state a tract of tax-forfeited land held in trust in favor of the taxing districts to a governmental subdivision for an authorized public use, if an application is submitted to the commissioner. application must include a statement of facts as to the use to be made of the tract, the need for it, and the recommendation of the county board. Property conveyed under this section for a value that is less than its appraised value cannot be included in a tax increment financing district. To the extent the provisions of chapter 282 are not inconsistent with this section, the provisions of chapter 282 apply to the sale of tax forfeited land in Ramsey County.

Subd. 2. **Use of land.** For lands located within Ramsey County, the deed of conveyance of tax-forfeited land to an organized or incorporated governmental subdivision of the state for an authorized use must be on a form approved by the attorney general and must be conditioned on continued use for the purpose stated in the application. If the governing body of the governmental subdivision determines by resolution after public hearing that some other public use should be made of the lands, the changed use may be made upon filing with the county recorder or registrar of titles a certified copy of the resolution and without conveying the lands back to the state and securing a new conveyance for the new public use. Permitted public uses under this section include street, storm water ponding, drainage, parks, watershed, wetlands, library, fire and police stations, utility easements, and public facilities.

Subd. 3. **Reverter of land.** When a subdivision to which tax-forfeited land has been conveyed for a housing purpose at a value of less than the appraised value, fails to pass a resolution designating a developer or approving a redevelopment contract within three years of the date of conveyance, the Ramsey County board may by resolution declare the land to have reverted to the state, and shall serve a notice of reversion, with a copy of the declaration, by certified mail to the subdivision and shall reimburse the subdivision for the consideration for the lands from the tax-forfeited sale fund. The Ramsey County board shall file for record with the Ramsey county recorder or registrar of titles a certified copy of the declaration of reversion and proof of service. A certificate made by a subdivision referring to a conveyance made to it and stating that it has passed a resolution designating a developer or approving a redevelopment contract for a housing redevelopment project may be filed with the Ramsey County recorder or registrar of titles, and the right of reverter in favor of the state under this section will then terminate.

Subd. 4. **Report by subdivision.** Each subdivision to which tax-forfeited lands have been conveyed under this section for a value of less than its appraised value must file a report with the commissioner of revenue by September 1, 2004, and by September 1 of each third year thereafter. The report shall contain a description of the lands conveyed to it, a status of the development efforts for the lands, the intended or actual uses being made of the lands, and the amount of property taxes being paid on the lands. The commissioner shall retain each report for a minimum of ten years. Failure of a subdivision to file a report shall be cause for the commissioner to declare a reversion of the parcel under section 282.01, subdivision 1e.
