.6	Section 1. [124D.143] EARLY LEARNING SCHOLARSHIPS.
.7	Subdivision 1. Early learning scholarships established. The Office of Early
.8	Learning must oversee the early learning scholarship program in consultation with the
.9	Minnesota Departments of Education, Human Services, and Health.
.10	Subd. 2. Duties. The Office of Early Learning shall administer the early learning
