1.6	Section 1. [157.177] SEX TRAFFICKING PREVENTION TRAINING.
1.7	Subdivision 1. Definition. "Sex trafficking" has the meaning given in section 609.321,
1.8	subdivision 7a.
1.9	Subd. 2. Prevention training required. (a) Every person, firm, or corporation operating
1.10	a hotel or motel within this state shall ensure that each employee who works on site, including
1.11	but not limited to any owner, operator, or manager, receive the training described in paragraph
1.12	(c) within the later of 90 days of the time of hire or 120 days of the effective date of this
1.13	section, and annually thereafter. The operator of each hotel or motel shall annually certify,
1.14	in an employee roster or in each employee's personnel file, that each employee has received
1.15	the training approved by the commissioner.
1.16	(b) The operators shall conduct ongoing awareness campaigns for employees that address
1.17	the components described in paragraph (c).
1.18	(c) The commissioner shall, in consultation with the state hotel and lodging association,
