1.8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.9	Section 1. [16B.992] EMERGENCY INSULIN ASSISTANCE PROGRAM.
1.10	Subdivision 1. Establishment. (a) The commissioner of administration shall implement
1.11	and administer an emergency insulin assistance program beginning July 1, 2020, for insulin
1.12	that is prescribed for self-administration on an outpatient basis.
1.13	(b) For purposes of this section, the following definitions apply:
1.14	(1) "emergency program" or "program" means the emergency insulin assistance program
1.15	established under this section;
1.16 1.17	(2) "Minnesota insulin patient assistance program" means the program established under section 62V.12; and
1.18	(3) "navigator" has the meaning provided in section 62V.02.
1.19	Subd. 2. Contract with third-party administrator. The commissioner may contract
1.20	with a third-party administrator to provide assistance in administering the program. The
1.21	initial negotiated contract is not subject to the requirements of section 16C.06. Any contract
1.22	with a third-party administrator must:

2.1	(1) require the third-party administrator to process insulin claims and pay participating
2.2	pharmacies at a rate at least as high as the medical assistance payment rate that would apply
2.3	under section 256B.0625, subdivision 13e, for insulin that is dispensed by the participating
2.4	pharmacy to individuals under the program;
2.5	(2) prohibit the use of rebates; and
2.6	(3) state that the contract is subject to section 13.05, subdivision 11, and require that all
2.7	data be maintained as private by the third-party administrator and not be shared with a third
2.8	party without the patient's consent.
2.9	Subd. 3. Eligibility requirements. To be eligible for the program, an individual must
2.10	have a valid prescription for insulin and attest to:
2.11	(1) being a resident of Minnesota;
2.12	(2) not being enrolled in medical assistance or MinnesotaCare;
2.13	(3) having a tax household income that is equal to or less than 500 percent of the federal
2.14	poverty guidelines;
2.15	(4)(i) being uninsured;
2.16	(ii) having prescription drug coverage through Medicare and having incurred annual
2.17	out-of-pocket prescription drug costs that exceed \$1,000; or
2.18	(iii) having private insurance coverage with cost sharing that exceeds \$50 for a month's
2.19	supply of insulin, regardless of the amount or types of insulin needed;
2.20	(5) not being eligible to receive insulin through Indian Health Services and not being
2.21	enrolled in TRICARE or prescription drug benefits through the United States Department
2.22	of Veterans Affairs; and
2.23	(6) not having had insulin first dispensed through the program during the 12 months
2.24	preceding the date of submission of the application.
2.25	Subd. 4. Application process. (a) The board of directors of MNsure and the
2.26	commissioner shall jointly develop an application form to be used for this program and the
2.27	Minnesota insulin patient assistance program established under section 62V.12. The
2.28	application must:
2.29	(1) require the applicant to indicate whether insulin is being requested on an emergency
2.30	basis; and
2.31	(2) provide for the applicant's consent to any transfer of personal data.

3.1	The commissioner and the board of directors of MNsure shall make the application form
3.2	available on their websites to pharmacies and to health care practitioners who are authorized
3.3	to prescribe, administer, or dispense insulin.
3.4	(b) An applicant must submit a signed and dated application form to the MNsure board
3.5	in order to obtain insulin under the program. By signing the application, applicants are
3.6	attesting that the information contained in the application is correct and they need insulin
3.7	on an emergency basis. An application for emergency insulin may be submitted through
3.8	the MNsure website or as a paper application through a pharmacy. An individual is not
3.9	eligible to reapply for the program until 12 months have elapsed from the date insulin was
3.10	first dispensed to the individual under the program, at which time the individual must submit
3.11	a new application form.
3.12	(c) Upon receipt of a completed and signed application, the MNsure board shall verify,
3.13	if applicable, whether 12 months have elapsed from the date insulin was first dispensed
3.14	under the program to the individual. The board shall provide applicants satisfying this
3.15	criterion and new applicants with an identification number, indicating that a completed
3.16	application has been received. The information must be provided in a format that can be
3.17	downloaded by the applicant or conveyed in an electronic format.
3.18	Subd. 5. Pharmacy participation. (a) Each pharmacy licensed under chapter 151 that
3.19	dispenses insulin must participate in the program as a condition of doing business in this

8.23	or picked up by the patient.

8.25	described in subdivision 4, the manufacturer must send a three-month supply of the product
8.26	ordered, unless a lesser amount is requested in the order, to the pharmacy or health care
8.27	provider designated by the patient at no charge to the patient, pharmacy, or health care
8.28	provider.
8.29	(c) Upon receipt of each prescription reorder for a patient, the manufacturer must send
8.30	an additional three-month supply of the product, unless a lesser amount is requested, to the
8.31	pharmacy or health care provider designated by the patient at no charge to the patient,
