The bill was read for the first time and referred to the Committee on Capital Investment

1.1 A bill for an act
1.2 relating to capital investment; appropriating money for a new fire station in the
1.3 city of Golden Valley; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. GOLDEN VALLEY; FIRE STATION.

1.6 Subdivision 1. Appropriation. \$17,000,000 is appropriated from the bond proceeds
1.7 fund to the commissioner of public safety for a grant to the city of Golden Valley to acquire
1.8 and improve property, predesign, design, construct, engineer, furnish, and equip a new fire
1.9 station with space to provide regional training opportunities and other associated site
1.10 improvements. This appropriation does not require a nonstate contribution.

1.11 Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.12 proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.13 the state in an amount up to \$17,000,000 in the manner, upon the terms, and with the effect
1.14 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.15 Constitution, article XI, sections 4 to 7.

1.16 EFFECTIVE DATE. This section is effective the day following final enactment.
