1.2 relating to health; adding charter schools to the prohibition of tobacco in schools;

1.3 increasing the tobacco sale age; increasing administrative penalties; adding a

1.4 provision to municipal license of tobacco; allowing alternative penalties; amending

1.5 Minnesota Statutes 2018, sections 144.4165; 144.4167, subdivision 4; 171.171;

1.6 461.12, subdivisions 2, 3, 4, 5, 6, 8; 461.18; 609.685; 609.6855; proposing coding

1.7 for new law in Minnesota Statutes, chapter 461.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2018, section 144.4165, is amended to read:

1.10 **144.4165 TOBACCO PRODUCTS PROHIBITED IN PUBLIC SCHOOLS.**

1.11 No person shall at any time smoke, chew, or otherwise ingest tobacco ~~or a tobacco~~

1.12 ~~product~~, or inhale or exhale aerosol or vapor from an electronic delivery device as defined

1.13 in section 609.685, subdivision 1, in a public school, as defined in section 120A.05,

1.14 subdivisions 9, 11, and 13, ~~and no person under the age of 18 shall possess any of these~~

1.15 ~~items~~ or in a charter school governed by chapter 124E. This prohibition extends to all

1.16 facilities, whether owned, rented, or leased, and all vehicles that a school district owns,

1.17 leases, rents, contracts for, or controls. Nothing in this section shall prohibit the lighting of

1.18 tobacco by an adult as a part of a traditional Indian spiritual or cultural ceremony. For

1.19 purposes of this section, an Indian is a person who is a member of an Indian tribe as defined

1.20 in section 260.755, subdivision 12.

1.21 Sec. 2. Minnesota Statutes 2018, section 144.4167, subdivision 4, is amended to read:

1.22 Subd. 4. **Tobacco products shop.** Sections 144.414 to 144.417 do not prohibit the

1.23 lighting, heating, or activation of tobacco in a tobacco products shop by a customer or

2.1 potential customer for the specific purpose of sampling tobacco products. For the purposes
 2.2 of this subdivision, a tobacco products shop is a retail establishment ~~with~~ that cannot be
 2.3 entered at any time by persons younger than 21 years of age, that has an entrance door
 2.4 opening directly to the outside, and that derives more than 90 percent of its gross revenue
 2.5 from the sale of loose tobacco, ~~plants, or herbs and cigars, cigarettes, pipes, and other~~
 2.6 ~~smoking devices for burning tobacco and related smoking accessories~~ tobacco-related
 2.7 devices, and electronic delivery devices, as defined in section 609.685, and in which the
 2.8 sale of other products is merely incidental. "Tobacco products shop" does not include a
 2.9 tobacco department or section of any individual business establishment with any type of
 2.10 liquor, food, or restaurant license.

 2.15 an alcoholic beverage in violation of section 340A.503 if the person used a license, Minnesota
 2.16 identification card, or any type of false identification to purchase or attempt to purchase the
 2.17 alcoholic beverage;

2.18 (2) is convicted under section 171.22, subdivision 1, clause (2), or 340A.503, subdivision
 2.19 2, clause (3), of lending or knowingly permitting a person under the age of 21 years to use

3.1 Sec. 4. Minnesota Statutes 2018, section 461.12, subdivision 2, is amended to read:

3.2 Subd. 2. **Administrative penalties for sales and furnishing; licensees.** If a licensee or
3.3 employee of a licensee sells, gives, or otherwise furnishes tobacco, tobacco-related devices,
3.4 electronic delivery devices, or nicotine or lobelia delivery products to a person under the
3.5 age of ~~18~~ 21 years, or violates any other provision of this chapter, the licensee shall be
3.6 charged an administrative penalty of ~~\$75~~ \$300 for the first violation. An administrative
3.7 penalty of ~~\$200~~ \$600 must be imposed for a second violation at the same location within
3.8 ~~24~~ 36 months after the initial violation. For a third or any subsequent violation at the same
3.9 location within ~~24~~ 36 months after the initial violation, an administrative penalty of ~~\$250~~
3.10 \$1,000 must be imposed, and the licensee's authority to sell tobacco, tobacco-related devices,
3.11 electronic delivery devices, or nicotine or lobelia delivery products at that location must be

6.21 provide notice that all persons responsible for selling these products must verify, by means
6.22 of photographic identification containing the bearer's date of birth, the age of any person
6.23 under 30 years of age.

6.25 electronic delivery devices, or nicotine or lobelia delivery products are sold, the licensee
6.26 shall verify, by means of government-issued photographic identification containing the
6.27 bearer's date of birth, that the purchaser or person attempting to make the purchase is at
6.28 least 21 years of age. Verification is not required if the purchaser or person attempting to
6.29 make the purchase is 30 years of age or older. It shall not constitute a defense to a violation
6.30 of this subdivision that the person appeared to be 30 years of age or older.

7.3 Subdivision 1. **Definitions.** For the purposes of this section, the following terms shall

7.5 (a) "Tobacco" means cigarettes and any product containing, made, or derived from
7.6 tobacco that is intended for human consumption, whether chewed, smoked, absorbed,
7.7 dissolved, inhaled, snorted, sniffed, or ingested by any other means, or any component,
7.8 part, or accessory of a tobacco product including but not limited to cigars; cheroots; stogies;
7.9 perique; granulated, plug cut, crimp cut, ready rubbed, and other smoking tobacco; snuff;
7.10 snuff flour; cavendish; plug and twist tobacco; fine cut and other chewing tobaccos; shorts;
7.11 refuse scraps, clippings, cuttings and sweepings of tobacco; and other kinds and forms of
7.12 tobacco. Tobacco excludes any tobacco product that has been approved by the United States
7.13 Food and Drug Administration for sale as a tobacco cessation product, as a
7.14 tobacco dependence product, or for other medical purposes, and is being marketed and sold

7.16 are defined in the Federal Food, Drug, and Cosmetic Act, that are authorized for sale by the

10.20 ~~attempts to purchase a product containing or delivering nicotine or lobelia intended for~~
10.21 ~~human consumption, or any part of such a product, that is not tobacco or an electronic~~
10.22 ~~delivery device as defined by section 609.685, is guilty of a petty misdemeanor. Law~~
10.23 enforcement and court system representatives shall consult, as applicable, with interested
10.24 persons, including but not limited to parents, guardians, educators, and persons under the
10.25 age of 21 years, to develop alternative civil penalties for persons under the age of 21 years
10.26 who violate this section. Consulting participants shall consider a variety of alternative civil
