The bill was read for the first time and referred to the Committee on Transportation Finance and Policy

1.1 A bill for an act
1.2 relating to transportation; appropriating money for intersection and associated
1.3 improvements on marked Trunk Highway 65 in Blaine; authorizing the sale and
1.4 issuance of state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **BLAINE; MARKED TRUNK HIGHWAY 65.**

1.7 Subdivision 1. **Appropriation.** (a) \$34,000,000 is appropriated from the bond proceeds
1.8 account in the trunk highway fund to the commissioner of transportation for one or more
1.9 grants to Anoka County, the city of Blaine, or both, for intersection improvements along
1.10 marked Trunk Highway 65 at 105th Avenue Northeast and Anoka County State-Aid Highway
1.11 12, known as 109th Avenue Northeast, and the associated frontage and backage roads. This
1.12 appropriation does not require a nonstate contribution.

1.13 (b) \$8,000,000 of the appropriation in paragraph (a) is for acquisition of rights-of-way
1.14 associated with the trunk highway portions of the project.

1.15 (c) \$26,000,000 of the appropriation in paragraph (a) is for construction of the
1.16 improvements associated with the trunk highway portions of the project.

1.17 (d) Upon written notice to the commissioner of management and budget, any unspent
1.18 portion of the appropriation in paragraph (a) remaining after completion of the project phase
1.19 or project is available for any other phase of the project or other intersection improvement
1.20 projects on marked Trunk Highway 65 in Spring Lake Park, Blaine, or Ham Lake.

1.21 Subd. 2. **Bond sale.** To provide the money appropriated in subdivision 1 from the bond
1.22 proceeds account in the trunk highway fund, the commissioner of management and budget

2.1 shall sell and issue bonds of the state in an amount up to \$34,000,000 in the manner, upon
2.2 the terms, and with the effect prescribed by Minnesota Statutes, sections 167.50 to 167.52,
2.3 and by the Minnesota Constitution, article XIV, section 11, at the times and in the amounts
2.4 requested by the commissioner of transportation. The proceeds of the bonds, except accrued
2.5 interest and any premium received from the sale of the bonds, must be deposited in the bond
2.6 proceeds account in the trunk highway fund.

2.7 **EFFECTIVE DATE.** This section is effective the day following final enactment.
